- f. has no conflict of interest in connection with the contract; a conflict of interest could arise in particular as a result of economic interests, political or national affinity, family, emotional life or any other shared interest; and also confirm not to have any personal, financial or commercial interest existing at present or occurred over the past 5 years;
- g. is not a subject of an administrative penalty for being guilty of misrepresentation in supplying the information required by EUI as a condition of participation in a procurement procedure or failing to supply this information, or having been declared to be in serious breach of its obligations under contracts covered by the Union's budget
- h. will inform EUI, without delay, of any situation considered a conflict of interest or which could give rise to a conflict of interest;
- i. has not granted and will not grant, has not sought and will not seek, has not attempted and will not attempt to obtain, and has not accepted and will not accept any advantage, financial or in kind, to or from any party whatsoever, where such advantage constitutes an illegal practice or involves corruption, either directly or indirectly, inasmuch as it is an incentive or reward relating to award of the contract;
- j. provided accurate, sincere and complete information to EUI within the context of this procurement procedure;
- 4) acknowledges that \square [the above-mentioned legal person] \square [he/she] may be subject to administrative and financial penalties if any of the declarations or information provided prove to be false.

If the tenderer is a legal person, information on the natural persons with power of representation, decision making or control over the legal person shall be provided only upon request by EUI.
