Prof. Héritier joined the EUI on March 1st, 2003. She has been appointed to the Chair of Public Policy, joint Chair between the Department of Political and Social Sciences and the Robert Schuman Centre for Advanced Studies. Adrienne Héritier has been professor of political and administrative science at the University of Konstanz for six years and had a full professorship in political science at the University of Bielefeld from 1990 until 1995. For four years (1991-1995) she was chief editor of the *Politische Vierteljahresschrift*. In 1994 she was awarded (jointly with Helmut Willke) the Leibniz Prize for scholarly excellence by the German Science Foundation. In 1995 she was elected a regular member of the Berlin-Brandenburgische Akademie der Wissenschaften. Her main publications are in the fields of policy analysis and policy network analysis, implementation research, comparative policy making, European policy-making processes, neo-institutionalism. She was directing a research programme on the "changing state in Europe" investigating policy patterns, political and administrative practices in various European member-states which are to be observed in the context of the European Union. Present research projects focus on new modes of governance in Europe; the deregulation and re-regulation of the utilities' sectors, and changing legislative processes in the European Union. Her research areas are Comparative Public Policy, European Policy-making, Institutional Theory, New Modes of Governance

She is currently directing two research projects on EU neighbourhood policies: one funded by the EU FP6 Programme on EU-Association relations with neighbourhood countries in comparative perspective "Inside-Out: New Modes of Governance with Non-Member States", Newgov Consortium, and one on EU Democracy Promotion in the ENP, co-directed with Frank Schimmelfennig and funded by the Swiss National Science Foundation.

Dr. Adam Łazowski is a senior lecturer at the School of Law at the University of Westminster London). He obtained a Master's Degree in 1999 and a PhD in 2001 from the Faculty of Law of the University of Warsaw. Between 1999 and 2003, he lectured at the University of Warsaw and created a postgraduate course on EU law. During the next two years, he worked as a senior researcher in European law at the T.M.C. Asser Institute (The Hague). Dr Łazowski's scientific interests include the law of the European Union as well as public international law. His research has so far led to a number of books, articles, contributions to edited volumes and conference papers. In 2003, his monograph on non-judicial remedies in EU law received first prize in a nationwide competition for the best book on EU law organised in Poland by the Foundation for the Promotion of European Law. He has recently edited (together with Steven Blockmans, T.M.C Asser Institute) a book devoted to the legal aspects of EU relations with all geographical neighbours ('The European Union and Its Neighbours. A legal appraisal of the EU's policies of stabilisation, partnership and integration', Asser Press & Cambridge University Press 2006). Since 1999, Dr Łazowski has actively participated in various EU law training programmes for practitioners in Poland, Bulgaria, Romania, Slovakia and Estonia. In Estonia, he served

as a mid-term expert in an EU-financed biannual project. In that capacity, he provided extensive training to national lawyers as well as co-writing a distance-learning course combined with a series of case studies aimed at Estonian judges.

He was co-founder of émigré political quarterly „Aneks” (1973-1990) and the Aneks Publishing House. Following the returned to Poland he became Deputy Chairman of Polskie Radio S.A. (public radio) with responsibility for program (1998-2002), and later its Program Director (2002-2004).
