Theoretically found, conceptually lost: How (not) to study the politics of religion

Religion is back in the academic study of politics and international relations. Interestingly, the research agenda is becoming increasingly bifurcated. One set of scholars, following Max Weber, bracket the meaning and definition of religion and focus on the political 'function', 'role', or 'impact' of religious ideas and actors. Another set of scholars have turned this traditional research agenda up-side down by focusing on the social construction, and underlying power relations, which inform the various ways in which categories such as 'the religious', 'the political', or 'the secular' are defined and understood. Should these two research agendas continue to be conducted on separate tracks? Or is it possible 'bridge the gap'? If yes, how can this be done without reifying overly ideological or unreflective definitions of 'religion' or 'politics'? And what does this all mean for particular research puzzles which doctoral researchers tend to ask? This will be the overarching theme of the fourth annual student-run workshop on religion and politics hosted by the Department of Political and Social Sciences (SPS) of the European University Institute (EUI) in Florence.

More concretely, the workshop's purpose is to bring together various EUI researchers whose research falls into the area of 'religion and politics', broadly understood. In accordance with the general philosophy behind student-run SPS workshops, participants are not necessarily expected to present fully-fledged papers. Rather, the main emphasis will be on the presentation and critical discussion of the most pressing theoretical and methodological which doctoral researchers are facing in the preparation of their doctoral theses in the field of religion and politics. This year's keynote speaker will be [Prof Elizabeth Shakman Hurd](#) (Northwestern University), author of the seminal book [The Politics of Secularism in International Relations](#), published in 2008 by Princeton University Press. The workshop will be chaired by Prof. Olivier Roy. The co-convenors of the EUI Religion and Politics Working Group (RPWG), Maria Birnbaum (maria.birnbaum@eui.eu) and A. Alexander Stummvoll (a.stummvoll@eui.eu) are in charge of organisation.
