INTRODUCTION

The Historical Archives of the European Union are organising an international conference in honour of Fausta Deshormes La Valle (1927-2013), unanimously regarded by scholars and experts as one of the mothers of united Europe. A journalist, then an official of the European Commission, Fausta Deshormes La Valle was the founder of the Women's Information Service, which was created in January 1977 within the Directorate General for Information. Under her leadership the unit organised numerous events gathering representatives from the civil society interested in gender equality issues in Europe, including women's organisations, members of the press, television and trade unions, members of Parliaments and local elected officials. Moreover, she launched Women of Europe, a bimonthly information bulletin distributed to women's organisations, women with political responsibilities, journalists and anyone else who requested it. Women of Europe immediately became an "official journal" for women, gathering information on women's and feminist movements in EU member states, as well as on the political and institutional life of the European Community, with a special focus on EC Gender Equality Policy and related debates at the European Parliament. Among the many achievements of the Women's Information Service, one particularly significant example was an awareness campaign that was launched on the eve of the first



European elections in 1979 with the aim of fully involving women in that historic event and of understanding their perspectives on and expectations for the construction of Europe.

For almost fifteen years, the Women's Information Service brought women closer to Europe and Europe closer to women. It became a major instrument in supporting the progressive organisation of a European civil society committed to promoting gender equality, opening new areas of action beyond national borders and finding new ways of campaigning.

Since the beginning of the Nineties, flourishing European women's networks have applied a coordinated pressure on national and European institutions. In this respect, Fausta Deshormes La Valle's personal commitment to the creation of the European Women's Lobby is of particular importance. The Lobby, which was formally established in Brussels in 1990 with co-financing from the European Commission, is to this day the largest coalition of women's associations, with more than 2,000 members from 31 European countries.

CONFERENCE OBJECTIVES

The first objective of the Conference is to highlight how the Women's Information Service and Women of Europe contributed to reducing the gap between citizens and European institutions, which are increasingly seen as bureaucratic structures distant from people's everyday problems. A greater understanding of this experience and of its impact on information, on European policy making and on supporting women's networks could help in finding ways whereby citizens' confidence and interest in the EU would increase, the dialogue between citizens and institutions would be strengthened and civil society participation in the construction of Europe would grow. The second objective of the conference is to assess, twenty years after the end of Women of Europe, the dialogue on gender equality between the European institutions and civil society as well as how women's organisations and European women's networks take part in developing and promoting European gender equality policies and are able to influence European institutions. This is an essential aspect of "participatory democracy", which is emphasised by the Lisbon Treaty as a key element of good European governance.

The Conference therefore aims to analyse successes in and difficulties of achieving these aims, and to identify solutions so that European institutions can better address women's objectives. An understanding of the lessons of the past and of current challenges will allow participants to discover new ways of stimulating the construction of a parity democracy and offering women a better future in Europe.



PROGRAMME

This one - day conference will be organised in three sessions. Each session will be opened by a presentation on a specific topic. A moderator will then direct a range of questions to the 4-5 panelists with a view to stimulating debate. The audience will also have the opportunity to participate in the discussion with questions and reflections.

9.30 - 11.00 FIRST SESSION

From Women of Europe to European women's networks

This session will begin by assessing how the Women's Information Service and Women of Europe contributed to the emergence of European women's networks and helped them in connecting with the European institutions. Two archival collections, "Femmes d'Europe" and "Fausta Deshormes La Valle," will help in illustrating the various instruments used in promoting the networks,. In the light of this, the panellists will go on to discuss: the role of European women's networks, their objectives and strategies for responding to the challenges of today, including EU enlargement; the role of women and gender in the main European civil society networks (e.g. the European Anti-Poverty Network); the role of women's press in the formation and the development of European women's networks; the contribution of new technologies, such as social networks, in promoting the objectives and initiatives of European women's networks.
