Title of project:	Global Citizenship Law: International Migration and Constitutional Identity
Job description:	The “Global Citizenship Governance” (GCG) Project, jointly hosted by the Robert Schuman Centre for Advanced Studies and the WZB Berlin Social Science Center, is seeking to appoint a research assistant in the field of “Global Citizenship and Technology.” The research seeks to explore the challenges and opportunities that new emerging technologies create to existing frameworks of citizenship, democracy, and states. The focus of the research will be on one of the following topics: [1] blockchain technology, “cloud communities,” and the future of citizenship; [2] matching algorithm for immigration selection; [3] “algorithmic citizenship” and identity (other topics, such as machine learning and big data, are welcome, as long as there is a nexus to citizenship, global governance, or democratic theory).

	<p>Emerging technologies are starting to change historic axioms and invite us to rethink the meaning and essence of citizenship. The research assistant is expected to study how technologies can reshape current theories and practices of citizenship, research the possible construction of a new concept—"cloud membership"—and its connection to global citizenship, coordinate a new "Global Citizenship & Technology" series, publish in high quality journals, and contribute to the GCG project, including engagement with academics and policy makers.</p>
