Assistant Professor and Deputy Director of the Florence School of Banking and Finance

The Florence School of Banking and Finance is a key point of reference for training and debate on banking and finance policy at the European level. The aim of the School is to develop a common culture of regulation and supervision in the European Union. It does so through policy debate, training and applied research and in close interaction with its network of leading academic institutions. The banking and financial professionals involved in the School's activities include members of European and non-European central banks, national supervisory and control authorities, European institutions, academia and the private sector, including numerous high profile figures. The School's training courses currently focus on four thematic areas: (1) Financial Regulation and Governance, (2) Digital Finance, (3) Sustainable Finance, (4) Methods. Since its establishment in 2016, more than 24.000 people from over 80 countries have participated in over 240 training courses and debate activities of the School.

The Deputy Director will be responsible for the further development of the Programme and the coordination of the FBF's growing staff, including external faculty. In cooperation with the FBF Director, the successful candidate will contribute to building the thematic specificity and mission of the FBF, encompassing its training, knowledge production, research and policy debate programmes, while at the same time pursuing an independent research agenda in a field related to the competences of the school.

Candidates will have a doctorate in one of the social sciences and significant professional experience in academic research and teaching. Ideally, the candidate will have proven experience in designing executive training programmes in an international Higher Education or research institution. Coupled with a strong organisational attitude and experience they should possess a first-rate ability to communicate and develop relations in the policy, academic and private sector arenas. They will be expected to have a proven track-record in mobilising external funds, including research funds.
