## Stephanie Acker Housman

Fellowship period: 1 September 2021 - 30 June 2022

Stephanie Acker is a local and federal leader specialising in improving outcomes for some of America's most vulnerable populations. Stephanie was one of the principals in the City of Boston's efforts to end homelessness. Prior to that, she served in the United States Department of Health and Human Services, focusing on solutions and programme assessments for the American refugee crisis. She has conceived and built more than a dozen programmes, built citywide partnerships to innovate service delivery, and co-founded 'Soccer Nights', a national programme that unites communities across lines of difference.

Stephanie holds a Bachelor's in Social Work from Gordon College and a Master's in Public Administration from Harvard University Kennedy School of Government and was a United States Presidential Management Fellow. At the EUI School of Transnational Governance, she is developing policy and practice solutions to close the refugee resettlement gap.



Faycal Ait Abdellouhab

Fellowship period: 1 September 2021 – 30 June 2022

Faycal Ait Abdellouhab is an experienced professional in public finance, in the area of taxation. He has several years of work experience at the Ministry of Finance of Algeria as a Senior Tax Inspector and Tax and Accounting Auditor. Faycal holds a Bachelor's degree in Economics, a Master degree in Public Finance, and a university diploma in European Integration. In 2015, he graduated from the College of Europe, Natolin Campus where he completed his Master of Arts in European Interdisciplinary Studies.

At the international level, he took part in the reform project of the indirect tax regime in Algeria led by an international work group in the framework of the EU-Algeria Association Agreement. Faycal accounts for many participations in seminars, training, and workshops within International and Regional Organisations, relating to fiscal sustainability, tax policy, and European and international affairs. As a Policy Leader Fellow at the School of Transnational Governance, EUI, his field of research is focused on the international tax system and the issues relating to the taxation of cross-border profits in a highly globalised and digitalised world economy.

Ucha Avsajanishvili works as an Associate at the leading Georgian law firm - BGI Legal. His primary practice areas include legal research, human rights, anti-corruption, and anti-money laundering law. From 2014-2021, Ucha worked as a Senior Legal Advisor (Research and Analysis) at the Analytical department of the Ministry of Justice of Georgia. His areas of expertise covered legal research and drafting, cybersecurity, anti-corruption, and anti-money laundering policy. In 2017 Ucha served as a Legal Consultant for the Council of Europe's European Committee on Legal Cooperation (CDCJ), advising the General Prosecutor's Office of Kazakhstan on the development of anti-corruption and criminal justice policy.

His professional experience also includes working as a Legal researcher at the Free University of Tbilisi (Georgia), where he taught legal research methods to LL.B. students and supervised legal research. Ucha holds a Master's degree (LL.M.) in European Economic Law from Stockholm University (Sweden) and a Bachelor's degree (LL.B.) in Law from Free University of Tbilisi (Georgia).



Florencia Caro Sachetti
Fellowship period: 1 February 2022 – 30 June 2022

Florencia is a researcher and practitioner with broad experience in policy issues related to gender equality, social protection and labour markets. Her work focuses on promoting social inclusion and human rights in her country and beyond through the implementation of evidence-based policies that are people-centered. She currently serves as coordinator of the Social Protection Programme at the Centre for the Implementation of Public Policies promoting Equity and Growth (CIPPEC), a think tank based in Argentina. She is also involved in the T20 and W20 networks, the official engagement groups delivering policy recommendations to G20 leaders.

As a Policy Leader Fellow, Florencia will study the role of transnational governance in promoting cooperation mechanisms and interventions to guarantee migrant care workers' rights. This topic intersects migration, class, gender, labour and care issues at a transnational level, requiring coherent multilateral approaches to tackle challenges and seize opportunities to leave no one behind.

Florencia holds a Master of Science in Development Studies (LSE, UK) and a degree in Economics (Torcuato di Tella University, Argentina). She is a member of Global Shapers and the International Association for Feminist Economics (IAFFE). Among other distinctions, she was selected as a Young Global Changer by the Global Solutions Initiative in 2019.



Iftach Cohen
Fellowship period: 1 September 2021 – 30 June 2022

Iftach Cohen is an international lawyer. In 2009, he co-founded a law firm specialised in Israeli Supreme Court litigation of human rights matters, such as targeted killings, the siege on and war crimes in Gaza, the Israeli settlements and the deportation of human rights defenders. He co-founded We Are Refugees, an NGO that provided pro-bone legal representation to detained asylum seekers, and co-litigated the 'Anti-Infiltration Law' case, a landmark ruling that led to the release of 1,500 detained asylum seekers. In Italy, he initiated and directed an innovative legal project in Sicily, which provided access to rights and legal information to asylum seekers in the region.

Iftach served as a member of an international team of experts on behalf of EASO, sitting in the Territorial Commission for the Recognition of International Protection of Rome. He is currently directing a legal team and managing the 'Reinstating Law's Rule at EU Borders' project at front-LEX.



Francesca De Chiara

Francesca De Chiara is a researcher and project leader at Fondazione Bruno Kessler, where she is working on developing and promoting data sharing at the institutional and community level. The latest projects focus on analysing the impact, the social and economic value of open data, and the reuse of public sector information.

As a fellow at the Governance Lab (Govlab) at New York University (NYU), she led the joint project Open Data 200 Italy. Francesca holds a Ph.D. in Sociology and Social Research. She has been a research fellow in development sociology at Cornell University (US) and visiting doctoral researcher at the Warwick Business School - University of Warwick (UK). Active in the Open Knowledge Foundation Network, Francesca coordinated and designed three editions of the Civic Tech School, training sessions, hackathons, and data challenges for local and national governments. She has been involved in the OpenCoesione initiative and the Open Government Partnership - Italian team.

She is the vice president of Monithon, an independently developed initiative to promote the civic monitoring of government spending.

Emma Gibbs is a socio-environmental consultant at the United Nations Food and Agriculture Organization (FAO), where she promotes policy change through sustainable forest management at national, regional and global levels. Emma has over seven years of experience across NGOs, the private sector, research bodies, and academic institutes promoting social change, capacity-building, and policy reform.

Emma holds a master's degree in Environment, Politics and Development from SOAS University of London (UK), and a bachelor's degree in International Relations and Anthropology from Oxford Brookes University (UK). As a Policy Leader Fellow, Emma will be examining the role of forest, education, and public health policies in mainstreaming the contributions of forests and trees to overall human health and well-being.



Teona Giuashvili

Teona Giuashvili is a Georgian diplomat with over eleven years of experience. She has worked on multilateral diplomacy and conflict resolution as deputy and then acting director of the Department of International Organisations at the Ministry of Foreign Affairs. As deputy head of the Mission of Georgia to the European Union (EU), Teona has focused on Georgia's European integration priorities, in particular political and security dialogues, the conclusion of the Association Agreement, and visa liberalisation. From Brussels, she moved to Paris and served as chargee d'affaires and deputy ambassador of Georgia to France.

Teona holds a Ph.D. in Political Science from Sciences Po, Paris, as well as Master's degrees in European Studies and International Relations from Sciences Po, the University Pantheon-Assas Paris II, and Tbilisi State University (TSU). As a PhD exchange scholar, she has spent an academic year at the Fletcher School of Law and Diplomacy in the United States. Teona has also lectured on Conflict Resolution at TSU. She speaks Georgian, English, French, Russian, and Italian.

At the EUI School of Transnational Governance, Teona is working on the evolution of the relationship between the EU and the three associated partner countries in the Eastern neighbourhood – Georgia, Moldova and Ukraine. In particular, she focuses on the role of non-state actors in these partnerships.



Pralok Gupta

Pralok Gupta is an Associate Professor at the Centre for WTO Studies, Indian Institute of Foreign Trade, New Delhi. He had served in the state civil services and Industrial finance corporation of India. He holds the Fintech and Regulatory Innovation certificate from the University of Cambridge. He has been engaged in policy-making by the government of India on trade and macroeconomic issues.

A member of India's negotiating team for the Regional Comprehensive Economic Partnership Agreement for E-commerce and Trade in Services, also appointed as an expert member of various task forces and committees of the government and industry associations in India. He has delivered training to delegates from developing and least-developed countries, including high-level delegations from Ethiopia, Mongolia, Myanmar, and Afghanistan.

He has been associated with research projects for international organisations. At the EUI School of Transnational Governance, he proposes to work on e-commerce/digital platforms.



Jaroslaw Gwizdak

Jaroslaw Gwizdak is a Polish lawyer, activist, former judge, mediator, and advocate for efficient and friendly institutions of public life, mediation, and social innovation. He is a member of the Institute for Law and Society Management Board. Jaroslaw also acts as a legal columnist for the oldest Polish daily newspaper and is an EU expert for Ukrainian judicial reform. Jaroslaw is a lecturer at WSB Academy in Dabrowa Gornicza and SWPS University in Warsaw. He appears as a legal expert in various media outlets: radio and TV stations, podcasts, and newspapers.

During his fellowship, he will work on developing a new narrative about the rule of law, especially in Central and Eastern European countries. Jaroslaw is the winner of the main prize of the "Citizen's Judge of the Year 2015" awarded by the CourtWatch Poland Foundation. Awarded by the daily Dziennik Zachodni with the distinction 'Personality of the Year' (2017) in recognition of promoting knowledge about the law in Polish society. He is a co-founder and initiator of the 2016 Judiciary Day (#DWS16) in almost 30 courts in Poland. Jaroslaw appeared at the Academy of Fine Arts at the biggest Polish rock festival 'Przystanek Woodstock' in 2017.

In 2018, after a low-budget, grassroots campaign, he come third in municipal elections in his hometown – Katowice, with 11% of votes. In 2020 and 2021 he was also a DemocraCEE Fellow, publishing analyses on legal issues on "Visegrad Insight".

#### Mustafa Haid

Mustafa Haid is a Syrian human right and accountability advocate who has organised several international campaigns for justice in Syria. At present, Mustafa is a board member of the Dawlaty Foundation, a Syrian non-profit foundation that works with nonviolent activists on capacity building, democratic transition, and transitional justice in Syria.

Mustafa worked as a consultant for Human Rights Watch, the UN Office of the Special Adviser on the Prevention of Genocide, and the Special Adviser on the Responsibility to Protect from 2011 to 2012. Mustafa works now on media development as a senior advisor with International Media Support. He holds a master's degree in conflict resolution from King's College London.



#### Kashimana Amanda Ivo

Kashimana Ivo is a political ecologist from Nigeria with academic backgrounds in environmental biology, geographic information systems, climatology, and geosciences. She specializes in climate and land-use nexus and changes, analyzing agriculture and forestry land-use conflicts, economics, and policies in West Africa.

She has worked for varied periods in the private sector, NGOs and development corporations holding designations including intern, landscape analyst, conservation officer, climate change projects officer, and environmental management consultant. She is now a cofounder of Biomes Conservation Limited, a consulting firm in Nigeria, working with governments, development agencies, and communities to improve policies for better livelihoods in Nigeria. In addition, she is rounding up her doctoral research as a DAAD scholar on landuse conflicts in relation to development objectives in Nigeria. She is interested in developing economies and development goals.

At the European University Institute, Kashimana assesses the implications of the West African transhumance and key land-use policies on livelihoods in Nigeria. Using an integrated assessment model, she runs scenarios to provide valuable insights into governance and policy options for managing resources and associated conflicts.

Previously, Umar worked as a research associate for the Economic Policy Research Centre; coordinating officer for strengthening good governance and policy implementation under the African Union Commission; capacity development officer in the Ministry of Gender Labour and Social Development in Uganda, and as an assistant researcher for the USAID Project on Refugee Resettlement in Uganda. He has a Ph.D. and Master's in Governance and Regional Integration, PGD in Human Rights, and a bachelor's degree in Psychology.

She was awarded the Young Reporter of the Year in 2008 and Best Feature Writer of the Year in 2016 by the Sri Lanka Press Institute and the Editors' Guild of Sri Lanka.

She is currently working with Amnesty International's regional office in South Asia on human rights violations related to the protection of human rights defenders in Afghanistan, rights of Rohingya refugees in Bangladesh, and enforced disappearances in Pakistan, Maldives, and Sri Lanka. As a Policy Leader Fellow at the EUI, she is focusing on enforced disappearances in South Asia and the application of the transitional justice process to bring justice to the victims and their families. Yasasmin holds a master's degree in Conflict Displacement and Human Security from the University of East London.

Her other academic interests include journalism and international relations for which she has academic qualifications from India and Sri Lanka.

Manjusha Mukherjee is an environmental specialist and policy strategist from India. As a Policy Leader Fellow at the School of Transnational Governance, EUI, she is engaged in analysing the best EU policies on resource efficiency and waste management in addressing climate mitigation and is aiming to develop policy recommendations for India. In her professional career of close to a decade and a half now, different aspects of climate change, environmental governance, and waste and sustainability has been her key interest and engagement areas. 


Boshko Stankovski Fellowship period: 1 February 2022 – 30 June 2022

Boshko researches international law and international politics with a focus on peacemaking and peacebuilding, particularly negotiation and conflict resolution, democratisation and good governance, human rights, and the role of youth in these processes. As a Policy Leader Fellow at the School of Transnational Governance, he will be studying civil-military relations in post-conflict societies.

His Ph.D. dissertation at the University of Cambridge studies peace agreements on self-determination and secession disputes.
