#### I. The Foundations of Transnational Governance

Offers perspectives on the actors, structures and practices of transnational governance and how informal and formal rules and regulation impact "beyond the state" and transform national political systems.

#### II. Tools of Transnational Governance

Provides the legal and statistical language necessary to understand the effects and impacts of transnational governance, as well as a learning platform to design future tools for dealing with them.

#### III. Economics

Drives learning about the essential economic insights to understand economic transformations and the consequences of specific regulatory solutions.

#### IV. Professional Development

Offers a broad range of practical skills ranging from negotiation to policy design, including leadership, project management skills, gender mainstreaming, and much more. Students will gain professional development skills training and other technical competencies to succeed in their careers.

#### V. Consolidation Electives

A selection of courses that provide students an opportunity to consolidate individual expertise within one of five specialisation tracks in transnational governance.

#### VI. Free Elective

Students complement their consolidation expertise by freely choosing one specialisation area elective from the rich offer of transnational governance courses available.

#### VII. Statecraft - Public Leadership & Policy Expertise:

This module offers a unique and practical experience to engage in interactive, meaningful discussions with established policy leaders, world-leading scholars and distinguished executives. Students will have the possibility to attend to a wide range of seminars, workshops, lectures and talks offered by the School in the different areas related to Transnational Governance.
