ATTENTION:

- The request for participation in the tender must be signed:
 - In the case of a single undertaking, by the legal representative or by a person duly authorized to undertake the same;
 - In the case of a consortium or grouping by TAC, by the legal representative or a person duly authorised the powers of the company, consortium or parent company/agent;
 - In the case of not yet constituted EEIG and TAC consortiums, by the legal representatives or persons duly authorised the powers to undertake the same.
- If the petitioner is a prosecutor or another entity, it must be accompanied by documentation (Chamber of Commerce certificate or power of attorney, in a copy certified in accordance with Legislative Decree 445/2000), which clearly infers power to validly bind the competitor to the tender.

¹ Pursuant to Article 38.2 of Legislative Decree 445/2000, the declarations of the affidavit shall be signed by the interested party and presented together with a non-certified photocopy of an identity document of the applicant. If the documentation is signed by the "attorney" of the company, it must be accompanied by a copy of the relevant power of attorney (general or special) or other document from which to infer the powers of representation.
