To being fully aware that for this contract there are risks of interference and to have taken this into account when formulating the offer. To being aware of all general, particular and local circumstances barring none and of any other element which may directly or indirectly affect the implementation of service or the determination of the bid tendered and thus to declare this bid as remunerative, with the commitment to keep it valid and binding for 180 (one hundred eighty) days from the date of the deadline for its submission. Requisites of economic-financial capability To be in possession of two bank references issued by primary Italian banks or authorised intermediaries as per Legislative Decree 385/1993 issued later than this letter of invitation, stating that the bidding company has always paid its debts regularly and punctually and that it has the economic and financial capability to perform the services pursuant to this tender.
