

The Academy of European Law offers the option of paying a reduced course fee of 100 EUR to selected course participants working or studying in the following countries.

Please check that the country where you work / study is included in the list before making a request to pay a reduced fee. Your nationality is not the determining factor; you must be working or studying in the country at the time of application.

The list was compiled using World Bank data and definitions. Low-income economies are defined as those with a GNI per capita of \$1,145 or less in 2023; lower-middle-income economies are those with a GNI per capita between \$1,146 and \$4,515; upper-middle-income economies are those with a GNI per capita between \$4,516 and \$14,005.
