

Research Seminar Spring 2011 Jorge Flores Thursdays, 13.00-15.00, Belvedere

Travels, Books, Audiences and Empires, 1400-1800

This seminar intends to analyse the complex relationship between early modern European empires and the world of travel and travel accounts in the same period. The main purpose is to discuss the ways in which the "travel-imperial experience" was interwoven with writing and reading practices, book-manuscript circulation and reception, library organization. etc. One will also focus on the role of images and the European status of non-Western knowledge.

The seminar integrates a workshop on "Islam and Europe in early modern books" (final programme and dates to be announced in due time). Each seminar session will be introduced by a brief presentation of the readings by one or two participants. The researchers are also expected to take actively part to the discussion based on the comment of these readings.
