OTHER PRIZES AND AWARDS

2011

Bryant Garth (LAW 1973- 1976) and his co-author Yves Dezalay won the Herbert Jacob Prize from the Law and Society Association in May 2011 for the best book on law and social science published in 2010. The book is *Asian Legal Revivals: Lawyers in the Shadow of Empire* (Chicago, University of Chicago Press)

Johanna Engström (LAW 2001-2009) has been awarded the European Public Law Group's special distinction 2010 for her thesis *Europeanisation of remedies and procedures - can a Trojan horse achieve effectiveness?*

Pablo Ibáñez Colomo (LAW 2006-2010) was awarded the Jacques Lassier Prize by the International League of Competition Law. The Prize is awarded every two years for Ph.D. dissertations written in competition law and related fields (including intellectual property and unfair competition), and was established in memory of Jacques Lassier, a former President of the League and one of the first practitioners in continental Europe to understand the importance of EU competition rules. The ceremony took place at Christ Church College in Oxford during the annual congress of the League.

Marie-Claire Ponthoreau (LAW 1987-1991) has been awarded the 'Prix du livre juridique 2010' during the Salon du Livre juridique for her recently published book *Droit(s) constitutionnel(s) comparé(s)* (Éditions Economica – Collection Corpus droit public, 2010). The prize is organized by the *Club des juristes et le Conseil Constitutionnel.*

Christoph Beat Graber (LAW 1989-1993), Professor of Law at the University of Lucerne, received the Swiss Academies of Arts and Sciences Award for Transdisciplinary Research, for the project he directed 'eDiversity - The Legal Protection of Cultural Diversity in a Digital Networked Environment'. The project was selected 'for its integrative, timely and path-breaking intervention in the field of media regulation concerning the protection and promotion of diversity of old indigenous as well as very new cultural expressions.' The award is the highest research prize of the Swiss Academies of Arts and Sciencies.

Dorte Sindbjerg Martinsen (LAW 1999-2004) is currently associate professor of political science at the University of Copenhagen. In 2009 she won the Vincent Wright Prize for one of the two best articles published in *West European Politics* in 2009
