## ABSTRACT

The Digital Public Sphere Working Group addresses current digital governance issues – such as AI and platform regulation, or data governance - from a public law perspective. It offers an interdisciplinary platform for researcher discussion on the interactions between the use and impact of digital technologies and public law values and norms.

Our researcher-driven dialogue focuses on two main areas. On the one hand, we look at the impact of new technologies on administrative activities, exploring the development, procurement and deployment of those technologies by public administrations across various domains, and analysing how public values can be safeguarded in the evolving digital State. On the other hand, we address the broader implications of social media platforms, big data and AI systems on societies, examining how those are and should be regulated, both within and beyond the confines of the State.

The Working Group's activities and particular thematic focus are ever-changing and cater to our researchers' interests and needs.
