Security studies has traditionally been one of the pillars of International Relations, next to such subfield as International Political Economy, for example. As other subfields in IR, it is also open to contestation in terms of, for example, subdisciplinary boundaries and theoretical foundations. Events and trends such as 9/11, the digital revolution, Covid-19, questions of what structure the world that we are living in, or Russia's war of aggression in Ukraine have renewed interest in strategic and security studies. The course surveys the field of contemporary international security theory and practice in transversal streams: (1) revisiting the foundational concepts that have structured the discipline, including security dilemma, deterrence and security community and (2) examining the conceptual and sociological innovations and underpinnings of (critical) security studies.

By the end of the course researchers will have:

- become familiar with the main debates in contemporary security studies and their relationships to one another;
- become able to identify the assumptions underpinning these debates as well as their theoretical origins;
- become familiar with current research conducted within various theoretical frameworks as well as critically evaluate their arguments;
- considered the relevance of particular approaches to their own work and practiced different forms of argument construction.

# Course requirements consist of

- Complete the readings and active participation in the seminar discussions and debates, e.g. contributing to addressing broader issues and questions underlying the readings, identifying strengths and problems with theory & research design as well as discussing potential room for revisions.
- authors' defendant (1x), that is, defend the merits of the week's readings in class.
- 2 discussion questions (1x) with a short explanation of why these questions occurred to you. Please upload these questions on the course page on Brightsapce and circulate them to the entire class via email no later than one day before class.
- Class expose (1x) of about 15 minutes introducing the articulation of the research questions, concepts, arguments, methods (while keeping in mind that everyone has read the texts already).

To receive credit for this seminar, you must get a pass on each of them.
