The primary focus of the workshop is on the influence of social origins on labour market success over and above the effect of own education. Each participant will address four main research questions in his/her country. First, is there a direct effect of social background on labour market success over and above the effect of own education? Second, has this effect declined over time? Third, does it vary depending on the level of education achieved and, more precisely, is it weaker among those with higher education. Fourth, has the direct effect of education on the labour market success varied over time? Furthermore, we will also make some steps in investigating the mechanisms underlying the social origin effect and in explaining the cross countries differences in the strength of residual social origin effects, using institutional and macro-level characteristics of the various countries.
