## **FOREWORD**

Little did I know, when I took over the directorship of the Max Weber Programme from Professor Richard Bellamy in 2019, what a ride this was to be for the Programme. I should have been forewarned: by some strange coincidence, 2020 marked the 100th anniversary of the premature death of the Programme's namesake, Max Weber. Although disputed, many claim that he was a victim of the Spanish flu pandemics that ravaged the world between 1918 and 1920. For better or worse, however, the Spanish flu, and the lessons it could have taught us, have been forgotten. Blissfully ignorant of past and present pandemics, the Programme started the Academic Year full of enthusiasm. We had received almost 1,060 applications, and in September we welcomed a cohort of 59 brilliant Fellows. We were looking forward to a packed agenda with the September presentations, Max Weber Lectures, workshops, thematic research groups and the training components of the Programme. Arguably, most of all, we were excited about the many possibilities for personal exchanges over coffee or lunch in the corridors, on the terraces and in the gardens of the Badia and the Villa Paola. Until this day, I am grateful that we could come together in person and forge close collegial and intellectual bonds before disaster struck. From March onwards, the world as we knew it ceased to exist. The first wave of the Covid-19 crisis, which had hit Italy so hard, forced all of us to isolate at home and go fully online. These were very testing months, which took a big toll on everyone. I am grateful and proud that despite this, the Programme carried through with most of its activities, and that the cohort could stay in touch, even if only virtually. My gratitude goes to the brilliant Fellows who have continued even during lockdown to make this Programme an intellectually stimulating and personally most enriching experience. And it goes above all to the wonderful Max Weber team, whose never ending efforts to adapt to an online world enabled us to support our Fellows as much as possible during these testing times, and carry through all activities, including a fully online June conference.




## MAX WEBER PROGRAMME IN 2019-2020 STATISTICS

#### APPLICATIONS FOR THE 2019-2020 MAX WEBER FELLOWSHIPS

By 18 October 2018 the Max Weber Programme had received 1,058 applications from 93 different countries for the Max Weber Fellowships 2019-2020.


#### FIGURE 1: APPLICATIONS TO THE MWP IN OCTOBER 2017 AND OCTOBER 2018 BY REGION

As in previous years the appeal of the Programme has reached out globally and applications came from around the world (Figure 1).

The European region remains by a long shot the strongest contributor of applications (626), followed by Asia (162) and North America (156).

Italy (155) takes the lion's share of applications (Figure 2), followed by the US (128), Germany (73) and the United Kingdom (65).

The gender ratio among applicants is slightly in favour of males (57%).




FIGURE 3: APPLICATIONS BY GENDER AND BY DEPARTMENT, 2018

The gender distribution by department instead reveals a degree of disparity by discipline (Figure 3). Applications by women to the department of Economics are one third (34%). To a lesser extent History and Political and Social Sciences also show a gender gap whilst the Robert Schuman Centre instead seems to appeal more to women (62%) than men (38%) and Law is the most balanced.




FIGURE 4: APPLICATIONS BY DEPARTMENT, 2018

As in the past, the departmental share of applications is substantially uneven (Figure 4). The department of Political and Social Sciences leads over the others with 425 applications, followed by History and Civilization with 322. The Robert Schuman Centre lags behind with 70 applications in total.

The data suggest that the Programme maintains its global appeal and its strong European focus.

As in the previous calls, applicants had the opportunity to choose a Thematic Research Group (TRG), as an interdisciplinary forum to discuss their common research interests. Alternatively, they could opt out of the thematic frame. This year the number of those opting out was much reduced (246), and it was lower than that of those choosing the most popular group (250).

The composition of preferences for a TRG by department shows that each TRG attracts from all disciplines, although some received more applications from a given department (Figure 6). Applications to the RSC, for instance, are highly concentrated in the group Citizenship and Migration, whilst applicants to ECO are split between the Tommaso Padoa Schioppa group and the newly formed Experimental Methods in Social Sciences group. The largest number of applicants to ECO however still chooses to opt out altogether.

#### MAX WEBER FELLOWS: 2019-2020

The Programme awarded 48 new Fellowships making the success rate about 4.5%. In total the cohort consisted of 59 Fellows, of whom 11 carried on their Fellowship from the previous year.

The average age of the Max Weber Fellows in 2019-2020 was 31 years and 55% of Fellows were women. The Department of Political and Social Sciences (SPS) received a larger share of Fellowships than the other departments.





FIGURE 8: MAX WEBER FELLOWS BY DEPARTMENT, 2019-2020


Sixteen of those offered a Fellowship withdrew before registration in September. They were offered either tenure track positions or longer-term fellowships elsewhere.

FIGURE 9: WITHDRAWALS FROM AWARDS 2011/2012 - 2019/2020




SPS was the department most affected by withdrawals, followed by HEC.

The 2019-2020 cohort of Max Weber Fellows included 29 different nationalities, confirming the global character of the Programme, although the predominance of German (10) and Italian (8) Fellows was marked.

Equally global and diverse is the list of institutions to award PhDs to the 2019-2020 cohort. Once again British academic institutions lead the ranking with 16 Fellows obtaining their PhDs in the UK, followed by the US (9), Italy (7), France (6.5) and Switzerland (6).



#### MAX WEBER FELLOWS AND THE JOB MARKET

The Covid-19 crisis made the hiring process very complicated. When Covid-19 hit, many searches were canceled or put on hold, and many institutions instituted either year-long or even two-year-long bans on hiring.

Despite the crisis, the 2019-2020 cohort had an excellent success rate (93.4%) on the job market over the year: 43 Fellows had moved on to new jobs by September 2020 (41 academic jobs, 2 non-academic jobs), 13 started their second year in the Fellowship, and 3 were still on the job market (Fig.13). Among those moving to new jobs, 28 went to a country different from the one where they received their PhD and 15 moved to the same country of the awarding institution, confirming that the Fellowship enhances the mobility of young academics, one of the aims of the Programme.

# MAX WEBER PROGRAMME ACTIVITIES 2019-2020

The activities of the Max Weber Programme are concentrated around two core themes: **Academic Practice** and **Multidisciplinary Research.** Over the years of the Programme, the objectives of the academic practice activities have become more structured and focused. An important lesson has been that professional skills are best learned when working in small groups which allow for frank exchange of experiences and reflection on best practices; tutorials and individual feedback based on different needs have also increasingly become an integral part of the Programme. The research activities, on the other hand, demand a multidisciplinary focus and a strong level of participation from as many Fellows as possible to reach their aim of enhancing and fostering multidisciplinary understanding.

#### **ACADEMIC PRACTICE ACTIVITIES**

Building on the experience gained in previous years, in 2019-2020 the Academic Practice activities were organised into three Modules: i) Job Market ii) Publishing and Writing and iii) Teaching. The activities within the three modules ran throughout the year to allow for continuity and follow-up according to participants' needs, with activities related to the job market (with the exception of individual support) concentrated primarily in the first term.

#### PREPARATION FOR THE JOB MARKET AND CAREER DEVELOPMENT

The Max Weber Programme actively supports Fellows seeking an academic position. This support takes various forms: workshops in which Fellows discuss and develop their CVs, cover letters, bio-sketches, and web pages; professional feedback on presentation and interviewing skills; a taught module to enhance presentation skills; individual consultations to assist Fellows in defining their job search priorities and strategies; organisation of mock job talks and other 'just in time' support when Fellows are long- or short-listed; advice on and editing of application materials; more broadly, the creation of a variety of informal occasions for sharing information and discussing job market strategies in their fields. Understanding the broader face of global academia and having access to up-to-date information is

Understanding the broader face of global academia and having access to up-to-date information is essential to informed career planning. The MWP is also a platform for obtaining information about, and reflecting on, the current state of the academic job market. In particular, the Academic Careers Observatory (ACO) offers a unique resource for researchers looking for a job in academia and, in general, for people interested in the international comparison of academic careers.



An increasingly vital part of the job market is self-presentation on the internet. To assist the Fellows in presenting themselves and their research in the best possible way, the EUI offers all Fellows the opportunity to construct their own website (https://me.eui.eu/website-directory/) and support for developing skills in communicating about their research to non-specialist audiences.

The 2019-2020 MWP activities on the job market were:

- September presentations, filmed and followed up with individual feedback sessions by the EUI Academic Communications Skills (ACS) Staff.
- Presentation and Public Speaking module in early October (with ACS Staff).
- 'Job market package' session in the first term for preparation of application materials (with Laurie Anderson, MWP) and relative individual tutorial followup throughout the year.
- Departmental presentations by Fellows in seminars.
- Advancing a personal Academic File with a draft Research Grant Proposal and a new Course syllabus outline.
- Engagement with Academic Careers Observatory activities
- Job talks and mock interviews by the Fellows, with feedback from MWP peers and EUI Faculty.
- Fellows' June Conference: organization and on-going research presentations.

Since its inception, the Max Weber Programme has proved to be very successful in the placement of its Fellows in an increasingly competitive academic job market: like the 2008-09 financial crisis, however, the Covid-19 pandemic (which hit Italy in early March, 2020) impacted the job search process for those Fellows who had not yet secured a position by that date. Although the 2019-2020 cohort had overall an excellent success rate on the job market (93.4%), with only 3 Fellows still looking for positions as of September 2020, in some cases the positions obtained were of shorter duration or with less certain career prospects than in previous years. To support Fellows in weathering the difficult transition period, the Programme extended support for the job search beyond the end of the official fellowship period (until the end of December 2020), in particular, in the form of editing of application materials and tutorial support.

#### PUBLISHING AND WRITING

The MWP considers writing and publishing a core element of academic advancement. Two sets of activities are carried out to support the Fellows in this area: workshops organised by the Programme and the writing activities offered by the EUI Academic Communications Skills (ACS) staff / FIE-SOLE Group. The latter activities are designed not only to assist non-native Fellows in fine-tuning their English language skills but also to support the writing process for all members of the Programme and for them to excel in English academic writing. They take various formats: i) two academic writing modules, offered in the first and second term, ii) individual tutorials and iii) disciplinary writers' groups, the latter two continuing throughout the year. The Max Weber Programme and the EUI Language Unit also offer the Fellows an extensive language revision service. Language revision and copy-editing is offered to all Fellows for their publications and working papers. Fellows can also use the revision service for their Power Point slides, CVs and cover letters.

The 2019-2020 activities on publishing and writing were as follows (where the move of Programme activities online from early March onward made changes in format or structure necessary, these have been noted):

- Workshop, 'Research and Grant applications: how to write a research proposal', January (with UCL Faculty).
- Publishing Strategies workshops, by discipline, December to February (EUI Faculty, ACS staff).
- 'Writing a book proposal', general session and individual tutorials, November (with John Haslam, CUP); individual feedback on book proposals, second and third term, in lieu of in-person workshop and feedback originally planned (Roger M. Haydon, Cornell University Press). In both cases, this feedback from editors was preceded by individual feedback on preliminary drafts of proposals on the part of the ACS staff.
- Research Grant Proposal (with written feedback from EUI Faculty).
- MWP Working Paper, to be published in Cad-

mus (with written feedback from EUI mentor).

- Taught module, 'Style in Research Writing' (first term).
- Taught module, 'Writing your Journal Article: Draft to Submission' (second term).
- Writers' Groups, by discipline (LAW, SPS; moved online, via Zoom, from March to July).
- Individual tutorials on written work (e.g. research proposal, working paper, book proposal, course syllabus, articles in progress, application materials), job talks, PowerPoint presentations, etc. (support utilised by circa 75% of the Fellows).

#### **TEACHING MODULE**

The Max Weber Programme aims to improve and develop standards of excellence in Fellows' teaching skills. Completion of the Teaching Module gives the Fellows the Max Weber Teaching Certificate, which is a valuable addition to Fellows' academic profile.

The Certificate is worth 3 points in the European Credit Transfer System (ECTS). It is designed to enhance Fellows' ability to respond flexibly and professionally to the teaching and learning needs of today's increasingly diverse higher education scene.

Fellows who elect to do the Certificate will take part in an innovative programme culminating in teaching practice weeks at top European universities: Humboldt, Masaryk University, Natolin College of Europe, Pompeu Fabra, Trinity College Dublin, University College London and the University of Florence.

Hands-on workshops designed to foster a reflective, transnational approach to the teaching/learning process lead up to this teaching experience abroad.

In order to obtain a **Max Weber Programme Teaching Certificate**, a Fellow must have successfully completed the prescribed academic practice activities organized by the MWP.

The 2019-2020 MWP activities on Teaching were:

- Workshop, 'Course Design' with Lynn McAlpine (Oxford).
- Workshop, 'Preparation for Micro-Teaching & Teaching Practice Weeks' with Lynn McAlpine (Oxford).
- Workshop 'Preparation for Micro-Teaching & Teaching Practice Weeks: Seminar Teaching' with Neil McLean (LSE).
- Workshop and individual feedback on the Micro-teaching Sessions with Lynn McAlpine (University of Oxford).
- Workshop 'Teaching Portfolio: Integrating the elements of MW Teaching Programme' with Lynn McAlpine (Oxford).
- Workshop, 'Developing Reflective Practice: Approaches to Classroom Observation' with Laurie Anderson (MWP).
- Humboldt Teaching Practice (because of Covid-19 this took place online).
- Masaryk Teaching Practice (because of Covid-19 this took place online).
- Natolin College of Europe Teaching Practice (because of Covid-19 this took place online).
- UPF Teaching Practice (because of Covid-19 this took place online).
- Actual teaching by Fellows is not a MWP requirement but taking into account that Fellows arrive with differing teaching experience, and that teaching methods differ across fields and university systems, the MWP offers different options for gaining practical teaching experience. This supports Fellows in their search for an academic position. It is the strategy of the Max Weber Programme to offer opportunities not only outside the EUI (where undergraduate teaching is possible) but also within the EUI.

Within the EUI, where mainly research-oriented seminars, master classes and workshops are 'taught', there is widespread opportunity to gain teaching experience at a high post-graduate level. Post-graduate teaching, tutoring and advising PhD researchers, as well as co-organising seminars and workshops, are activities very much appreciated by Max Weber Fellows. Fellows are also put in charge of organizing some of the summer schools for European MA students in the Social Sciences. Departments hold Fellows' seminars on a regular basis. Considering the standards of excellence of the Max Weber Programme, and the highly selective appointment of its Fellows, a systematic collaboration between EUI Professors and the MWP postdoctoral Fellows promotes the European and global academic reputation of all Departments and the appeal of the EUI as a whole.

Local Universities: Over the past ten years, the MWP has expanded its network of collaboration with local universities and has established links with many of the Florence-based American campuses, and Italian Universities offering undergraduate or MA level courses. Among these are James Madison University, Gonzaga University, New York University at La Pietra, FIT/Polimoda and IMT Lucca. Max Weber Fellows are offered teaching and/ or lecturing opportunities at several of these universities. The MA in European Union Policy Studies offered by James Madison University in Florence, for example, guarantees priority in the selection process to Max Weber Fellows with competences in line with James Madison University's teaching needs. Courses can also be team-taught. Fellows are requested to use state-of-the-art, interactive, teaching methods and are monitored and supervised, in order to improve their performance. Grading methods and tutoring of papers, as well as assessment skills, are developed in conjunction with the academic coordinator. Fellows receive professional feedback on their performance and an overall written evaluation of their teaching skills by the end of each course. **Teaching Abroad**: In 2008, the Max Weber Programme set up a 'teaching abroad' programme with the London School of Economics in which Max Weber Fellows were offered the possibility of a week's teaching experience. In May 2008 five Fellows visited the LSE where they each gave a public lecture and a seminar and received professional feedback on their performance from Nick Byrne, Director, and Neil McLean, Professor, at the LSE Teaching and Learning Centre. In addition, the Fellows had meetings with LSE faculty members in their fields. Based on the success of this experience the Max Weber Programme continued

the development of this exchange and in 2009 a selected group of sixteen Fellows had the opportunity to go either to the LSE in London or to Humboldt University in Berlin, for intensive teaching training practice for a week. For the academic year 2009-2010 an agreement was made between the EUI-MWP and the University of Pompeu Fabra, Barcelona, to set up a teaching exchange for a maximum of another eight Max Weber Fellows. In the academic year of 2014-2015, a total of twenty-five Max Weber Fellows participated and in the academic year 2015-2016 a total of twenty-three Max Weber Fellows participated in a teaching practice week and obtained a Teacher Training Certificate as a result. In the academic year of 2016-2017 twenty-two Max Weber Fellows participated in the teaching module and teaching practice week, and obtained the Teacher Training Certificate. In year 2017-2018, we extended our network for teaching placements of Fellows to UCL in London, Trinity College in Dublin, and Masaryk University in Brno, nine Max Weber Fellows organised their own teaching practice in Florence, both at the EUI and at other local institutions.

In 2019-2020 nineteen Fellows chose to complete the teaching module and were awarded the MWP Teaching Certificate on 24 June.

#### ON THE MASARYK TEACHING PRACTICE

The teaching practice took place online from 20-30 April 2020, and was set up in collaboration with the Language Centre of Masaryk University (Brno), Libor Štěpánek and Barbora Novotná. The Masaryk Teaching Practice week required the Fellows to teach a 90-minute lesson twice for students (undergraduate or postgraduate) in law, economics, history or social and political sciences. The Fellows were asked to plan an interactive class, and not to lecture more than 25% of the time. Fellows were encouraged to choose a core concept for their teaching. The attending students provided the Fellows after each class with written feedback. while Masaryk faculty attending the class gave them detailed oral and written feedback after each class taught. Before the teaching practice the Fellows were asked to submit a form formulating the goals they hoped to achieve during the TPW and expressing any potential problems they could foresee. They were also very much encouraged to observe their peers teaching, and if requested their own teaching could be recorded.

Seven Fellows taught at Masaryk University: Anca Cretu (HEC), Julie Deschepper (HEC), Jorge Díaz Ceballos (HEC), Nikolaos Mavropoulos (HEC), Arianna Tassinari (SPS), Pauline Trouillard (LAW), Stylianos Tsiaras (RSC).

#### ON THE UPF TEACHING PRACTICE

The UPF-MWP Barcelona teaching practice took place online from 4-8 May 2020, and was set up in collaboration with the coordinators of the MWP exchange at UPF, Pau Solà, Marina Muñoz and Lucia Gil Royuela, of the Teaching Quality and Innovation Center (CQUID) and the Dean of the Faculty of Humanities, Mireia Trenchs. All Fellows taught a couple of sessions within the undergraduate courses and each gave a talk on a topic related to their research. They were also in contact with MA and PhD students and professors of the respective faculties and departments hosting their teaching. Four Fellows taught at UPF: Andreas Greiner (HEC), Ian Hathaway (HEC), Milica Prokic (HEC), Ester Sigillò (RSC).

#### ON THE HUMBOLDT TEACHING PRACTICE

The teaching practice took place online from 25-29 May 2020, and was set up by agreement between the Max Weber Programme and the English Department of the Language Centre, Humboldt University, Berlin. The Humboldt staff responsible for the organisation of the module were Connie Hacke and David Bowskill. The module included three components: class observation (prior to teaching), MW Fellows observed the group they would be giving the tutorial to during a language class (English for Specific Purposes), the colleague teaching the class afterwards discussed all technical and other details of the tutorial to be taught by the Fellow; tutorial, three convenors observed the tutorial and gave feedback to the Fellow, students filled out feedback forms which were discussed in the feedback session, other Fellows attended the tutorial and the feedback session; lecture, MWP Fellows gave an open undergraduate lecture in their own discipline, the convenors attended the lecture and there was a feedback session, other Fellows attended the lecture and the feedback session.

Six Fellows taught at Humboldt: Émilien Fargues (RSC), Mateusz Grochowski (LAW), Lana Martysheva (HEC), Viola Müller (HEC), Giacomo Tagiuri (LAW), Alexandra Zeitz (SPS).

### ON THE NATOLIN COLLEGE OF EUROPE TEACHING PRACTICE

Every year the College of Europe at Natolin invites Max Weber Fellows at the EUI to devise and lead two workshops on historical topics. This collaboration between the Max Weber Programme at the EUI and the European Civilization Chair at the College of Europe is part of a wider cooperation between the two institutions. ## MULTIDISCIPLINARY RESEARCH

The Multidisciplinary research activities encompass the Thematic Research Groups; the Max Weber Lectures, with at least one Lecture linked to each of the TRGs, to which the Lecturer gives a Master Class as well as being interviewed by one or more of the TRG members; the Multidisciplinary Workshops, which are organized by the Fellows themselves; the June Conference, which is likewise organized by the Fellows and provides a summation of the academic year; the ACO Conference for national and European funding opportunities in the Social Sciences for young scholars; the Joint Graduate Symposium with James Madison University in Florence.

## MWP THEMATIC RESEARCH GROUPS

Fellows within a TRG have the opportunity to present a paper based on their research, attend a Master Class with at least one, and sometimes two or even three Max Weber lecturers – in the case of TRGs involving several disciplines –, and discuss their research proposals. Each group is led by one or more professors.



## Citizenship and Migration – academic leads, Andrew Geddes (RSC), Martin Ruhs (RSC)

This theme has a double focus on citizenship and migration.

It looks at issues of political and legal constructions of community, boundaries and membership at local, national and supranational levels and to the newest developments (empirical and theoretical) in this field. It also discusses novel trends in the field of migration and mobility. Finally, and most importantly, the theme draws the link between evolving conceptions of citizenship and community with social and economic phenomena of transnationalism and of cultural diversity management in an increasingly mobile and interconnected world.

# Europe in the World: International Relations, International Security, World Politics – academic leads, Ulrich Krotz (RSC/SPS) and Corinna Unger (HEC)

This thematic area brings together cutting edge research in the areas of international relations, international security, and world politics, all broadly defined. It seeks to integrate theoretical and conceptual insights with empirical research and political or historical relevance. It involves projects from the disciplines of international relations, political science, history, and law, as well as from related fields, and is both inter- and transdisciplinary. While the cluster focuses on the EU and/or one or more European states, it also embraces innovative projects investigating other geographical regions

or states or otherwise engaging with world politics, as well as comparative research. The sorts of topics likely to be explored include: Europe's role and place in the emergent world of 21st-century global politics; Europe's foreign relations broadly, including the EU's or European states' evolving relations with the major and emerging powers (including the US, China, Russia, India, Brazil), as well as regional and global international organizations; foreign, security, and defence policy; the impact of the grand shifts and continuities in international affairs on Europe itself.

This group brings together researchers with an interest in issues of constitutionalism, political regime and politics on the national, transnational and supranational levels. It looks at issues of political equality, the shift from government to governance, and the relations between law and politics. It combines empirical and normative analysis, and perspectives from political science and law.

## Ideas, Concepts and Theory – academic leads, Andrea Sangiovanni (SPS) and Ann Thomson (HEC)



Themes include the nature of law; justification and legitimacy; normative and metaethical theory; the relationship of law and politics to morality; social and political philosophy and their application to the assessment of public policies and practices. The group provides a forum for interdisciplinary exchange on these and similar themes, and dialogue between those interested in various contemporary theories and/or the history of ideas.

#### Tommaso Padoa-Schioppa: Assessing the Fiscal and Monetary Framework of the EU – academic leads, Jean Pisani-Ferry (RSC) and George Papaconstantinou (STG)

This theme is inspired by the work of Tommaso Padoa-Schioppa (1940-2010), a central banker and Minister of the Economy and Finance in Italy (2006-08). He is often credited as the father of the European single currency. The theme brings together economists working on monetary policies, international macroeconomics and finance, economic historians, political economists, and lawyers interested in financial regulation and constitutionalism, to explore issues in these broad areas in which Padoa-Schioppa worked and wrote.

#### MAX WEBER LECTURES

The 2019-2020 Max Weber Lectures were given by:

#### Valerie Jane Bunce (Cornell University)

Her lecture, *Tit-for-Tat: The U.S.-Russian Game of Weaponizing Elections*, took place on 16 October 2019.

Abstract: Russian intervention in the 2016 U.S. Presidential election, along with the Russian invasion and de-stabilization of Ukraine, beginning in 2014, were responses to repeated U.S. electoral interventions in Russia's neighborhood. This two-person game of electoral tit-for-tat shared similar goals, such as de-stabilizing the other country, supporting the election of more friendly leaders and laying some groundwork for regime change. The weaponization of elections under-

mines democracy, supports growing authoritarianism and undermines international alliances.

**Richard Whatmore** (University of St Andrews)

His lecture, The End of Enlightenment and After, took place on 20 November 2019.

Abstract: The major claim of this lecture is that a central fact has been missed by generations of historians and commentators. It is that in the final decades of the eighteenth century many contemporaries believed that they had failed the challenge of maintaining Enlightenment and were

set fair for an era of civil and likely international war, the growth of intolerance, and possibly political apocalypse, in the sense of the collapse of existing constitutions and governments. Some have argued that such fears for the future were a commonplace response to the French Revolution. The problems identified as likely to cause the end of enlightenment occurred much earlier in actuality. The French Revolution was more a response to anticipations of imminent crisis than their cause. The view became widespread after the end of the Seven Years' War that new forms of fanaticism were abroad. Traditionally associated with religious extremism, as societies across Eu-

rope became polarized, frightening forms of superstition and enthusiasm were being translated from religion into politics. These terms – superstition, enthusiasm and fanaticism – were of fundamental importance in any understanding of eighteenth-century thought. They need to be defined as they identify worries about the likely future for numerous philosophers who died between Hume (1776) or Rousseau (1778) and Paine (1809).

#### Nadia Urbinati (Columbia University)

Her lecture, *The Populist Ambition*, took place on 15 January 2019.

Abstract: The lecture is devoted to the examination of populism as the construction of a new kind of representative government. A populist democracy promised is the form representative democracy can take in the age of the empire of the audience, in which horizontal networks of commu-

nication and transient movements shatter political associations and make politics a terrain of conquest by leaders, whose representative claim relies on the verdict of the audience and the daily communication with the people. representation Direct within electoral democracy: this seemingly oxymoron is the physiognomic of a populist form of democracy.



#### Marie-Janine Calic (Ludwig Maximilian University Munich) Her lecture, The Enlightenment in South-

eastern Europe, took place on 19 February 2020. Abstract: The lecture explores 'enlightened' political thinking in the region from the mid-18th century onwards. It outlines different types of 'enlightenments' in the Balkans and their respective main features, time frames and transformations. It demonstrates how Croatian, Serbian, Greek, Romanian and other intellectuals both from the Habsburg Monarchy and the Ottoman Empire formed part of a broader European network of thinkers sharing similar values of patriotism and cosmopolitanism at a time. Moreover, influences from 'radical' France (in particular Voltaire) were as much present in the region as 'moderate' phi-

losophers from Austria and Germany (like Christian Wolff). The lecture also looks into the main channels of transmission of new ideas in societies where a large majority of people were illiterate. Yet, the enlightenment provided for new arguments and methods of thinking, and it changed discourses, values, social practices, and representations in the region.

Mariana Mazzucato (University College London) Her lecture, Rethinking Value Creation for a post-Covid recovery that is inclusive & sustainable, took place on 29 June 2020 on Zoom.us; it was jointly organised with Rethinking Economics and the Institute for Innovation and Public Purpose.

Abstract: Value is often confused with Price. And the public sector is not seen as a value creator, just a market fixer. The lecture looked at both these problems and developed a new approach to public policy that is based on market shaping and co-creation. It focused on the implications for achieving sustainable development goals and for constructing a post-Covid economic recovery that is sustainable and inclusive.

The lecture was based on two key references: Mazzucato's latest book *The Value of Everything: making and taking in the global economy,* and her high impact work with the European Commission on Mission Oriented Policy.

Three other planned lectures Ruud Koopemans (WZB Berlin), Waltraud Schelkle (LSE), and Axel Honneth (Columbia University New York), were cancelled because of Covid-19.

#### **ABSTRACT**

#### **Lifecycle of Intergroup Conflict**

#### **ABSTRACT**

Subnational intergroup conflict has become ever more salient in Europe and the world over the last decades: from ethnic, religious, gender, class, ideological, generational differences to territorial disputes and anti-immigrant sentiment, there are various groups along the lines of which distributional conflict has formed. In this workshop, we aim at taking a broader, multidisciplinary perspective on the entire lifecycle of in-out-group relations: How does a group become an out-group? How does conflict between groups develop, manifest itself and abate in different contexts? What increases and reduces prejudice towards other groups? In two mornings, nine presentations and a moderated closing discussion, we shed light on these and more questions, hear about Tunisia, Italy, Turkey, the U.S., Germany, and Switzerland, discuss consequences of outgroup status for labor market integration, political attitudes and behavior, and learn about ethnic, racial and immigrant/native conflict.

## Labour Market Dynamics, Institutions and their Mutual Linkages: Fostering Interdisciplinary Dialogue

#### **ABSTRACT**

This half-day, multi-disciplinary research workshop is intended as a dialogue across disciplines studying the different interactions between institutions and labour market dynamics. The mutual relationship between institutions and labour market dynamics has been for decades a key concern of a broad field of scholarship cutting across political economy, economics, labour sociology and labour history. Despite a large (and increasing) academic literature and high interest from the political sphere, dialogue across disciplines has been scarce. In this workshop the organizers brought together Max Weber Fellows, researchers and academics from across the EUI and beyond working from different disciplinary angles on topics concerning the interaction between institutions, regulation and labour market dynamics, from theoretical, historical and empirical perspectives. Together they addressed how labour market institutions at all levels shape

#### **Inequality and Discrimination**

#### **ABSTRACT**

The aim of this workshop was to bring together academics from different areas of social science working on inequality and discrimination. With an emphasis on data, theory, and policy, this workshop tackled these issues by exploring key questions like: What do the data tell us about causes and consequences of inequality and discrimination? What are the theories needed to understand what has been happening? What are policy ideas and controversies associated with these problems? This workshop embodied the multidisciplinary approach promoted by the Max Weber Programme: the organizers hoped that participants in the workshop could appreciate the contributions brought



by different disciplines on the topic of inequality and discrimination, and could see the potential of an interdisciplinary approach.

### Natural and Field Experiments for the Social Sciences

ABSTRACT

Causal identification has become increasingly important in the social sciences. Natural and field experiments, because of their use of real life data or realistic environments, are at the forefront of methodologies aimed at establishing causal relationships. These methods are continuously advancing; staying informed about the latest developments in this area is paramount to producing relevant and top quality research. Originating from the Max Weber Interdisciplinary Workshops, a group of EUI Fellows with the support of faculty has put together a workshop series targeted at bringing leading causal inference scholars to the EUI to offer methods training to EUI researchers, Fellows and faculty.

Each session comprised of a lecture and a lab exercise using R. Students were guided through problem sets to help them to implement the methodologies introduced in the lectures in their own research.



The workshops offered a half credit course (10 hours) and was open to all EUI researchers, faculty and Fellows.

### Migration in Historical and Contemporary Perspectives

#### **ABSTRACT**

This one-day multidisciplinary workshop brought together contributions linked broadly to the topic of migration. Since 2015, narratives and imagery of people fleeing conflict in the Middle East and Africa and taking to boats to cross the Mediterranean or Aegean in order to find refuge in Europe have become recurrent news. In North America, the US-Mexico border has become a space of exclusion through the migrants' forced encampment. Furthermore, various international humanitarian organizations have signaled the urgency in addressing forced displacement. However, the incidence of migration is nothing new, as waves and related crises of displacement have been recurrent historical events in times of violence, natural disasters or economic insufficiency. Indeed, contemporary forms of migration and the debates that arise from them are often underscored by historical processes related to race, gender, labour, class, and/or the state. This workshop brought together researchers and academics from across the European University Institute and beyond, working from different disciplinary angles on topics concerning local, national and international governance of migration, the socio-economic integration of migrants, and public opinion about immigration.

### The Protean Consumer: Exploring Competing Visions of Consumption and Consumerism

#### **ABSTRACT**

This workshop drew together scholars from history, law, and the social sciences whose work is linked to the study of consumption from a variety of perspectives. Through theoretical, historical and empirical contributions, the workshop aspired to pluralize consumption, and particularly the consumer, by emphasizing roles and process-

es that have been relatively marginalized in both academic and popular discourse. The consumer ceases to be understood as either vulnerable or resistant and takes on new roles. The papers in the workshop illuminated the complexity of some of such roles across different historical and geographical contexts, as well as different ideational contexts; from law to economics, from popular culture to the arts. Understanding such roles seems important because different representa-

tions of the consumer are mobilized towards different social and political ends. The workshop was an opportunity for cross-disciplinary training and contamination of perspectives that enriched individual research agendas as well as pointing to future opportunities for collaboration.



## 14TH MAX WEBER FELLOWS' JUNE CONFERENCE

#### A TIME FOR ANXIETY? 18-19 June 2020 – Online

'May you live in interesting times' warns an apocryphal Chinese saying, sometimes used in English as a curse, which was selected as the title for last year's Venice Biennale. It may indeed be wiser to desire to live in *uninteresting times*, when peace, stability, and prosperity abound. *Interesting times* are, instead, moments of rapid change, rich in opportunity but also characterized by the displacement of traditions, institutions, and forms of living, which often result in growing inequality and conflict. These moments are, in the minds of many, times for anxiety. To grapple with the transitional nature of our own contemporary world, the 14th Max Weber Conference would like to encourage a responsible scholarly reflection on the turbulent political, economic, legal, and historical processes that characterize – today as in the past – both real and perceived times for anxiety.

#### In collaboration with the EUI Law Department


On 5 December the Max Weber Programme and the Law Department (The Legal and Political Theory Working Group) organized a meeting with Professor Daniel Markovits (Yale Law School) on his newly-published book 'The Meritocracy Trap' (Penguin: 2019). The book asks highly relevant and timely questions about the role of universities and higher education in combatting or entrenching social inequalities and about the actual value of meritocracy as the social project. Professor Markovits discussed his main argument, along with the underlying data. The presentation was followed by an open discussion.



#### MAX WEBER PROGRAMME ACTIVITIES FEEDBACK 2019-2020

Despite Covid-19 enforced lockdown the programme activities were well received as appears from the survey circulated among the Fellows in June, especially the skills training and the teaching module, even online. Max Weber Lectures were not as well received. This reflects a longer trend of Max Weber Lectures falling short of expectations. The Multidisciplinary Workshops also worked well online. In general, Fellows appreciate disciplinary activities very highly, whereas they have more mixed feelings about multidisciplinary activities.

Covid-19 undoubtedly had repercussions on the job market and the support from the central EUI Social and Welfare fund to affected Fellows was very welcome.



## MAX WEBER PROGRAMME ACADEMIC CAREERS OBSERVATORY (ACO)

The MWP Academic Careers Observatory (ACO) is an on-line resource for PhD candidates, postdoctoral Fellows and early career scholars who wish to explore and debate academic careers in the humanities and social sciences. ACO facilitates the diffusion of knowledge among young researchers about national academic careers and research opportunities in the social sciences and humanities, throughout Europe and beyond. Career planning for PhD candidates and postdoctoral Fellows can be easy in one's own country of reference, but often proves complicated when pursuing an international profile. ACO provides information on academic careers by country, discipline and theme, and links to research opportunities in Europe, job platforms and a list of funding from postdoctoral to professorial level.

#### **ACO Conference**

On 28 January 2020, MWP-ACO organized the conference 'National and European Research Funding Opportunities in the Social Sciences for Young Researchers'. The conference gathered together representatives of European and national funding agencies as well as young academics to discuss research schemes and grants available to international researchers in the Social Sciences and Humanities. The speakers provided the audience with information about opportunities which are directly aimed at early-career scholars, in countries such as the Netherlands, Germany, Austria, Switzerland, France, Ireland and Poland. The conference was divided into five main sections:

- European Funding Opportunities for Young Researchers: Introduction to Marie Skłodowska-Curie Actions and the European Research Council.
- Seminar: Top Tips for Grant-Writing for Early Stage Researchers: Essential Elements of a Successful Application.
- Roundtable: Advice and Insights on the Application Process.
- National Funding Opportunities for Young Researchers, first session (Austria, Germany, The Netherlands) and National Funding Opportunities for Young Researchers, second session (France, Ireland, Poland, Switzerland).
- Individual Tutorials with Representatives of the Agencies.

### Impact of Covid-19 on the Academic Job Market in the Social Sciences and the Humanities

Because of Covid-19 disruptions, in 2020 universities have been cancelling or postponing job searches. The disruptions are going to shake up the careers of researchers at all levels, but they will likely have the greatest impact on early-career academics.

The Academic Careers Observatory (ACO) has monitored the impact of Covid-19 on the academic job market in the Social Sciences and the Humanities and its effects on the broader scientific community. The research was carried out by four EUI PhD researchers: Risto Conte Keivabu (SPS Department), Adrian-George Matus (HEC Department), Natalia Menéndez González (LAW Department), Nastazja Potocka-Sionek (LAW Department).

17 European countries and a further 6 extra-European countries were covered by the research, laid down in four main sections:

- impact of Covid-19 on the national job market
- responses adopted by the Government and the National Funding Agency
- responses adopted by the universities
- useful resources

#### WRITING

During the year, Ian produced two article manuscripts. The first, 'Exceptional Papers for Exceptional Needs: Travel Patents, Identification, and Mobility in the Early Modern Mediterranean' was accepted for publication by the *Journal of Early Modern History* and is currently forthcoming. He is also preparing a critical edition of a manuscript play *The History of Purgatory* (for PIMS, Toronto), a unique example of early-seventeenth century Catholic drama in the English vernacular, for which he was awarded a Society for Theatre Research grant.



During her time as a Max Weber Fellow, Ari worked mainly on three projects. First, she finalized a book manuscript based on her PhD thesis, which will be published in Fall 2020 with Oxford University Press (coauthored with Stefanie Walter at the University of Zurich, and Nils Redeker at the Hertie Institute of Governance). The book, titled *The Politics of Bad Options*, examines the political underpinnings of crisis responses in both creditor and debtor states during the Eurozone financial crisis (2008-2013).

Moving beyond her dissertation work, she also worked on a paper examining the role of household heuristics in shaping fiscal preferences among European voters. For this she collected survey data in Italy and wrote up a working paper dubbed 'Household Heuristics, Analogical Reasoning, and Attitudes towards Sovereign Debt', which will be sent out for peer review in Fall 2020.

Third, Ari also worked on data collection for her project 'Do Informal Connections Matter for and Political Ambition and Success?', part-financed by the Russell Sage Foundation. The large project, in a first stem aims to collect biographic information on individuals that ran for state senate and assembly positions in the US, in a period spanning 1998-2018.



This project analyses the effects of two important reforms that reduced working hours in Portugal in the 1990s, with a particular focus on firms. The project takes advantage of comprehensive data on the universe of Portuguese firms and workers in the past 30 years. This is the first reduced-form, causal evidence of the effects of working-hour reductions on firms. The paper was presented at the internal seminar of the Economics department, the economics seminar at the University of Melbourne, the Max Weber conference, and the workshop 'Labour market dynamics, institutions and their mutual linkages', which took place at the European University Institute in May 2020.
