### European Elections and the Logics of Political Recruiting

### European Citizens and the Public debate on Europe

**European Elections and their Impact on European Integration**

It is also likely that, in some domains, the input of the EP has contributed to the strengthening of the integration process. Contributions to this session systematically analyse these issues.
