Participants are engaged in a rich programme of online events and training. This project is led by the STG's Climate Cluster in close cooperation with the World Bank's Carbon Pricing Leadership Coalition.

Phase One of the project (2020) focused on South Africa and India, while Phase Two (2021) expands the programme to Saudi Arabia, Mexico, Brazil, Indonesia and Argentina (tbc).

Integrity in Sports – The Existential Crisis of Sports Governance, Corruption and Match-Fixing

Sport is facing an existential crisis: unprecedented waves of scandals, doping, and match-fixing are shaking the public's belief in sport, and participants' faith in the organisations that govern it. The failure of **comprehensive governance** and **regulatory oversights** has allowed sports corruption to flourish. Sport governing bodies, law enforcement bodies and other public authorities are neither prepared nor equipped with the resources to combat the toughest challenges facing sport in a century. Action is needed. A fundamental shift in approach is required to ensure that global practitioners are equipped with the knowledge and skill sets to combat sports corruption. To this end, the "Integrity in Sports" executive training will provide intense, hands-on, and practical education – developed "for practitioners, by practitioners" – that will teach participants the key concepts, help them access the tools and resources available, and equip them with the skills needed to combat sports corruption. The course is rigorous, but taught in clear, direct language by experts from around the world.

This executive training program aims to provide participants with a comprehensive understanding of the benefits and drawbacks of adopting a new pandemic convention to ensure the world is better prepared for future pandemics. Do we need a new **pandemic treaty**? What would it, or should it, include? What are the benefits of adopting a new pandemic convention as opposed to revising existing arrangements? Are there any drawbacks? This executive training program will provide participants with an in-depth, critical appreciation of the proposal for a new pandemic convention to strengthen global health security. Drawing from some of the world's leading experts in international law, public health, and global health governance, the executive training program will provide negotiators and interested parties with an advanced understanding of the **World Health Organization**'s constitutional authority to adopt legal instruments, consider the scope of issues to be addressed under a new pandemic convention, and critically weigh the benefits and drawbacks of adopting any new instruments versus revising existing arrangements ahead of the **Special Session of the World Health Assembly** from 29 November to 1 December where proposals for a new pandemic convention are being discussed.





Part I: Digital Actors

The governance by and of the internet brings enormous challenges on how it takes place and what can realistically be achieved. Most of its governance is only feasible on a transnational level, while the role of private actors has become increasingly central, raising a number of questions concerning the accountability of the private sector in the **transnational regulation of online content**. The training will explore different **regulatory models** (state regulation, self-regulation and co-regulation) and focus on the rationale underlying a preference for involving private actors in regulation and enforcement over purely public (top-down) law arrangements as well as the limitations and challenges this type of transnational regulation in the digital sphere. Given the speed of change in the digital media environment, and the increasing threats of private regulation to citizens' interest/rights in different sectors, the importance of ensuring private sector accountability and buy in for fundamental values is central to building citizens' trust.



Four online training modules will take place during autumn 2021, focusing on the following topics: innovative tools for fact-checkers, online disinformation: policies and regulations, principles for media information and literacy policies, and neuroscience and disinformation: understanding online disinformation.

Digital platforms have become a focal point in policy conversations across the world. The result has been the development of a complex policy discussion, not so much about "whether" to regulate digital platforms, but rather, on the difficulty of reaching consensus on "what", "how" and "who" to regulate. In this executive training we will discuss and debate the risks and opportunities arising from digital platforms, their role in and beyond competition policy, and the role of platforms, and in particular large social media, in the future of the public debate, with emphasis on the promotion of democracy.

Europe is exposed to rapid, complex and deep transformative trends. We need different policy approaches to address them, including building renewed alliances with European citizens and stakeholders. In order to address this challenge, EuSA and the EUI School of Transnational Institute are teaming up to develop a European Leadership Programme designed to support future senior managers/middle managers in EU institutions to develop the new competences and leadership skills that are required to promote the public policy innovation needed to address current challenges. This programme will lead the participants through a 12 month learning path that will be organized in partnership with state of the art learning centres and universities across the EU.

Unboxing the Commission: How to Understand and Engage with the EU Executive

March 2022

This executive training aims to shed light on the black box of policymaking within the European Commission. The training is practice-oriented and brings together three important vantage points: the academic analysis of Commission governance and operations; the "insiders' view"; and that of a lobbyist whose job is to have an impact on the Commission. It will be delivered by former members of the Commission services who have served at both Cabinet and DG level in several policy areas, experienced academics, and campaigners who have engaged with it across a host of areas. In addition to the latest data, case studies, and policy developments, participants will also learn skills for engaging with the Commission: how to effectively contribute to the public consultation process; how to write policy memos and position papers aimed at the Commission; how to follow the Commission's cycle and do proper audience mapping within the Commission.

Skills and Strategies for the 21st-Century Policy Entrepreneur

March - May 2022


What is a 'policy entrepreneur'? And how do they become entrepreneurs? Are they born that way? Or can organisations create, educate and train them? In other words, what are the key skills and characteristics of policy entrepreneurs and can they be learnt? This workshop will investigate the attributes of policy entrepreneurs, various theories about them and cases of successful entrepreneurship. This workshop will give you an opportunity to examine and expand the range and variety of successful styles and strategies that both individuals and organisations use to develop and sell new policy ideas and bring about real change. This is about taking new (or re-jigged) ideas and policy creativity all the way from setting public agendas through to policy implementation. This executive training will be delivered through blended methodology with the first three weeks of the programme being online, followed by a residential period in Florence (2 days) and ending with a final online session.

Migration Communication Strategies: Effective Approaches to Depolarise the Debate

May 2022

Badia Fiesolana, Florence, Italy - In collaboration with the Migration Policy Centre (MPC) of the EUI

Immigration is a controversial issue that is polarizing societies. The rising salience of the immigration issue has evoked heated debates and the rise of hate speech. Additionally, it has also driven dissatisfaction with political elites and migrant advocates who are often perceived as out of touch with citizens' concerns about immigration and diversity. As a result, we are facing a growing uncertainty about how to best communicate about immigration-related issues and how to reach out to segments of society that might be skeptical of immigration. Governance actors working in the field of migration, however, are in need of more opportunities to develop practical skills to depolarize the debate. To foster social cohesion, narratives are needed that neither alienate affected migrants, nor people who have concerns about immigration. This Executive Training develops and strengthens communication skills by providing in-depth insights into the factors that decisively shape how people perceive and react to immigration and ethno-cultural diversity. In the course of eight thematic sessions, participants will learn to identify and apply productive communications approaches towards migration-related issues in challenging contexts.



EU Restrictive Measures and their Impact in Political and Legal Context

May 2022

Restrictive measures (sanctions) are one of the most significant instruments of the EU Common Foreign and Security Policy (CFSP). They aim to bring about a change in policy or behavior on the part of governments of non-EU countries and the entities and individuals who support them or who are considered responsible for the behavior at stake. This executive training will cover in detail the evolution and major features of EU restrictive measures, their political and legal nature, the broader international context within which they operate, and the mechanisms whereby they become law. It will also discuss the practical implications and challenges as regards their enforcement, the judicial review ensured by the courts of the EU, their effectiveness and legitimacy, their placement within the EU's external policy, their geopolitical potential, as well as their impact on the development of EU law and fundamental rights protection. It will be delivered by senior EU and national policymakers, judges, and academics. By blending experts' inputs and learners' interaction through case study discussions, this executive training also creates an enabling environment for peer learning and networking.

Different Plans, Common Challenges: Implementation of the National Recovery & Resilience Plans in the Context of NGEU

May 2022

Hybrid: Online & Badia Fiesolana, Florence, Italy

This interactive executive course will enable participants to better comprehend the critical issues in implementing the national National Recovery and Resilience Plans (NRRPs) "on the ground" (e.g. national administration capacities, loans, performance indicators, timelines, reporting, evaluation). These revolve particularly around the required joint implementation of reforms and investments throughout the RRPs, as well as the digital and green transition. Gathering high-level public officials working on the Recovery portfolio from the Member States who will share their experience, this training will serve both as a platform where the participants can get to know the 'state of play' in implementing the National Recovery and Resilience Plans (NRRPs) across Europe, discuss the common challenges that arise during this process, foster a "community of practice" that exchanges best practices, and also provide a forum for sharing concerns and experience with EU Officials.



Environmental Policy-making – Andean Community

This tailor-made training is designed to meet the learning requirements of the Andean Community and assist its members in the successful development and implementation of the planned environmental management platform. The training curriculum will share the EU experience of environmental policymaking emphasising in particular the issues relevant to the Andean Community while addressing the consolidation of evidence for decision-making through an examination of the work carried out by the European Environment Agency and the European Commission's Joint Research Centre.

Mainstreaming Gender in EU Policymaking: Gender-responsive Budgeting

Hybrid: Online & Badia Fiesolana, Florence, Italy

This training provides key theoretical elements, practical examples, and individual guidance to implement the instruments for gender-responsive budgeting. From evaluation into planning, the training provides participants with a set of tools and case studies relevant to the EU's policy-making process, especially in the context of the new requirements set out in the EU's Gender Equality Strategy, the Next Generation EU package, and the Multiannual Financial Framework. Academic experts and practitioners will guide the participants through the definition and application of the key tools: Gender Analysis, Gender-sensitive Data and Scoreboards and Gender-Responsive Budgets. Participants will also have the chance to bring in examples from their professional life and perform exercises on them under the guidance of the trainers. They will have the possibility to practice on items and examples of their choice, i.e. bringing-in tasks related to their daily work.

Effective Migration Management: Putting Policy into Action

Public authorities, civil society organisations, and private businesses, are involved in managing migration, with significant implications for societies in sending, transit, and receiving countries. In order to respond to the complexity of migration, and to reduce implementation gaps, there is a need for a holistic view of migration. This Executive Training aims at developing and strengthening migration management skills through a holistic perspective. Using case-study teaching, we will work with participants to share different experiences and reflect on common constraints and opportunities. In the course of a variety of interlinked thematic sessions, participants will explore the different stages of migration management, from finding evidence to decision making processes and implementation. The training will combine insights of migration theory and practical perspectives from the operational level. At the end of the training, participants will have developed a sophisticated understanding of the complexities, challenges and trade-offs of migration management.
