#### **Climate Risk Academy**

This Climate Risks Online Academy co-organized by Oliver Wyman and the Florence School of Banking and Finance (EUI), in scientific cooperation with the EUI's School of Transnational Governance, combines the expertise and tools of the financial industry to assess and grasp the risks posed by climate change to the financial sector. Instead of examining how the risk landscape has been altered by climate change, the Academy reviews practical approaches for quantifying their impact and explores best practices for integrating climate risk into both prudential and risk management frameworks. This online Academy has been designed for staff members of financial institutions, micro-prudential and macro-prudential authorities who wish to deeply understand the crucial risks that climate change pose to the financial system. In addition to providing topical content and practical tools, this online Academy also acts as a platform to stimulate exchange and debate between public officials, academics and private practitioners.

#### High Quality Regulation: Tools and Practice

This 4-day executive training course covers both the dimension of regulatory analysis and the practice of governing rules across the policy life cycle. A large part of the curriculum focuses on the integration of operational lessons from real-world experience alongside the 'better regulation agenda' of many different countries. The course also delves into the assessment of multi-annual research programmes funded by the European Research Council (ERC).

Participants learn how the 2021 Communication of the European Commission on better regulation will be implemented across the EU and its member states, while also addressing various impacts on accession countries and the rest of the world. The learning format includes case studies, lectures, and testimonies designed by the Florence School of Regulation (FSR) Energy & Climate.

#### Digital Platforms: Towards a Comprehensive Policy Framework

Digital platforms have become a focal point in policy conversations across the world. However, their regulation has only recently been added to the discussion, since online intermediaries have remained largely unregulated. The result is a complex policy discussion, not so much about "whether" to regulate digital platforms, but rather, on the difficulty of reaching consensus on "what", "how" and "who" to regulate. After the training, participants will have a better understanding of how platforms operate, how they create value, and how they can potentially act anti- competitively. They will also have the opportunity to learn about the evolving economic and technological features of digital platforms and their prospective benefits and risks for the economy and society, especially in the context of a growing use of sophisticated Artificial Intelligence (AI) techniques which often escape the ability of regulators to monitor the market.

This 2-day executive training course by the European Digital Media Observatory (EDMO) responds to the most pressing training needs in the areas of online disinformation and fact-checking practices. As increased digital media literacy becomes ever more necessary in the complex online environment, it is crucial that media literacy practitioners are able to effectively monitor the results of their initiatives and measure these against their goals. In the absence of a widely agreed way to measure impact, this training offers, through a multi-and cross-disciplinary approach, a deep dive into each step of the process of monitoring and evaluation, and provide useful examples of measurement and assessment.

## Making Sanctions Work: Political and Legal Challenges of EU Restrictive Measures

EU restrictive measures, or sanctions, are one of the most significant tools of Common Foreign and Security Policy (CFSP). However, their adoption and application carry complex political and legal challenges. Over the course of this 5-day blended training course, top legal experts, academics, and practitioners share detailed knowledge on the political and legal aspects of EU restrictive measures, some of which include their political and legal nature, the mechanisms whereby they become law, the practical implications and challenges concerning their enforcement, and the judicial review ensured by the Courts of the EU, their impact on developing common EU norms and principles and fundamental rights protection, their effectiveness and legitimacy, their placement within the EU's external policy, their geopolitical potential.





It will focus mostly on two sets of issues: Cross-cutting horizontal governance and implementation challenges relating to capacity building, as well as to the use of tools for project management, monitoring, evaluation, and reporting; and "Deep dives" in the critical areas of the green and digital transition, and to advancing social cohesion. It will serve both as a platform for participants to discuss the common challenges of implementing NRRPs across Europe, therefore fostering a "community of practice", as well as providing a forum for sharing concerns and experiences with EU officials.

#### Webinar: The Legal Challenges, Implementation, and Legacy Issues Lying Ahead for Next Generation EU

To promote youth engagement in multilateralism and support the next generation of diplomats, particularly from underrepresented countries at the United Nations, the President of the 76th Session of the General Assembly (PGA) has established the "PGA Fellowship for Harnessing Opportunities for Promoting Empowerment of Youth" (PGA Fellowship for HOPE). The School of Transnational Governance hosted 8 fellows for two days in Florence and organised a set of workshops in its core areas, including democracy, human rights, the rule of law, global governance and most importantly, the EU's perspective on multilateralism. These sessions were complemented by study visits, group discussions, and a rich social programme.

In an era of rapid, complex, and deep transformative trends in Europe, this 3-day prototype leadership programme targets mid and senior-level managers of EU institutions and bodies and their teams. The STG supports the European School of Administration in programme design by specifically hosting the session kick-off meeting in Florence where 12 EU managers have an opportunity to begin their learning journey with purpose and value, by reflecting on the goals they want to achieve during their time here.

They gain first-hand perspectives of the next generation by engaging with students of the School's Master programme, while also having the unique opportunity to speak with former Greek Finance Minister, Prof. George Papaconstantinou to gain a first-hand account of how crisis leadership traits are built while effectively managing innovative policy solutions through crisis management. This first meeting allows for an assessment to identify key leadership competences, that prepares participants for the second half of the programme to take place in Brussels with their teams.

# Capacity building programme of the Western Balkans (two training courses for Western Balkans Diplomats)

#### 6-10 June and 10-14 October | For the Italian Ministry of Foreign Affairs and International Cooperation

The training programme aims to engage junior diplomats and mid-career diplomats of the Western Balkans on matters relating to European Union (EU) policymaking in view of developing their capacity to act and negotiate in today's globalised world while at the same time, strengthening strategic relations between the Western Balkans and the EU. Moreover, the programme will contribute to the consolidation of democratic institutions in the region by supporting the prospect of EU accession while facilitating the reconciliation process among Western Balkan countries. A first cohort of junior diplomats was trained in Florence in June and a second cohort of mid-career diplomats will participate this October.

# Open Society University Network (OSUN) Open to Health (O2H): A Pandemic Training Response to Rebuild Resilience

#### Long-term programme

This project has been designed within the context of a partnership between the European University Institute and the Universidad de los Andes. The aim of the partnership is to deliver executive education and professional training in the critical areas of health and health governance over a three-year period. The courses will contribute to rebuilding and strengthening public health systems' capacities, with a particular emphasis on low and middle-income countries to design better prospects for global health governance visà-vis the training of a new generation of professionals who will be able to navigate the intersecting fields of governance and public health.

Acting as a 'hub,' the two lead institutions (the European University Institute and the Universidad de los Andes) will draw upon other partner institutions in the OSUN network and beyond to provide expert contributions in support of bespoke design courses.

# ICAP Summer School on Emissions Trading for Emerging Economies and Developing Countries

22 August - 2 September | For the International Carbon Action Partnership (ICAP)

After a three-year hiatus, the International Carbon Action Partnership (ICAP) resumes in-person trainings with the 2022 edition of its flagship training activity, the ICAP Summer School on Emissions trading. Over the course of two full weeks, participants will explore concepts and key elements of emissions trading systems implementation, through a mix of presentations from expert speakers and policy practitioners as well as interactive activities. They will also have opportunities to network with each other and with the teaching faculty, composed of representatives from ICAP members, and carbon market professionals. The course is organised in cooperation with the Ecologic Institute and Get2c on behalf of ICAP.
