<b>Title of project</b>	'SAFE LANDing through enhanced ground support' — 'SAFELAND'
<b>Job description</b>	<p>The SAFELAND project will start in July 2020 and will run for 30 months. It aims at supporting flight and landing of aircraft operated by a single pilot, in case of partial or total incapacitation of the pilot. SAFELAND will focus on the ground side and in particular on the role ATM could have in managing the transition from a single pilot operated flight to a status with reduced or absent contribution of the onboard pilot to landing.</p> <p>SAFELAND will investigate the interaction of the air traffic controller with onboard automation and/or a ground based pilot operating through a remote cockpit position to manage the flight.</p> <p>The project is run in collaboration with the University of Bologna, therefore the place of work will be Bologna.</p> <p>In the context of the SAFELAND project, the Research Assistant will carry out the following tasks:</p> <ul style="list-style-type: none"><li>analyze the legal and regulatory constraints of the possible implementations of the concept (requirements, procedures, etc),</li></ul>

	<p>focusing on the main responsibility and liability issues, for each involved actor, related to the model of flight tasks and the concept of operation, identifying issues and challenges and suggesting mitigation measures.</p> <ul style="list-style-type: none"> <li>• assess the potential legal and regulatory implications of the project validation plan. In particular, the RA will (1) identify legal and regulatory criteria to be included in the Evaluation Plan; (2) analyze the legal and regulatory aspects of the implementation options selected for the simulation, in order to identify advantages and disadvantages of each option</li> <li>• support the organization of activities and events related to the dissemination of the project.</li> </ul>
