#### **Project details**

Global Citizenship Law: International Migration and

Constitutional Identity. Governing global migration is one of the most pressing issues of our time. With more than 250 million international immigrants, the question of how citizenship should be distributed has become controversial, morally and politically. Traditionally, international law has not regulated nationality law; naturalization requirements remain the last stronghold of national sovereignty. This project advances the establishment of a new subfield in public international law—International Citizenship Law (ICIL)—which would govern nationality law. It asks a critical and timely question: What should be the international norms in setting up requirements for naturalization and, more broadly, for granting citizenship?

The successful candidate will be part of the European Research Council's project research team and will be in charge of the completion of the historical part of the project especially with regard to the dissemination and publication of the findings resulting from the three conferences on the history of citizenship held during the project's timeframe.
