The [Robert Schuman Centre for Advanced Studies](#) (RSCAS) is an interdisciplinary research centre at the heart of the European University Institute (EUI). It was established in 1993 to complement the four EUI disciplinary departments of Economics, History and Civilizations, Law, and Social and Political Science, with the goal of developing cutting-edge, academic research and using that research to engage with a wide variety of stakeholders in the public and private sector.

The results of the Centre's research often become policy output in the form of publications and public events, where academics, policy-makers, members of civil society, and representatives of business exchange knowledge and build solutions to face the challenges of our time. In doing so, the Centre provides opportunities for younger scholars and established researchers to participate in a sustained dialogue with the world of practice. This problem-centred research agenda is necessarily thematic and interdisciplinary. It also extends beyond the traditional domain of the four disciplinary departments in ways that connect with other centres of excellence in Europe and globally.

The [Global Governance Programme](#) (GGP) is one of the flagship programmes of the Robert Schuman Centre. It was launched in 2010 in response to a growing need for global governance in an ever more interconnected and multipolar world. Since then, it has focused on broad interdisciplinary themes and on the many cross-cutting issues related to globalisation by advancing research and promoting multi-stakeholder dialogues.

The Global Governance Programme of the Robert Schuman Centre is looking to appoint a research fellow to work on issues related to central banking and macroeconomic governance. These issues range from the unconventional use of monetary policy instruments, to the evolving framework for monetary policy making, the relationship between monetary policy and other economic policies, the threat of fiscal or financial dominance, the use of monetary policy instruments to pursue non-monetary objectives, the changing context for political independence, and the interaction between central banks and other institutions of government. The successful candidate will be expected to work with scholars from different disciplines interested in the same issues – including, inter alia, Waltraud Schelkle, Thorsten Beck, Marco Buti, Giancarlo Corsetti, Erik Jones, Pierre Schlosser, and others both within the Robert Schuman Centre and across the EUI.

Job description

The research fellow will carry out research work in an independent manner and collaborate on the research work of the project.

Main tasks include:

- Supporting the coordination of activities linked to central banking and macroeconomic governance at the Schuman Centre and, where appropriate, at the EUI as a whole;
- Supporting the project director and collaborating in conducting research projects and other activities;
- Advising on the programme development of workshops, seminars and other research or policy events on central banking and macroeconomic governance;

- Keeping direct relations with relevant stakeholders as well as enhancing cooperation and networking activities;
- Assisting in the development of research proposals and applications for external funding;
- Developing, designing and conducting high-quality scientific and policy research in an independent manner in one or more of the fields / policy areas mentioned above;
- Writing co-authored and single authored working papers suitable for publication in academic journals;
- Contributing to the activities of the European and Monetary Union Laboratory (EMU Lab) recently established jointly by the Pierre Werner Chair and the Tommaso Padoa-Schioppa Chair in European Economic and Monetary Integration.
