Project details

The European Research Council Advanced Grant project LIBRAD investigates how populist regional governments across the EU reshape executive governance to implement illiberal policy changes. By covertly manipulating the machinery of government, these actors erode pluralistic norms, reduce accountability, and politicize the civil service in service of their illiberal agendas. Focusing empirically on subnational governance in EU member states and analysing executive transformations in a selected subsample, LIBRAD examines the conditions under which bureaucrats comply with or resist illiberal demands. The project combines theory testing on the effects of populist rule with theory development, offering a novel interactionist explanation of bureaucratic behaviour.

Job description

The research fellow will carry out research work in an independent manner and collaborate on the research work of the project. The research assistant will provide research assistance to the Project Director(s). Main tasks include:

- Compiling and analysing regional-level economic and governance data (2009–2024);
- Constructing panel data sets combining sources like EUROSTAT, OECD, EQI, and newly assembled populist party datasets;
- Implementing panel regressions and synthetic control (“synthetic doppelgänger”) analyses;
- Supporting the selection of regions for deeper case studies and survey targeting (input for WP3);
- Drafting peer-reviewed articles on economic and governance effects of populist rule.

- PhD in political economy, economics, or public policy with a quantitative orientation;
- Demonstrated advanced knowledge of quantitative methods and experienced with quantitative data analysis and statistical software (proficiency in R, Stata, or SPSS);

- Proven expertise in: panel data econometrics, time-series cross-sectional analysis, causal inference (esp. synthetic control methods);
- Proven knowledge of EU regional (NUTS-level) statistics, political economy of populism and democratic backsliding, comparative regional governance in the EU context;
- Demonstrated research background in quantitative public administration research, democratic theory, or a related area and ability to manage large multi-source datasets and ensure replicability;
- Proven excellent analytical and writing skills, ability to work independently and collaboratively as part of a team acquired through previous experience;
- Strong demonstrated communication skills for disseminating research findings through various media channels.

Desirable:

- Demonstrated experience handling QoG/EQI datasets.
- Proven knowledge of spatial data or mapping regional economic performance;
- Track record of co-authoring peer-reviewed empirical publications;
- Excellent proven knowledge of documentation and data management practices.
