MARK A. POLLACK is the Scientific Co-ordinator of the BP Chair in Transatlantic Relations. His first research project focuses on the delegation of powers to supranational institutions in the EU and the influence of those agencies in the process of European integration. His second project examines the emerging structures of transatlantic economic governance, and the changing nature of transatlantic relations during the first year of the Bush Administration. He is part of the directing team the 2001-2 European Forum.

Associate professors running RSCAS projects are: JEAN-VICTOR LOUIS (LAW), responsible for the 'Euro Spectator' project; Luisa PASSERINI (HEC) director of the Gender Studies Programme; MARTIN RHODES (SPS) in charge of the Welfare State Programme; JEAN BLONDEL who continued with his projects concerned with the analysis of abstention in Western Europe at supranational, national and regional levels, and the comparative analysis of social and political values in 18 countries of Western Europe and South East Asia; and Renaud Dehousse (Centre européen de Sciences Po, Paris) who runs with ELLEN Vos, (Univ. of Maastricht) the New European Agencies project which intends to determine what sort of relationships there may be between the agencies and their interlocutors, starting from the idea that the agencies are centres of vast European networks rather than centralized bodies.

The Programmes

1. European Institutions

This programme, co-ordinated by Bruno De Witte, has paid special attention to questions relating to the constitutional future of the EU. In 2000, the RSCAS had prepared two studies for the European Commission, one on the reorganization of the treaties and one on the reform of treaty revision procedures. In 2001 it created a new web page Policy Papers Series on Constitutional Reform of the EU. In October, Profs. MÉNY, WALLACE and DE WITTE were invited to present contributions to Europe 2004 - Le grand débat, a confer-

ence on the constitutional reform of the EU organized by the European Commission. Following the 2000 Responses to Joschka Fischer online symposium, the RSCAS, in cooperation with the Jean Monnet Chair at Harvard Law School and the NYU School of Law, had put together online a collection of reactions by prominent political scientists and legal scholars to the White Paper on Governance which the EC published in July, called Responses to the European Commission's White Paper on Governance.

2. Eastern Europe

JAN ZIELONKA co-ordinated two projects run jointly with the European Commission. One established a special Reflection Group on Unity and Diversity in the Enlarged EU. It was chaired first by JACQUES DELORS, and later by JEAN-LUC DEHAENE. The Group of Policy Advisors at the European Commission co-sponsored the project. He also co-ordinated a special Working Group on current issues related to the EU's enlargement which was chaired by H.-G. Krenzler and run jointly with the Directorate General for Enlargement of the European Commission. He was also involved (with J. BLONDEL) in a joint project with the ECPR that tried to map developments in Political Science Research in Eastern Europe since the end of the Cold War, and convened a conference in November.

3. Identity and Community

Bo Straath is in charge of this programme. Issues of community construction and social demarcation through inclusion and exclusion were studied both from a contemporary perspective, with a focus on developments in the labour markets and in immigration policies and practices, and from a more long-term historical view of European value production. In 2001, the programme included the EURONAT project. A joint seminar series (with IAPASIS) on The Stranger started in October. Anna Triandafyllidou acts as co-ordinator for both.

4. Economic policy

This programme includes a seminar series for invited speakers under the heading of the



European Monetary Union and the personal research of MICHAEL ARTIS. A new initiative was a Summer School, organized in September, on Competitiveness and EU Enlargement (M. ARTIS/S. SENIOR NELLO, Univ. of Siena/G. ZUKOVA, Law). This was designed to lead to an application for funding under the EC 5th Framework Programme on a similar theme and included speakers from the institutions involved in the application.

5. Competition Policy and Deregulation Beside the yearly Competition Law and Policy Workshop (C.-D. EHLERMANN), this programme hosts several regular conferences for policy makers, including the European Electricity Forum of the Commission and the International Bar Association's annual meeting on Competition Law.

6. Welfare States

MARTIN RHODES ran (with M. FERRERA, Univ. of Pavia) a project – including a conference in December – on Welfare Systems and the Management of the Economic Risk of Unemployment - Experiences and Prospects of Reform in the EU, sponsored by ISFOL (Istituto per lo Sviluppo della Formazione Professionale dei Lavoratori), Rome. It assesses the responses made by the EU Member States to the problem of persistent unemployment in the 1990s, focusing on income packaging for the unemployed and the activation of benefits in ten of the EU Member States. In 2001 several publications emerged from the European Forum Recasting European Welfare States (1998-99) and from work undertaken for the Portuguese Presidency of the Council of the EU in 1999-2000.

7. Environment

Activities centred around environmental challenges following Eastern enlargement and the implementation of EU environmental policy. A quantitative study of Member State compliance with Community law was conducted in collaboration with the Max Planck Project Group on Common Goods, Bonn. A database on penalties against Member States for violating Community law is available on-line.

8. International Relations

Primary themes include the development of transatlantic governance mechanisms, the role of the EU as a global actor, and a collective study of the roles of the EU and the USA in global environmental diplomacy. Much of this work is conducted via the BP Chair in Transatlantic Relations. The 2001-02 European Forum addresses the external dimension of Europeanisation.

9. The Mediterranean Programme

The programme is organised around two chairs. One deals with social and political themes and is funded by ENI spa, Ente Cassa di Risparmio di Firenze and Mediocredito Centrale. The other deals with political economy and is funded by Compagnia di San Paolo, European Investment Bank and Monte dei Paschi di Siena. The Inaugural Lecture for this, on The Mediterranean, Europe and Globalization: Keys to the Future?, was delivered by Kemal Dervis, Turkish State Minister of Economic Affairs in June. Philippe Fargues (Inst. national d'Études démographiques, INED, Paris) directs two new projects on international migration. One project examines New Generations and the Future of International Migration. The second project is the Euro-Mediterranean Databank for Analysis of International Migration. This has three objectives: compiling a multi-dimensional and systematic databank, organizing teaching and research activities and building-up Euro-Mediterranean expertise. The programme has also sponsored the pilot phase of a project on The Social Capital of Religion and Ethnicity in the Eastern Mediterranean, directed by ARMANDO SALVATORE, with Profs. B. STRATH and P. Wagner. The project launched in 1999 Economic Networks and the Politics of Fiscal Policy Reform in the Middle East, directed by STEVEN HEYDEMANN (Social Science Research Council, New York) held its concluding workshop in San Francisco in July. The second session of the Mediterranean Social and Political Research Meeting (IMCO BROUWER) gathered 160 scholars. The third summer school (Valérie Amiraux) Building Interdisciplinarity in the Study of the Middle East,

directed by STEVEN HEYDEMANN, was held in July with more than 25 students.

10. The Transatlantic Programme

The programme, with its main funding from a generous grant from BP, has undertaken policy-oriented as well as basic research on key issues of common European-American interest. The BP Chair sponsored an active speakers series, a transatlantic essay contest, and three major conferences on: the settlement and prevention of transatlantic trade disputes (see E.-U. PETERSMANN); the state of transatlantic environmental relations: Green Giants? Environmental Policy of the United States and the European Union (N. J. Vig/M. Faure); and the origins and outcomes of the 1995 New Transatlantic Agenda agreement between the US and the EU: The New Transatlantic Agenda at Five: What Has Been Achieved?. The President of the European Commission, ROMANO PRODI, delivered the First BP Annual Lecture on The New Europe in the Transatlantic Partnership, and presented prizes to the winners of the essay contest.

11. Gender Studies Programme

This programme, directed by Prof. Passerini and co-ordinated by Dawn Lyon, supports the study of gender across the departments of the EUI, and stimulates interdisciplinary work. The main events of 2001 were:. A conference on Gender Studies in Europe as part of the series: Gender Studies - The State of the Art (with the Univ. di Firenze and the ATHENA-Women's Studies in Europe-network); The first Ursula Hirschmann Annual Lecture on Gender and Europe delivered by Prof. Rosi BRAIDOTTI, (Utrecht Univ.): Gender, Identity and Multiculturalism in Europe; A summer school, directed by Prof. ELENI VARIKAS (Univ. of Paris VIII), on Women and Gender Relations in Europe: The Southern and Eastern Boundaries attracted students from more than 20 countries. A new EC 5th Framework Programme-funded project on Gender Relationships in Europe at the Turn of the Millennium: Women as Subjects in Migration and Marriage (GRINE) held its first meeting in October.

The European Forum

The 1999-2001 Forum directed by Profs. BAR-TOLINI (SPS), RISSE and STRATH followed for a second year the theme Between Europe and the Nation State: The Reshaping of Interests, Identities and Political Representation. It discussed several dimensions of the domestic consequences of Europeanization, organised around three topics: A European political economy (co-ordinator T. Notermans, JMF); Legal integration (co-ordinator B. DE WITTE); Political integration (co-ordinator S. Bartolini). Special mention should be made of the connection between the Forum and Europeanization, Collective Identities and Public Discourses (IDNET) Project. The 2001-2 Forum, Europe in the World: The External Dimensions of Europeanisation, directed by Prof. Wallace with Profs. Pollack and Zielon-KA, has three main emphases: The interface between the EU and its potential new members and other near neighbours (co-ordinator J. ZIELONKA); The interface between the EU and its global partners, particularly via the transatlantic relationship (with the BP Transatlantic Relations Programme and co-ordinated by M. Pollack); and, The changing features of the Common Foreign and Security Policy, now to be reinforced by a defence dimension. The Forum looked specifically at the ways in which the EU exports its norms, policies and practices to other European countries and neighbours, and at the way in which developments in these other countries are shaped on this form of Europeanisation. Publications continue to flow from previous Forums on 'European Welfare State' (1998-9), 'Migrations' (1997-8) and 'Citizenship' (1995-6).

Policy Dialogue

The Centre (co-)organises many activities to disseminate its research results to a wider audience or to co-operate with non-academic institutions. It holds conferences together with public and private, national, European and international institutions, so that academics and policy-makers can exchange views on important topics on the political agenda. The



Centre prepares documents with or for various external partners, a recent example being the report of the Reflection Group on The Political Dimension of EU Enlargement: Looking Towards Post-Accession. The Centre publishes policy papers and hosted many leading personalities, among whom: from the European Commission, the President, Romano Prodi, Commissioners Mario Monti (Competition) and Frits Bolkestein (Internal market); The Turkish Minister for Economic Affairs, Kemal Dervis; The Portuguese Secretary of State for European Affairs, Francisco Seixas da Costa; The Constitutional Committee of the Swedish Parliament.

Research Student Developments

With respect to last year, research student candidates for academic year 2001-2 were down by 7%, with a total of 1185 compared to 1277 last year. From EU and Associate Member States, the EUI received just under 900 applications. This represented a 9% decrease compared to 2000. Over the last three years the number of applications has been decreasing rather than an increasing, but two important facts should be borne in mind:

World wide, in recent years, there have been fewer students applying for doctoral programmes in the major US and European schools, one of the reasons for this being the improved career market now open to graduates. Immediate employment is to many more attractive than spending 3 to 4 years in a doctoral programme. New postgraduate and doctoral courses in other countries are increasing


and attracting students from within the home nation or university; internal financial incentives are making such courses even more attractive.


Moreover, the quality of this year's candidates was up on last year. The national delegations and Departments were very satisfied with applications. The overall ratio of candidates to intake is a little under 10 to 1. In January almost 1200 students applied and by September 128 of these had taken up their places at the EUI.

The number of Central and Eastern European (C&EE) students applying is rising and would no doubt be higher if more facilities or grants were available. The Italian Foreign Ministry has been most helpful, awarding scholarships and creating new programmes for students from: Central and Eastern Europe; the Mediterranean basin and (SE Europe) Yugoslavia, Bosnia and Herzegovina, FYR Macedonia and Albania. Thanks too are due to the Cassa di Risparmio di Firenze from whom the EUI has received funds for financing students in these three groups. For the

Mediterranean Programme there were 35 applicants and 2 students were offered places. For the C&EE and SE European grants, there were 160 applicants, of whom 10 were admitted. From other countries, there were 81 applicants to whom 5 admission offers were made. Special thanks must also go to the Luxembourg authorities who have, once more, generously awarded a scholar-

ship to a Bulgarian student for the duration of the doctoral programme from 2001-2.

In March, the Institute signed the fourth preaccession agreement with Hungary. There will be one Hungarian grant every year.

One scholarship was awarded to a research student in History in the framework of the



Vasco da Gama programme (funded by the Vasco da Gama Foundation, Portugal), while two US candidates were admitted to the Law department on Fulbright Commission scholarships. The Phare/ACE programme of the EU Commission and the European Investment Bank continued their awards for students in the Economics department.

Introductory Programme

All first-year research students are introduced to the activities of Institute through a series of meetings organised at the end of August and throughout September and start the intensive language courses. Seminars and academic programme proper began in October.


Academic Programme

During their studies, EUI research students may make use of one of the exchange schemes, or take up a *stage* at the European Commission in Brussels. In both cases, researchers are on leave of absence from

the EUI for some 3 to 5 months but continue their work within the doctoral programme. For Europe, the EUI has agreements with several universities under the Socrates-Erasmus Programme; last year 15 EUI students visited these while a similar number was welcomed from partner institutions. Under the inter-university agreements with universities in the United States (Univ. of California at Berkeley, Univ. of Wisconsin, New York University, and Columbia University), 14 EUI researchers participated in 4-month exchanges. As many students from the US visited the Institute.

The EUI wishes to thank the European Commission for the generous offer of 10 trainee places (*stage*) at various DG offices.

Students also have the opportunity of spending a week at the Salzburg Seminar where they meet up with experts from around the world in their particular field. Two EUI students were admitted to the Seminar this year.



Extra-curricular activities

The "4B" (social-sports-cultural) committee organised many activities during the year, too many to list here, but of particular note were: a football team trip to Amsterdam, a successful series of Thursday Evening Concerts, History of Art lectures, the Friday night theme parties, and a huge increase in the use of the Institute's gym with activities ranging from Tai-Chi Chuan to Kung Fu, yoga to aerobics. The Institute's Choir, the Coro Universitario Europeo, has now been in place for two years and gave some outstanding performances, notably in front of the European Commission on 7 November. In Florence, through special arrangements, weekend chamber and orchestral concerts at the Pergola (Amici della Musica) and the Teatro del Maggio Musicale Fiorentino were very popular.

Doctorates awarded in 2001

The number of doctorates defended by EUI research students again increased with respect to last year. There were 80 in all, 75 awarded by the Institute, while five researchers defended at their home university. The median time-to-degree rate stayed in line with the overall figure of 4.1 years. With the high numbers of doctorates completed over the past few years (see graph), the completion rate has now reached a figure in excess of 70%. Of note also is the extremely high level of completion of LL.M theses, with very few failures over the years.



Funding of the EUI


The institutional funding of the Institute is provided by the Contracting States. The financial contributions of the Member States are set according to the following scale:


The Institute also has resources of its own, consisting of deductions from staff remuneration and income from research services. It is entitled to receive gifts and legacies.

Of particular note is a contribution from the European Communities (4,123 million EURO), earmarked for specific teaching and research activities.

Expenses associated with the administration of the European Community Historical Archives are covered by a contribution (1,071 million EURO) from the European Communities.







The Institute's Governing Bodies

The High Council

By Article 6 of the Convention setting up the Institute, the High Council is composed of representatives of the governments of the fifteen Member States. The European Union has observer status.

The High Council held its two annual meetings on 6 and 7 June and 6 and 7 December, with Ambassador Antonio Zanardi Landi, of the Italian Delegation, in the Chair. Three representatives of the Institute's academic community also took part in the proceedings.

At its June meeting the High Council considered the interim report of the Strategy Group set up in December 1999 to review the Institute's long-term policies in the light of developments that have taken place in higher education since the 1991 "Beyond Maintenance" report. At the same meeting it held an initial exchange of views on ways of funding the pension scheme following an actuarial study done the previous year.

In December the High Council adopted the budget for 2002, providing in particular for creation of a new joint professorial chair in the Schuman Centre and a department.

It took the decision in principle to proceed with funding the Institute's Pension Reserve Fund, with the details remaining to be determined (in particular, whether financing should be over 20 or 30 years).

It considered the Strategy Group's final report, "Enlargement and Enhancement". Subject to consideration of the budgetary implications, to be done in June 2002, it approved the essential principles, as follows: – increase in number of doctoral students to

600, with the prospect of accession by the Central and Eastern European States that are candidates for entry to the European Union;

- better structuring of first-year studies in the doctoral programme, while taking account of the specific features of the departments;
 stress on strengthening the post-doctoral sector, in both the Schuman Centre and the departments;
- development of collective and interdisciplinary research projects, and of Institute participation in research networks in Europe;
 increase in the share of outside funding in the Institute's budget;
- devolution of financial responsibilities to departments and the Schuman Centre.

The Academic Council

The Academic Council, chaired by the Principal, includes the Institute's Secretary, all professors, the Librarian, seven researcher representatives, one representative of the Jean Monnet Fellows and one of the Staff Committee. It has general powers in relation to teaching and research, and may bring before the High Council recommendations on questions within the latter's province – for instance, on the Institute's future policies as proposed by the Strategy Group.

As it does every year, the Academic Council took the individual decisions incumbent on it, regarding definition of the academic profiles of vacant chairs, nomination of members of thesis examining boards, and, in restricted session, appointment of teachers or renewal of their contracts, and appointment of Research Council members)

The Research Council

At its spring meeting the Research Council's discussion focused on the Self-Assessment Report by the Law Department, in which it was stressed that the Department has become a major centre for the discussion of distinctively European approaches to issues in international law. There is a diversity of lan-

guages used in teaching and research, diversity of legal systems represented among staff and researchers, the pluralism of legal sources studied, and a diversity in the balance between practice and theory. The Departmental website is also making a contribution to improving the dissemination of working papers and highlighting recent publications, particularly by staff.

The quality of current staff is very good. They are engaged in the publication of a large number of works and are considered leaders in their fields. They have the advantage of being broad in their range of interests, which helps to provide support for a wide range of legal research, as well as enabling cross-fertilisation of ideas. The workshops and conferences organised enable the EUI to be a

major centre at which contemporary issues of legal research are discussed.

The Department was asked to produce in the near future a fuller statement of the criteria by which it wishes to judge the success of its teaching and the methods it uses.

In its autumn meeting, the Research Council discussed and approved the Strategic Review Group's final report and recommendations for Institute policy in the coming decade.

The Research Council also carried out its annual review of the current and new research projects, and allocated the research funds, including those for the interdepartmental projects.

A few words in conclusion ...

The President's Report for the academic year 2000-2001 is the last of a series begun by PATRICK MASTERSON when he took over the leadership of the Institute. He was aware that the initiative would have to respond both to the need to inform and to the requirement for the Institute as a whole to make an annual stocktaking of its activities for both its own members and the authorities responsible for its development.

A consideration of the reports for recent years points to the profound changes that have come during Dr. Masterson's two Principalships. They may seem imperceptible to the outside eye comparing one year's report with the previous one. But they are impressive once the comparison is extended to the whole range. The change was first of all quantitative: growth in researchers, post-docs, the library, publications, chairs and programmes, and number of theses defended.

But the real changes are qualitative. Even if here it is harder to set up indicators, and they are less reliable – apparently – than growth in square metres or budget volume, there can be no doubt the progress has been considerable. Our researchers' places in prestigious universities and institutions show this, and it is confirmed by the quality of the publishers and journals that take our publications. Our university's attraction to the hundreds of internationally renowned professors who are candidates for vacancies, and the career development of our ex-professors, are additional evidence of it.

This result is a collective outcome, a piece of teamwork. But none of it would have been possible without the enthusiasm, willingness and passion for the Institute that Patrick Masterson displayed throughout the past eight years. We thank him for having, with prudence, wisdom and firmness, transformed the European University Institute.
