Nature of post: 1 temporary post – grade B* 4¹ – Assistant (Systems analyst)

Unit to which post is attached: Computing Service

Duration of contract: two years, with possibility of renewal.

Description of duties: temporary staff member reporting to the Head of Unit, in charge of providing technical supervision in the maintenance, the development and the enhancement of desktop PC configurations. In particular:

- Creation, updating and testing of software clones images.
- To research and promote prototype technical solutions in response to user requirements.
- To evaluate innovative software and hardware as well as emerging technologies for integration in the development and deployment of systems.
- To provide second level support to the User Support group
- To maintain documentation.

Qualifications required:

- Being a national of the European Union, or a national of third countries having acquired the status of long term resident on the basis of the European Council directive 2003/109/EC;
- A Level of scientific/technical post-secondary education attested by a diploma;
- Knowledge and practical experience in:
 - Microsoft Windows XP;
 - Windows configuration/management and troubleshooting;
 - Desktop software configuration and integration in network environment and Microsoft Active Directory services;
 - Scripting technologies, including WMI integration (VBscript and JScript);
 - Networking technologies and troubleshooting;
 - Enterprise tools used for centralised deployment and management of applications.
- At least 5 years working experience in information technology;

- Ability to work as part of a multinational team;
- Excellent knowledge of English and good knowledge of a second language of the Institute. Knowledge of a third language would be an asset.

Selection process:

Candidates short listed by the Selection Board will be invited for an interview, enabling assessment of the candidate's ability to

- carry out the tasks of the post
- work in a European university institution
- exercise language skills.

The net monthly salary:
