Weather shocks, conflict pushing millions into hunger, UN warns

NITED Nations (UN), yesterday, warned that over 122 million more people are facing hunger in the world due to the COVID-19 pandemic, weather shocks and conflict, including the war in

This was contained in a joint report by five UN agencies: Food and Agriculture Organisation (FAO), International Fund for Agricultural Development (IFAD); United Na-Children's Fund (UNICEF); World Food Programme (WFP) and World Health Organisation (WHO).

Titled, 'The State of Food Security and Nutrition in the World 2023', the report notes that the number of people experiencing hunger worldwide reached between 690 and 783 million in 2022, a stark increase of 122 million people compared to pre-pandemic figures.

It notes that while global hunger figures stalled between 2021 and 2022, there are many places in the world facing deepening food crises.

The report notes that approximately, 2.4 billion individuals, largely women and residents of rural areas, did not have consistent access to nutritious, safe, and sufficient food in 2022.

It notes that child malnutrition is still alarmingly high. In 2021, 22.3 per cent (148.1 million) children were stunted; 6.8 per cent (45 million) were wasted and 5.6 per cent (37 million) were overweight."

According to the report, as accelerates, urbanisation there is noticeable increase in consumption of processed and convenience foods, leading to a spike in overweight and obesity rates across urban, peri-urban, and rural ar-

DSS charges Emefiele to court after judge issued one-week ultimatum

DEPARTMENT of State Services (DSS), yesterday, said it charged former Central Bank of Nigeria (CBN) Governor, Godwin Emefiele, to court, following order by an Abuja High Court.

Spokesman for the secret police, Dr Peter Afunanya, said: "Sequel to an Abuja High Court order today (yesterday), July 13, 2023, DSS, hereby confirms that Mr. Godwin Emefiele has been charged to court, in compli-

The statement reads further: "The public may recall that the service had, in 2022. applied for a court order to detain him, in respect of a investigation. Though he obtained a restraining order from an FCT High Court, the service, however, arrested him in June 2023, on the strength of suspected fresh criminal infractions/information, one of which forms the basis for his current prosecution.

"The service assures the public of professionalism, justice and fairness in handling this charge of its duties within the confines of the law."

Earlier, yesterday, Justice Hamza Muazu had issued a one-week ultimatum to DSS to charge Emefiele to court or set him free.

Muazu issued the order. while delivering ruling in a fundamental human rights suit instituted against DSS and others, by Emefiele.

The judge held that, while DSS has power to carry out its constitutional duties of arrest, detention, and preven-

matter, and indeed the dis- must be done within the ambit of law. He maintained that the law stipulates conditions under which a Nigerian citizen could be held, and for how long.

In the suit, instituted on his behalf by a Senior Advocate of Nigeria, Joseph Daudu, the suspended CBN Governor

Emefiele also demanded N5 million compensation as exemplary damages for his alleged unlawful detention.

Cities in West African sub-region to benefit from flight connectivity

AIR Peace has said it is expanding regional connectivity with launch of the Lome, Togo route on July 28,

In a statement by the airline, yesterday, it also announced flights to Antigua, between August 5 and 9, 2023, in partnership with Tour Brokers International.

The airline said the Lagos-Lome-Lagos route would be operated with the 50-seater Embraer 145 jets.

"We are expanding our West African presence to connect cities in the sub-region, ease connectivity for Africans and strengthen commercial ties between countries.

"Air Peace is committed to easing the air transportation burden of Africans, and this will continue to drive our route expansion as well as fleet modernisation. We also recently received two Boeing 737-700 aircraft to further strengthen our domestic and regional operations," the airline said.

On the Antigua operation, Air Peace said it was offering deals for customers who plan to travel for the Antigua Carnival from August 5 to 9, 2023, plus hotel packages from Tour Brokers International.

Similarly, the airline hinted that plans are in top gear to resume China soon, saying more connections and routes like Congo Kinshasa and Abidjan are in the works. With Lome operations, Air Peace's regional route will increase to eight, including Douala and Niamey, launched in 2021 and 2022.

LP, INEC duel over call for dismissal, prosecution of Yakubu

▼ ABOUR Party, yesterday, Ldemanded immediate dismissal and prosecution of Chairman of the Independent National Electoral Commission (INEC), Prof. Mahmood Yakubu, for allegedly superintending the worst election in Nigeria's history, on February 25, 2023.

Director General of the Obi-Datti Campaign Organisation, Balogun Akin Osuntokun, disclosed this at a media briefing in Abuja.

He said: "If you go to equity, you go with a clean hand. INEC and security agencies have already taken steps to prosecute the Residential Electoral Commissioner (REC) of Adamawa.

"As far as we are concerned, what the REC did was like what Yakubu did at

is the case, we are also thinking that Yakubu should be prosecuted and dismissed."

Reminded that Yakubu's position is protected by the constitution, and only the President, with concurrence from the National Assembly, can remove him, Osuntokun said: "So also is the position of a CBN governor; it is constitutionally guaranteed. That is why he (President) called it suspension. Ideally, somebody who has committed the abuse of office INEC Chairman committed should resign, or it means that of the CBN and selective."

He added: "If INEC is not credible, how can we expect results emanating from that same group to be credible? At the very minimum, if Yakubu has any shame, he would have resigned. But if

the national level. So, if that the President has the political will, there are ways to go round it. He can be suspended from office just like what he did to the CBN gov-

But Chief Press Secretary to the INEC chairman, Rotimi Oyekanmi, in a statement, said: "It is not within LP's jurisdiction to demand dismissal and prosecution of the INEC Chairman over the outcome of an election in which the party fielded candidates.

"Interestingly, arising from the outcome of the same 2023 general election, LP has now produced one state governor, eight senators, 35 House of Representatives members and 38 members of state Houses of Assembly."

He added: "It is surprising and strange that a political party that is in court to challenge the outcome of

the 2023 presidential election would still go about openly advocating issues before the court at press conferences, which it knows is subjudice.

"Labour Party is one of the 18 political parties registered and regulated by INEC in Nigeria. The party will do well by restricting itself to activities permitted under rules and regulations governing the conduct of political parties."

Despite huge revenue, Lagos local councils

ONSTITUTIONALLY, the local councils are meant to construct and maintain roads, streets, drains, parks, open spaces, naming of roads, streets, as well as provision and maintenance of public transportation and refuse disposal.

It is also the duty of councils to establish and maintain cemeteries, burial grounds and homes for the destitute or infirm in addition to establishing, maintaining and regulating markets, motor parks and public conveniences.

Local councils are also meant to collect taxes, fees along with licensing of bicycles, trucks-other than mechanically propelled trucks-, canoes, wheelbarrows and carts. It is also within the purviewoflocalcouncilstocontrolandregulate outdoor advertising, movement and keeping of pets of all descriptions, shops and kiosks, restaurants and other places for sale of food to the public, and laundries.

For many of the about 16 million Lagos residents, of the outlined constitutional duties of the councils, the state government has taken responsibility for a number of such responsibilities of the local councils. Yet, the few tasks left with the local councils to carry out, like the construction of councilroads, and drainages, de-silting the drainages, establishing, maintaining and regulating markets, motor parks and public conveniences among others, the councils have not lived up to expectations.

For instance, in Oriade LCDA, virtually all the roads are in deplorable state. From Olayemi Street to Saibu, Fashiro, Moradeyo, Balogun, to Muritala streets to mention a few, residents are wondering if the local council exists.

Yet the 20 local councils recognised by the Federal Government received N401.09 billion as federal allocation between February 2020 and December 2022. Between February and December 2020, the 20 councils got N107,594,962,381.88; from January to December 2021, they got N132,575,539,174.01 while between January and December 2022, the councils got N160,928,933,449.86.

The 20 local councils are expected to share the allocations with the 37 LCDAs created out of themorexecute projects and programmes within these LCDAs.

What the councils and LCDAs generated as Internally Generated Revenue (IGR) within these three years is not known, because the councils' books are not open or made public. Attempts by Civil Society Organisations (CSOs) to get the information are often met with resistance with no information often made available to those who made the requests.

Ironically, despite the huge federal allocations to councils in Lagos State, from Amuwo Odofin to Mushin, Alimosho or Badagry to Agege, the awful state of council roads, blocked drainages, and dirty markets, parks and roads stare one in the face. Just as vehicle owners and motorists bear the brunt of the deplorable roads because they have a telling effect on their vehicles with repeated calls at the mechanic workshops, so also are residents bearing the impact of government failure at the local level.

Surulere Local Council seems to be a shining light, with many of its roads tarred or in interlocks with streetlights and drainages. It is, however, not because the local council chairman in Surulere has been outstanding in terms of delivering the dividend of democracy to the people. Describing how unpalatable the situation is, a resident of Lagos, Akeem Ogunjobi, alleged that Royal Estate CDA graded a road, installed the number of roads and streetlights among other development that Gbajabiamila facilitated in Surulere Local Council in his last four years may have not been matched by the 57 local councils and LCDAs chairmen put together within same period.

It was even gathered that a road, Adedamola Ojomo Close, within Surulere Local Council, has been under construction for more than a year

Local councils are meant to bring good governance closer to the people at the grassroots. In Lagos, Local Council Development Areas (LCDAs) were created from the local councils to better achieve that goal, but rather than the residents feeling the impact of governance at the lower level, good governance is far from the residents with many of the council roads in horrible state, despite monthly federal allocations and all manner of revenue collectors running after businesses and individuals. Aside from monthly allocations, these councils are very aggressive about IGR, but many residents have resorted to self-help to bridge infrastructure gaps within their domains, by executing projects individually or through Community Development Associations

During the yearly community day celebration in Lagos, over 80 CDAs were identified to have executed various projects, ranging from roads, electrification, drainage, water to mention a few

From highbrow areas in Eti-osa and Ikeja to rural areas like Epe and Badagry, CDAs completed projects worth hundreds of millions of naira, many of which should have been done by the councils.

For instance, in Ikosi-Isheri LCDA, one of the CDAs, Isheri North CDA in 2020 was identified to have constructed 8km embankment, 1.5km road, installed five 500kva transformers, electrified the entire community, procured 40armed security officers, graded roads, mounted streetlights, built CDA secretariat, constructed and renovated its drainages, as well as purchased industrial pumping machines. In the same year, under Isolo LCDA, Greenfield CDA constructed two gatehouses and 48 interlocking roads, installed 10 500 KVA transformers, solar power streetlights and constructed a power substation. It also installed CCTV cameras, developed a well detailed area map of the chased and installed electrical concrete poles projects mentioned above, it recorded that the CDÁ had three other interlocking roads ongo-

Similarly, in Ikorodu Local Council, Elepe streetlights, constructed two roads with concrete floor, energised its transformer, as well as constructed drainages and cleared its canal.

Ayobo-Ipaja LCDA was not left out, as Peace Estate CDA constructed drainages, and 21 culverts, graded 21 roads, purchased and installed two 500kva transformers, purchased and installed 100 concrete poles.

Within Eti-Osa East LCDA, Seaside Estate CDA constructed the community main entrance gate, purchased 500kva transformer, constructed 1.2km road with interlock stones, erected four boundary gates in the community, constructed drainages and fence around the transformer, purchased and installed solar street lights.

Also, in Igando-Ikotun LCDA, New Era CDA purchased aluminum conductors, graded 21 roads, purchased a 500 KVA transformer, constructed a mountain step, nine culverts, one borehole, and drainage.

In Oriade LCDA, New site Estate CDA purchased 500kVA transformer, constructed 920m drainage, graded road, cleared drainages, purchased 20LT and 15HT concrete poles, constructed culverts and purchased cable wire.

OmotoyeEstateCDAinOrile-AgegeLCDAalso constructed 110 m long and 8 m wide interlock road from the entrance gate, 8m culverts with asphalt, replaced 12 wooden poles with 12 concrete poles, and constructed entrance gate.

These CDAs executed these projects without huge federal allocation. Ironically, council chairmennotonlyenjoyfederalallocationbut also generate huge revenue.

An executive of a CDA, who pleaded a nonymity, for fear of victimisation by the state government, provided in sight to how his CDA executed a number of projects. He revealed that the projects were done without financial support from the government.

Before they started executing the projects that bridged the infrastructure gap, residents had unpalatable experiences driving or walking on the community's streets, because it used to be deeply waterlogged and marshy. Sometimes, we task ourselves for a particular project demanding that every resident contributes an amount to execute the project. It is only the security levy that is yearly and paid by all residents; landlords and tenants.

He disclosed that his CDA was able to execute the projects through donations and levies. He, however, said that a larger part of the fund for the projects were products of generous donations from residents.

According to him, the residents resorted to selfhelp because the government failed to provide the appropriate infrastructure for the commu-

He said that before they started executing the projects that bridged the infrastructure gap, residents had unpalatable experiences driving orwalking on the community's streets, because it used to be deeply waterlogged and marshy.

He said: "Sometimes, we task ourselves for a particular project demanding that every resident contributes an amount to execute the project. It is only the security levy that is yearly and paid by all residents; landlords and tenants."

He also revealed that an element of competition was created among residents to drive development. According to him, residents on each street were told to buy the interlocking stones needed to construct their streets while the CDA provides the labour, sand and other materials needed to complete the road.

16 million residents resort to self-help

According to him, the residents resorted to selfhelp about six years ago when the government failed to come to the community's aid and residents were daily bearing the brunt of infra-

"As individuals in Lagos, you are your own local council. When I bought my property, there was no access to the property. I was the first to develophis property on mystreet. For two years, I was parking my car in a friend's house. At one point, Ibuilt a bamboo track to link my house because of a waterlogged road. We later filled the road with rubble to be able to drive to my house.

"Yet, I pay tax to the government and now government visits to demand for Land Use Tax on my property, despite constructing and still maintaining my road and the drainage.'

He revealed that the government cannot say it is not aware of the infrastructural gaps in his community because monthly, the CDAs executive attend the Community Development Community (CDC) meetings where each CDA presents the infrastructural gaps in its domain to the CDC for transmission to government but nothing has come out of the effort.

He said that last year his CDA needed to buy transformers and construct drainage, each landlord was asked to contribute N350,000 towards the project.

An analysis by Dataphyte in 2019 revealed that 13 out of the 20 top federal allocations receiving local councils are from Lagos State and not less than 15 of the 25 local councils that received the most from the Federal Account Allocation Committee (FAAC) in the last 12 years are from Lagos State.

Still, residents, traders and visitors to local councils are made to pay all forms of levies. From council parking fees, hawking fees, imported vehicles tickets, haulage and lockup stall levy are some of the taxes and levies residents and visitors pay to the councils and its representatives.

Also, gridlock is a major issue in Lagos. In the bid to contribute to easing the logjam, local councils also set up traffic taskforce and traffic units. But rather than help free points of bottlenecks of traffic, council traffic officers in Mushin, Oshodi-Isolo, Ajeromi-Ifelodun and Yaba, move about towing vehicles allegedly accused of committing traffic infractions. Residents said they are often very crude in their operation, with no rules of engagement. In most cases, alleged offenders are made to pay fines into private accounts.

For instance, along the Apapa-Oshodi expressway, between Iyana-itire and Toyota bus stops inward Oshodi, trucks often park on a column of the service lane, obstructing traffic. Rather than the council traffic officers rein in the owners of the trucks or even enforce its law, it looks away. Also, commercial tricycle operators at Iyana-itire, Ilasa, Iyana-Isolo, Five Star and Toyota bus stops inward Oshodi have turned the service lane into a garage to pick passengers, thereby obstructing traffic flow. For once, the traffic unit of the Mushin Local Council that parades the corridor in three different towing vans indiscriminately impounding private vehicles has not for once called the tricycle operators to order. Yet the tricycle operators 'activities constantly contribute to the traffic snarl usually recorded on that corridor.

Across the different local councils in Lagos State, it has been observed that to generate revenue, many of the councils go into Public Private Partnership (PPP) with a huge part of the revenue going into private pockets. This is because the revenue collection process is devoid of accountability.

On many occasions, the revenue consultants print the tickets and where the council prints the tickets, the revenue collectors issue the tickets to residents randomly. It was also observed that many pay these levies without getting tickets. This is the case with transport unions that manage the parks and garages on behalf of the councils.

In spite of transport unions generating over a N100b yearly from parks and garages belonging to local councils, many of the councils cannot boast of a billion naira yearly IGR.

In addition, many hawkers, makeshift shop owners, cart pushers and petty traders operating by the roadside pay daily levies to the council through its representatives or consultants but often do not get ticketed for what is paid.

Recently, a lady-hawking groundnut around Mazamaza had aphysical bout with a representative of the Oriade Local Council Development Area over daily levy.

According to an eyewitness, the lady claimed she made a payment at Mile 2, a bus stop away, despite not having made any sales, so she was not ready to part with any money at that point. The revenue collector, on the other hand, insisted on collecting the levy, maintaining he would confiscate part of the lady's groundnut, if she fails to pay the levy, which led to open confrontation between the two.

Findings revealed that sometimes within the same local councils and LCDAs, petty traders, especially hawkers and cart pushers are made to pay levy more than once contrary to the state's local council law

And the state government through the state assembly, which should keep the councils in check often, backtracks after barking. For instance, on August 6, 2022, the Lagos State House of Assembly announced it had begun the probe of the 20 local councils and 37 LCDAs to justify accountability of public funds.

The then Chairman House Committee on Public Accounts (Local), Mr. Mojeed Fatai noted that the probe by the Joint Committee on Public Account (Local) and Committee on Local Government Administration and Community Affairs was to ensure accountability.

Fatai said the exercise was to make sure the funds from Joint Accounts Allocation Committee (JAAC) allocated to local councils and LCDAs were expended judiciously.

Yet after announcing probe commencement, the outcome of the probe was not made public. On many occasions, it usually ended in behind the curtain discussions even when the lawmakers unearth weighty infractions.

Stakeholders express concerns

When the acting Head, BudgIT Tracka, Ayo Ladipo, was asked to rate the local councils, she said that the performance of local councils in relation to their core mandate is abysmal.

Ladipo said: "An example is the Ikorodu Local Council. While reviewing its 2020 and 2021 budget implementation reports, we discovered that 79 per cent of the total expenditure was for recurrent spending, and only 21 per cent went to capital expenditure, which means the focus was on administration rather than development."

She observed that overreliance on financial resources from external parties is a huge stumbling block to local councils' effectiveness, because they have become puppets of the state governments and salary-paying agencies.

"This over-reliance has made local councils have no incentive to improvise, and generate revenue to ensure development and sustainability."

On how local councils in Lagos could be made viable, Ladipo said that restructuring and capacity building are two critical steps. She added that local councils in Lagos should be restructured to have more independence over their affairs with little interference from the state government.

She further said that the state government should perform oversight functions and should not be heavily involved in funding and administration.

"Federal Account Allocation Committee (FAAC) allocations should also go directly to the local councils without passing through the state government. Bypassing the state government will highly reduce the witch-hunting situation that local councils experience.

"There is also the need to improve the capacity of council officials to be effective and understand how to generate substantial revenue outside of FAAC. This will allow for improved service delivery in terms of capital infrastructure and development in their communities."

On if Lagos residents are doing enough to make the council chairmen accountable, Ladipo noted that residents are doing their bit, but they can do better.

She observed that many residents have overlooked the importance of local councils and focused on state and federal governments, allowing local council administrators to get away with a lot of misdemeanours.

Labour, Atiku slam NASS' speedy approval of Tinubu's \$800m loan, N500b palliative

ORGANISED labour, yesterday, described as laughable and economic waste, the plans by the Federal Government to transfer N8,000 to 12 million poor households in the country for six months.

In separate requests to the two chambers of the National Assembly, President Bola Tinubu had sought approval from the Senate and House of Representatives for a \$800 million loan and N500 billion palliative for the removal of petrol subsidy.

In May, former President Muhammadu Buhari had asked the Senate to approve the loan request despite the public outcry it generated.

Tinubu's letter, which was tagged 'Request for approval of additional financing of the national social safety net programme set up by the National Assembly,' stated: "The purpose of the facility is to expand coverage of shock responsive safety net support for all and vulnerable Nigerians and the cost of meeting basic needs.

"Under the conditional cash transfer window of the programme, the Federal Government will transfer the sum of N8,000 a month to 12 million poor and low income households for a period of six months with a multiplier effect on about 60 million individuals."

President Tinubu further explained that "to guarantee credibility of the process, digital transfers will be made directly to beneficiaries' accounts and mobile wallets.

"It is expected that the programme will stimulate economic activities in the informal sector and improve nutrition, health and education outcomes for beneficial households."

The Director General of the Budget Office of the Federation, Dr. Ben Akabueze, had recently criticised the continuous accumulation of public debt, saying the lean revenue does not support the move.

Speaking at the induction programme for lawmakers elected into the 10th National Assembly, Akabueze lamented: "We now have very limited borrowing space, not because our debt-to-GDP is high, but because our revenue is too small to sustain the size of our debt. That explains our high debt service ratio.

"Once a country's debt service ratio exceeds 30 per cent, that country is in trouble and we are pushing towards 100 per cent. That tells you how much trouble we are in. We have limited space to borrow. When you take how much you can generate in terms of revenue and what

you can reasonably borrow, that establishes the size of the budget."

But without delay, the Senate approved Tinubu's requests - the \$800 million World Bank loan and N500 billion fuel subsidy removal palliative.

According to the Senate, the N500 billion request meant to cushion the negative effects of the removal of fuel subsidy by the executive shows that the nation has a "government that listens." In a remark shortly after the approval was granted, President of the Senate, Godswill Akpabio said: "Let me thank colleagues for today's deliberation. I must thank all of you for your show of patriotism despite the hiccups. That's the Senate for you; very matured. Your attitude today has shown your commitment and determination to ensure that the present administration succeeds."

Also yesterday, the Senate passed amendments to the N819.500 billion 2022 supplementary budget. In passing that amended supplementary budget, the Senate approved N500 billion for palliatives and other capital expenditure to cushion the effect of the recent subsidy removal policy.

N185,236,937,815 was approved for the Ministry of Works and Housing to alleviate the impact of the severe flooding experienced in the country in 2022 on road infrastructure across the six geopolitical zones.

The sum of N19,200,000,000 was approved by the Federal Ministry of Agriculture to ameliorate the massive destruction to farmlands across the country during the severe flooding experienced last year.

Also, the sum of N35 billion was approved for the Na-

tional Judicial Council; N10 billion to Federal Capital Territory Administration for critical projects, while the National Assembly got N70 billion to support the working conditions of new members in the Assembly.

ARGUING against what it termed wasteful spending, the organised labour called on the government to halt the policy implementation, querying what N8,000 monthly to 12 million Nigerians could do, compared to the hyperinflation and socioeconomic challenges the nation is currently battling with.

According to them, with about 133 million Nigerians that are multi-dimensionally suffering from poverty, N8,000 for six months, which translates to N48,000 in six months, will neither eradicate nor alleviate poverty in 12 million household's lives.

They maintained that what the government has done was an ambush and gone beyond what it was supposed to do, stating that it has compromised the workings of the Presidential Steering Committee it inaugurated to come up with a framework on how palliatives would be distributed to cushion the effect of subsidy removal on Nigerians.

Also, the Special Assistant on Public Communications to former Vice President Atiku Abubakar, Mr. Phrank Shaibu, described Tinubu's plan to hand out N8,000 to 12 million households for six months as a brazen attempt to divert public funds.

Shaibu said in a statement that Tinubu's plan to spend \$800m on palliatives under an opaque arrangement was reminiscent of former President Buhari's conditional cash transfer and COVID-19 intervention initiative, which saw politicians keep-

ing food items and provisions in their homes while the poor went hungry.

He said Buhari's interventionist programmes only ended up making Nigerians poorer as shown in reports released by the National Bureau of Statistics (NBS).

Atiku's aide stated: "After announcing the removal of petrol subsidy without proper planning, Tinubu has asked for the approval of \$800m loan, which he claims will be disbursed to 12 million households for six months at N8,000 for each household per month. This is a continuation of the scam of the All Progressives Congress.

"According to statistics, a Nigerian household as at 2019 counted on an average of 5.06 members. So, with Tinubu's uninspiring plan, each individual in a household will get N1,600 per month or N53 per day. What should they do with it? Use the money to buy sachet (pure) water or a cup of boiled groundnut on a daily basis? And this is the man they claim transformed the economy of Lagos State? This must be a joke or a more sinister attempt to divert public funds."

Shaibu argued that Tinubu lacked a clear economic policy apart from taxing Nigerians. He said having deceptively attained presidential power, Tinubu has been exposed as an economic illiterate.

"His only plan is to tax Nigerians to death as he did in Lagos and that is why the people of Lagos rejected him in the last election. Tinubu promised to turn Nigeria's economy into a \$1 trillion economy but it is all a scam and can never be achieved with his brand of agberonomics."

He added: "Agriculture makes up about 30 per cent

of Nigeria's GDP. He should have invested funds in the production aspect of agriculture and other issues affecting crop yields. The rural areas, which are mostly agrarian, are in the throes of insecurity. On Tinubu's watch, over 200 people have so far been killed. However, he seems clueless on how to tackle this menace.

"The so-called palliatives that Tinubu seeks to share to the poor are just another avenue to divert public funds. For years, the Nigerian government has rejected calls to publish the list of the beneficiaries of the so-called palliatives but this has never been done because it is all a scam."

Already, Nigerians are agitated, calling for salary increases and palliatives that would benefit all, following the removal of the petrol subsidy. Chairman of the Progressives Governors' Forum (PGF) and governor of Imo State, Hope Uzodinma, at a recent meeting, said the President's decision to remove subsidy was in tandem with his campaign promises.

He expressed optimism that the new administration would come up with palliatives that would cushion the effect associated with the removal of fuel subsidies.

Earlier in April, the Buhariled administration had promised that it would pay N5,000 to 10 million households or 50 million Nigerians for six months as palliative for removing petrol subsidy after June, using the \$800 million World Bank loan to fund the project.

The then Minister of Finance, Budget and National Planning, Zainab Ahmed, said the effort was led by the Ministry of Humanitarian Affairs, Disaster Management and Social Development. "They developed the register with the support of the World Bank. The register has about 10 million households, equivalent to 50 million Nigerians."

But the disbursement did not come to fruition until the administration left office on May 29.

Just as it kicked against the earlier decision on the spending plan of the \$800 million loan, the organised labour yesterday, kicked against this fresh proposal by the government. Labour said while it was watching the government keenly, as it doesn't want to be drawn into the argument, "the problem of Nigeria is deeper than sharing money or talking about palliatives."

President of the Association of Senior Civil Servants of Nigeria (ASCSN), Dr. Tommy Okon, said the poverty situation in Nigeria could not be wished away by mere palliatives, adding that as far as labour is concerned, the government is paying lip service to the poverty situation in the country.

The Director-General of the Nigeria Employers' Consultative Association (NECA), Adewale-Smatt Oyerinde, said the government must stop using scarce resources to fix policy problems. He said it was both unrealistic and unsustainable, alleging that the

Stakeholders decry gaps in child adoption processes in Nigeria

STAKEHOLDERS and operators of orphanages and child care homes have expressed concern over lack of due process in child adoption in the country.

National President, Association of Orphanages and Homes Operators in Nigeria (ASOHON), Rev. Dr. Gabriel Òyediji, particularly, lamented lack of post-institutional monitoring of adopted children and proper documentation before they are given out.

He made this known in Abuja, yesterday, during a two-day national conference of the association.

"There is no post-institutional monitoring of what happens to children, when they leave care homes for adoption and fostering. We don't know what happens to these children after they have been adopted, and there is no follow up on their well-being by government agencies responsible for implementing policies, until they turn 18," Oyediji

The president said members were being trained at the event to track children in orphanages and curb abuses and growing rate of illegal orphanages that indulge in child trafficking.

NAHCON allays Hajj concerns as NCAA suspends Max Air's Boeing 737 aircraft

NIGERIAN Civil Aviation Authority (NCAA) has suspended operation of Boeing B737 aircraft in the fleet of Max Air Limited.

This was as National Haji Commission of Nigeria (NAHCON) assured pilgrims and stakeholders that the suspension would not affect airlift of passengers returning from Saudi Arabia.

Deputy Director (Information and Publications), Mousa Ubandawaki, said: "A clarification became necessary to calm pilgrims and relatives back at home, that the suspension order is limited to domestic air services, and does not affect international operations. The commission, therefore, wishes to assure all Nigerians and pilgrims, in particular, that the ongoing airlift of Nigerian pilgrims will continue undisturbed."

NCAA, in a statement, yesterday, said it took the action, following incidents involving the aircraft type.

They included loss of Main Landing Gear (MLG) wheel during a serious incident involving a Boeing 737-400

aircraft, with registration 5N-MBO, which occurred between take-off at Yola Airport, Adamawa State, and landing at Nnamdi Azikiwe International Airport (NAIA), Abuja, on May 7, 2023.

Others were: "Fuel contamination of the main fuel tank of B737-300 (5N-MHM), leading to Auxiliary Power Unit (APU) shutdown, at Yola Airport, on July 7, 2023.

"Aborted take-off of Boeing 737-400 (5N-MBD), which occurred at the Mallam Aminu Kano International Airport, due to high Exhaust Gas Temperature (EGT) indication on July 11, 2023, and an air return by B737-300 (5N-MHM) to NAIA, due to duct overheat indication in the cockpit on July 11, 2023.

The statement said the authority set up a team of inspectors to conduct audit of the organisation and insisted results must be satisfactory before the airline would be allowed to further operate the aircraft type.

Police nab father for selling three children NI.5m in Rivers

THE police in Rivers, yesterday, said operatives attached to the Commissioner of Police (CP) Monitoring Unit on Saturday, July 8, at about 5:00p.m., arrested one Charles Michael alongside six others for selling his three children for N1.5 million.

Michael sold his five-year-old child, two-year-old, and a day-old for N700,000, N500,000, N350,000 respectively.

The suspect, in an interview with newsmen, blamed economic hardship for his action, saying he was unable to take care of the children.

He confessed that he sold the children at intervals and used the proceeds to open a salon for his wife with hearing and speaking disabil-

He also confessed to being intercepted by a vigilante group in Omerelu in Ikwerre Council in Rivers State.

Michael disclosed that he was handed over to Elele Police Division from where he was transferred to the CP Monitoring unit.

The states Police Public Relations Officer (PPRO), Grace Iringe-Koko, while parading the seven child-trafficking syndicate, said their arrest was based on the revelation of two suspects who were earlier arrested.

Arrest corporal, others for armed robbery

Iringe-Koko noted that an extended investigation into Omudiaga community in Emohua Local Council of Rivers State and Ogbaku community in Mbaitoli Local Council of Imo State led to the arrest of the duo of Ndubuisi Egbueri at Omudiaga and Ndubuisi Wosa and Chioma Anele at Ogbaku.

She also noted that they confessed to receiving one of the babies, which they later handed over to a former councillor in Emohua Local Council identified as Regina Aki at Rukpokwu in Obio/ Akpor council of the state.

Iringe-Koko further stated that Aki was also arrested and she admitted to contacting one Favour Amaewhule at Aluu, in Ikwerre LGA where the day-old baby was sold in the presence of Michael Charles, the father of the baby.

She further explained that Favour Amaewhule was arrested and admitted to buying the baby for the sum of N700,000.00, while N350,000.00 was paid to Michael Charles, the father of the baby, and N350,000.00 was paid to Regina Aki and partners.

However, Iringe-Koko noted that both the two-year-old and the baby bought by Amaewhule have been recovered, adding that investigation was in top gear to recover the fiveyear-old.

Meanwhile, the mother-in-law of Michael explained to newsmen that before the arrest, the suspect had been lying to her that her grandchildren, especially the last child, died after birth.

She said the suspect was taking advantage of her daughter's disabilities to perpetrate the act of selling MEANWHILE, operatives of the Rivers State Police Command have arrested a police corporal identified as Bright Oke for alleged armed robbery and car snatching. Iringe-Koko said the officer with three of his accomplice went to snatch a Toyota Corolla at the Gate-

way axis of Ada George in Obio Akpor Local Council of the state when they were intercepted by men of the C41 intelligence unit. She said exhibits such as single-

barrel guns, were recovered from the officer who has now been dismissed.

Recall that the convoy of the cleric was in October 2022, attacked by gunmen with sophisticated firearms, leading to the death of six persons, including three police offi-

Isah, a plumber from Okene, Kogi State, told newsmen that their mission was to assassinate the pastor.

The suspect confessed he joined the vicious gang in 2021 after he was freed from Olokuta Correctional Centre where he was on remand since 2019 for alleged involvement in armed robbery.

He said: "The plan of our gang on October 21, 2022, was to forcefully kidnap the Apostle and collect a huge

"We had trailed him for days and planted an informant on the Benin - Auchi express road to feed us updates on

his itinerary on the day of the attack.

"I was the one who first opened fire on the convoy upon its approach but he managed to escape the attack. The attack was actually to assassinate him, although I was not part of the meeting.

Ilyasu and two other people were part of that meeting."

Parading the suspect in Abuja, the Force spokesperson, Muyiwa Adejobi, said operatives of the Intelligence Rapid Team (IRT) arrested Isah following an intensive investigation.

The suspect, who lives at Agbaraoluwa Phase 2 Ijoka, Akure, Ondo State, was arrested and five Ak47 rifles, two K2 Assault rifles, 180 live ammunition and four suspected improvised explosive device (IEDs), were recovered apartment.

Adejobi said investigations revealed that the suspect was part of the seven-man gang responsible for the attack on the convoy of the Apostle and some of the rifles found in his possession were in fact rifles snatched from the three police officers slain during the October 21, 2022 attack.

Police said efforts are ongoing to apprehend other suspects who are still at large.

Enugu community raises concerns over fate of vigilantes allegedly attacked by soldiers

Rivers: Pastor pleads guilty to sexually abusing 15-year-old girl

A Resident Pastor of Glori-ous Covenant Church, Port Harcourt, the Rivers capital, Piller Erekwa, yesterday, pleaded guilty to abusing 15year-old girl in Emohua Local Council of the state.







Ending abuse of court processes

THE trend by key players in the **■** judiciary arm of government to sanitise the sector, and ensure adherence to court processes is commendable, just as it deserves encouragement. As a veritable third arm of government essentially charged with the dispensation of justice, the judiciary plays an indispensable pivotal role in the sustenance of democratic governance in Nigeria. Therefore, abuses of the court processes, such as filing frivolous lawsuits in court, render the judiciary impotent and constitute a significant obstacle to the administration of justice.

Therefore, the recent statement of the Chief Justice of Nigeria (CJN), **Justice** Olukayode Ariwoola, during a special session to mark the 2022/2023 legal year and the inauguration of the 62 new Senior Advocates of Nigeria, is highly instructive. The CJN blamed the pressure on the judiciary on the filing of many frivolous cases in different courts. He advised that the public should engage in less litigation and embrace Alternative Dispute Resolution (ADR) to relieve courts from unnecessary pressure. Furthermore, the CJN stated: "In every little disagreement, we rush to court, and in every lost case, we rush to appeal, even up to the Supreme Court, no matter how trivial the issue might be. This has obviously resulted in several pending appeals in the Supreme Court."

We cannot agree more with the CJN. It is settled law that aggrieved persons should be allowed unimpeded access to law courts to seek remedies, as guaranteed in the constitution. In fact, nothing can be so loathsome as denying aggrieved persons their constitutional rights to seek remedy in law courts. However, there are many instances in which parties file frivolous lawsuits to abuse the court process or to overreach, injure, prejudice, frustrate, and work injustice against the other parties. In such initiates the court's process to annoy, harass, vex, and oppress the other party to the suit, as opposed to their purported constitutional right to seek remedy late Justice Niki Tobi in the Supreme Court case of Agwasin Vs. Ojichie (2004) was able to say, "Litigation is not a game of chess where players outsmart themselves through dexterity of purlitigation is a contest by judicial it out of reprehensible ignorance.

However, it is gladdening that some bold judges have now resorted to imposing hefty fines on lawyers and litigants in order to prevent them from filing frivolous cases in court. For instance, on February 26, 2020, the Supreme Court fined two popular members of the Bar N10 million each for respectively bringing vexatious and frivolous cases to court. The Supreme Court Justices were so angry with the duo that they ordered each of them to pay N10 million to each of the three respondents from their own pockets. While delivering the judgment, Justice Amina Augie said: "I cannot believe, and with tears in my eyes, I say I cannot believe that in my lifetime, I will see very senior members of the Bar bring applications of this nature to this court, which are aimed at desecrating the sanctity of this court, fouling its well-known principle that the decision of this court is final and destroying the esteem in which this court is held."

In March, the Lagos High Court sitting at Yaba ordered a legal practitioner to pay a N10 million fine for encouraging his client to file a suit that had already been decided at another Lagos High Court and the Court of Appeal. On May 26, the Court of Appeal, Abuja division, imposed an even heftier fine of N40 million on a former presidential candidate for filing a frivolous appeal in court. Shortly after that, the Federal High Court sitting in Abuja wielded the big stick against a legal practitioner for filing a frivolous suit. While dismissing the suit as frivolous and premised on recklessness and a complete lack of knowledge of the elementary principles of law as they relate to the Constitution and Electoral Act, 2022, the court ordered the legal practitioner to pay a gargantuan sum of N20 million in fines. Similarly, the Federal High Court in Abuia on June 6 awarded a N10 million fine against a former Minister of State for Labour and Productivity, Mr. Festus Keyamo, SAN, for filing a frivolous suit against the Peoples Democratic Party (PDP) candidate in the last presidential elecinstances, the abuse is evidenced from. In fact, the judge ordered by the intention of the party that Keyamo to pay N5 million each to the PDP Presidential candidate Abubakar Atiku and the Independent Corrupt **Practices and Other Related Offences** Commission (ICPC).

While it is not uncommon for some in court. It is in this light that the lawyers to file frivolous cases, it is important to note that the vast majority of lawyers strive to uphold ethical standards and ensure the cases they file have merit. However, it is obvious that some lawyers file frivolous cases on behalf of their clients in order to pose and tricks. On the contrary, earn more professional fees. Some do

in court to gain publicity, regardless of the frivolity of the action. This is why some judges now impose sanctions on lawyers, who bring meritless claims before the court, holding them accountable for wasting the court's time and resources. This can serve as a deterrent for lawyers who might be tempted to file frivolous

Consequently, in conformity with their professional ethics, lawyers should advise their clients against filing frivolous cases. Failure to do so should result in the courts continuing to award heavy costs against the lawyers. Lawyers should always adhere to their professional ethics. They should refrain from misguiding an aggrieved party by giving false hope that they can win their case in court. After all, the legal profession has rules and regulations that govern the conduct of lawyers, and they are expected to exercise their professional judgment when deciding to file a case. Lawyers have a duty to their clients and to the court to present legitimate legal claims and arguments in courts. Lawyers can advise their clients on the likelihood of success and the potential costs involved in pursuing a meritless claim.

Conversely, courts should encourage the use of mediation and alternative dispute resolution mechanisms as alternatives to litigation. These processes can help parties find mutually acceptable solutions without resorting to lawsuits, reducing the likelihood of frivolous cases being filed. Courts can implement efficient case management systems to promptly identify and dismiss frivolous cases at an early stage. This can help prevent the unnecessary burden on the court system and deter lawyers from initiating baseless litigation.

Like many other public sectors, the country's judiciary has not been spared in the crisis of integrity that has afflicted the country over the last eight years. But for an arm that is meant to be the last hope of the common man, such a crisis is embarrassing, and should not be allowed to degenerate through abuse of court processes. Preventing such an unwholesome situation calls for the active collaboration and cooperation of everyone, lawyers, judges and litigants inclusive.

It is important to strike a balance between preventing frivolous cases and ensuring access to justice. While discouraging frivolous lawsuits, it is crucial to protect individuals' legitimate constitutional rights to seek legal remedies when they have a valid claim.

Tunji Olaopa and his problems as an 'autobiographer'

ET me state urgently that I don't know Tunji Olaopa. I have **L**never met him physically and do not believe or expect that his path ever will cross mine. But this open factual remark does not really mean that I don't know this young and youngish former federal permanent secretary who became a professor of political science at Lead City University, Ibadan after his unexpected retirement from the Federal Civil Service. Of course, his premature retirement we must blame on the vagaries of the Federal Civil Service of sometimes vicious politics, to put it mildly. In a place like the Federal Civil Service peopled by men and women and officers, senior and junior officers, of vicarious authority and existence one cannot but be surprised that a public servant of unquestionable critical insight such as Tunji Olaopa's would always be viewed and treated as an aberration to be thrown out once the slightest opportunity presented itself. Now let me re-qualify my opening remark. I know Tunji Olaopa but by reputation. I have at different times read his articles published in this newspaper and other ones. Besides, this author whose newspaper articles have made serious impression on the minds of many readers happens to be a former Higher School Certificate (HSC) student of Olivet Baptist High School (Olivet Heights), Oyo which I savoured for a term and a half long before Tunji Olaopa entered the four walls of that famous college known far and wide for its academic and soccer exploits. So I know Dr. Tunji Olaopa after all - as a far younger student who never saw or caught a glimpse of my brake light, in a manner of speaking, in school and in college.

When Tunji Olaopa's The Unending Quest for Reform: An Intellectual Memoir recently came out of the press in faraway Austin, Texas, USA, I became interested in it on the triple grounds briefly related above. I made the right effort to have a copy of it for my personal edification being a lover and critic of his kind of book - I mean of his "intellectual memoir" which he calls an "autobiography" as well. Bishop Matthew Hassan Kukah and Professor Eghosa F. Osaghae who respectively wrote Foreword One and Foreword Two to the book equally followed his example to call An Intellectual Memoir an "autobiography." Do I agree with the three of them? These three minds undoubtedly have critical and creative gifts. But are they right absolutely to call the memoir autobiography? An attempt to answer this question offers me as a reader versed in autobiography the first problem in calling and interpreting Tunji Olaopa's memoir which it correctly is as an autobiography, which strictly it is not. To call the book "autobiography is misleading. Tunji Olaopa realizes this hence he tries to resolve his dilemma by giving his essentially public servant's book its correct title of The Unending Quest for Reform: An Intellectual Memoir, as already indicated. It is a captivating account of his civil service record and experience. This explains Tunji Olaopa's concentration on what I will call here events which centre on his political memory.

Qua autobiographical work of art, Memoir as work of art cannot be interpreted as autobiography even though it rightly contains very pertinent information about his Aawe homeland origins. I am not interpreting the book, I am only trying to criticize it according to standards, in comparison to other autobiographical works of art, for instance, the Italian Michel de Montaine's Essays whose "fancies" were not to "convey information about things" not squarely useful to his unique self. The chief task of the autobiographer is the presentation of himself. In other words, self-justification is the sole aim and concern of the autobiographer. An autobiography, an ideal autobiography, that is, does not, to all intents and purposes, represent the efforts of a series of men or of individuals each making what he or she could make out of series of events and or the work of his or her predecessors. This is within the orbit of a memoir.

Tunji Olaopa writes ambitiously which leads to other problems. The memoirist delves into history, into historical facts, which his present readers are not assumed to know. For example, the operation wetie in the Yoruba region historically called the "Wild , Wild West" on account of the violence which the political disagreement and tragic quarrel between the Chief Obafemi Awolowo and Chief Samuel Ladoke Akintola factions of the Action Group unleashed in that part of Nigeria in the fabulous nineteen sixties. Interpretation-wise, the liquidation operation wetie engendered is not in any way different from the criminal and militant fire and chaos we have witnessed in different parts

Thus Tunji Olaopa's book is relevant pertinently as history which detracts from the narrator's self. In fact, his focus on historical facts in several places in the narrative also arouses his interest in philosophy/psychology which cannot but enable one to say that the narrative is a philosophical/psychological stratification which Tunji Olaopa tends to utilize to give shape to his matter. Closely related to this is the matter of his mystical and mysterious experience at Olivet Heights and that of his Christian and spiritual advancement. His interest in Rosicrucianism, ifa, and Christianity is compelling and it enables the reader to have a thorough glimpse of his sensitive, inquisitive and penetrating mind. And his sagacity and consciousness as a bookworm that feeds on different kinds of books and the thoughts of their authors permit the reader to call him an autobiographer - as Bishop Kukah and Professor Osaghae have done!

Am I at last guilty of the sin of contradiction engendered by our narrator's confusion? Clearly not must be and is my answer. The problem is not this reviewer. The problem is the memoirist who also wants to double as an "autobiographer" as I have tried to argue. As a matter of fact, he also reveals himself as an essayist as witnessed in several paragraphs in the chapters. What everything I have said so far indicates is that Professor Tunji Olaopa is a victim of autobiography because of its protean, chameleonic nature. Roy Pascal makes this plain in Design and Truth in Autobiography. Georg Misch also seemingly makes this plainer in A History of Autobiography in Antiquity.

My prime concern in this short enterprise is with the interpretation and shape rather than with the subject of The Unending Quest for Reform: An intellectual Memoir. One reason for this is that I personally have slim hope for the bureaucratic leadership in present day Nigeria. The reforms Tunji Olaopa proposes will not be allowed to flourish in this country - his country your country my country our country. The Simeon Adebo model in the Western Region and the Allison Ayida example in the Federal Civil Service have since ceased to be because of who we are. Whatever brilliant ideas patriots such as Tunji Olaopa may have will never grow, or, be allowed to see the light of day by those who will hijack them to suit their nefarious, malicious and anti-Nigerian intentions and purposes. By the way, what has become of TET-FUND that the Academic Staff Union of Universities caused our federal government to establish long ago? ASUU's brilliant ideas that gave birth to TETFUND were swallowed by would-be killers of Nigeria and of our public universities. Tunji Olaopa's will be put through the mill by envious, jealous, lazy, dull and unpatriotic bureaucratic colleagues and leaders who have been misleading our politicians and political leaders.

A crucial statement on Tunji Olaopa's book under review: Every lover of Nigeria should read it. It is a priceless memoir-cum-autobiography as well as "autobiography-cum-memoir written and designed to call our attention to the service and labours of Nigeria. In any case, I have not deliberately set out to promise, promote or recommend it. It recommends itself even though the numerous pictures that adorn the pages give the wrong impression that the book is a run of the mill portrait. It is not and it is not even a variety of it – although readers and critics may debate the importance of the pictures in the book that Tunji Oloapa wants us to accept as a portrait of the "autobiographer." The pictures of himself and other persons of high society cogently show the narrator's preference of mind as plainly as an intimate memoir could do. For it is not in our memoirs but in our

selves. In this lies the essence and true nature of the art of autobiography. But this is debatable, I must admit. My final statement is this reiteration: Every lover of Nigeria should read The Unending Quest for Reform: An Intellectual Memoir. A great deal of the Nigerian problem is revealed in it.

 ${f T}$ ROUBLESHOOTING is an experimental process of thinking outside the box to ascertain what can work as well as what the prospective end-users think. It is an embedded consultative system of sampling people's opinion. A more explicit method is conducting focus group discussions as a form of opinion sampling and the creation of policy ownership through informal consultation. The two methods of troubleshooting and focus group discussion are aimed at the saturation of critical constituencies. After producing a policy, it must be monitored and managed to conclu-

The monitoring and management of policies can start with a test run which is usually a small scale experimentation. The system seeks to discover the strengths and weaknesses of a policy in actual operation. The test run provides a final opportunity to put the policy to test in action before its public launching. It also affords the policy Adviser the opportunity to correct errors and weaknesses that manifest in the trial operationalisation of the policy. All the above steps are necessary and should be painstakingly taken because a public policy error is very expensive to an elected political regime. In fact, it may be very critical to the electoral survival of the regime.

One of the weaknesses of the policy advisory system is the fact that the Advisers hardly coordinate their activities or see the need for cooperation. It is very important that the policies

visers must cooperate to align policies for synergy because the policies of a regime must not work at cross-purposes. Advisers must work together as a team because administrative departmentalization is merely for convenience rather than for functionality. It is in fact advisable that a regular meeting of Advisers be convened for experience sharing and general policy coordination. Advisers must come to the understanding that they serve the same principal. Their meetings should address the inevitable process of policy interaction which they can manage through the process of policy triangulation. This will lead to proper policy integration issuing from the same government. The advisory system in Nigeria at the federal and State level lacks coordination. There is no meeting point for the Advisers to honest trustee of another ethnic group. The rethe President with the Advisers to the various sult is that the government is divided for the Ministers. How Advisers are as critical as their offices. Advisers when carefully selected are essential for an effective government. However, there are many socio-political constraints in the recruitment of competent Advisers. Some constraints are inherent in the personality of the principals while others are systemic, statutory or constitutional. A principal who is not given to standards is likely to opt for mediocrity either by being nepotistic or clannish. Incompetent principals cannot recruit competent officers. What determines the quality of recruitment by a principal comes under the minimax rubric, namely that the principal who makes his own level of efficiency and

of a regime should be synchronised for effect. Ad- competence the minimum requirement for recruitment of Advisers will recruit excellent people. On the other hand, a principal who makes his own level of efficiency and competence the maximum requirement will invariably recruit mediocrities and sycophants. Such a principal is comfortable with such officers because they meet his mark. In such cases where the criterion of recruitment is not competence, it is illogical to expect competent performance.

The recruitment of Advisers is also affected or even dictated by systemic factors. In a plural society, members feel that their protection, welfare and share of public amenities is a function of their representation in government. This attitudinal disposition is a product of ethnic mutual distrust that no ethnic unit can be an people by the people such that the people think that the interest of each ethnic group can only be protected by members of that group. Sometimes this feeling is so deeply ingrained that it is written into the statute books and even into the constitution. That is the case of Nigeria. In local parlance, Nigerians want it implemented by demanding government presence in their localities. In Nigeria, therefore, the people perceive the Federal Government as the product of what the relevant invisible mental ethnic slice represents. In this sense, therefore, the Federal Government is local. While the abstract division of government along ethnic lines ostensibly sets out to ensure social equity and determines the location of the individual in the polity, it is responsible for the sub-optimal performance of government. Every appointment is located in the mental construct of the ethnic slice of the federation.

The above constraints notwithstanding, the principal still has to recruit personnel into these and other positions. As President Tinubu is now poised to recruit personnel into offices, he must carry out the functions to the best of his ability in the best interest of the country and mindful of the fact that he is not immune

The late Timi of Ede, HRH Tijani Oyedokun, Agbonran II summarised Palace 101 to me in one sentence: "The Palace is a refuse dump". All and sundry, rich and poor, young and old throw, and are entitled to throw refuse there. That is also a defining right of democracy. What reduces the dumping of refuse is to continue to do what is right rather than what is good. Right and good have their appropriate occasions. Another antidote and consolation is that: "Abuses do not break bones". The Principal must therefore not be tempted or driven to the other extreme which my first year Political Science teacher, Prof James O'Connel summarised in another sentence: "Once a king receives the staff of office, he no longer gets good advice". Good or bad, everybody praises the king's actions. Unfortunately, when the King falls, everybody says "We warned him!!" It is only power that makes people powerful. The Principal must always remember that it is the Adviser that is rich in options, adds value and honestly speaks truth to power, that is the sincere, competent and loyal Adviser.

'Go to court': Any remedy for Nigeria's ailing justice system?

¬O to Court can also be hubris of judicial Gcapture and corruption. As I have said elsewhere: "Nigeria's judiciary appears deep in the throes of being reshaped as an estate defined by filial and genital relations to facilitate transactions for political power. This is called judicial capture. As judges now have the casting vote in Nigeria's elections, ambitious politicians have decided they must own the judges. Judicial capture occurs through both decisions and omissions by and beyond the judiciary." The point about judicial capture is that it does not pretend to put the institutions of the judiciary to any transcendental or societal goals. The entire goal of the office of the judge is creating and sustaining an incest of power. This is why leading politicians and judicial figures will insist on making their spouses, mistresses, children or family members' judges. This is also why state governors will ensure that all judges who serve in their territories are given choice properties and other dispositions which they do not habitually declare.

The underlying narrative of judicial capture, as I have also suggested, is that "in Nigeria judicial skill and temperament naturally resides mostly in the bedrooms of politicians (and their judicial allies)." Quite clearly, this does not stand up to scrutiny, but that has not stopped an incest of senior lawyers, judges, and politicians at the highest levels in Nigeria from pro-

To be sure, the erosion of the credibility of Nigeria's legal profession and judiciary may have plumbed new depths in recent times but the crisis of confidence arising from perceptions of judicial partisanships, especially in the political context of election disputes, has a much longer history. In its 1986 report, the Judicial Commission of Inquiry into the Affairs of the then Federal Electoral Commission (FEDECO) between 1979-1983, which was chaired by former Supreme Court Justice, Bolarinwa Babalakin, noted with reference to election petitions that followed the 1983 general elections that:

As the verdicts began to be pronounced, the general public often expressed shock and dismay. Some commentators in the nation's newspapers took the view that the verdicts in a number of instances constituted a rape of democracy perpetrated through the law

Allegations of corruption in high places were freely made.

Following the 2003 and 2007 elections, Professor Obi Nwabueze, SAN, accused the Supreme Court, no less, of playing a "discreditable part" in manufacturing a jurisprudence of electoral impunity for the country. In particular, he laments the failure by "the Supreme Court to appreciate that the question of who should rule Nigeria is not one to be decided by a perverse and narrow legalism, by the technicalities of the rules of evidence, practice and procedure and by considerations of expedi-

This jurisprudence of electoral impunity has created a system of mutual benefit between judges and politicians to the exclusion of voters. Under Nigeria's constitution, According to S.14(2)(a) of Nigeria's 1999 Constitution, "sovereignty belongs to the people of Nigeria from whom government through this Constitution derives all its powers and authority." Article 21(3)26 Id27 Federal Republic of Nige-

The Universal Declaration of Human Rights affirms that "the will of the people shall be the basis of the authority of government; this shall be expressed in periodic and genuine elections which shall be by universal and equal suffrage and shall be held by secret vote or by equivalent free voting procedures." Similarly, Article 13(1) of the African Charter on Human and Peoples' Rights declares: "Every citizen shall have the right to participate freely in the government of his country, either directly or through freely chosen representa-

Yet, in Nigeria, the real deciders of who gets to win or lose an election is no longer the voter but the judge. This judicial expropriation under cover of the law of rule (not rule of law) of a right that only belongs to the voter, ensures that the politicians no longer focus on persuading the voter through campaigns and manifestoes. Instead, they target the judges through focused campaigns of corruption and capture, which are profitable for the judge who in turn use their office to en-

sure the politicians of their choice get the spoils of office. When the politician gets into office, he has an incentive to ensure that only persons beholden to him get into high judicial office.

Profitable as adjudicating on elections and politics has become for him or her, the average Nigerian judge no longer has any incentive to sit on regular casework. The current reality is not merely that the Nigerian judiciary binges on party political cases, it is also that they assign priority to politicians over ordinary citizens, in so doing, encouraging the idea of a hierarchy of citizenship.30 If you are involved in a political case but not as a benefactor or client of the judge, you stand no chance of getting a fair shake. If your case is not political, you stand no chance of even being heard. Either way, "Go to Court" has become a short hand for telling the court user that they are involved in a futile pursuit. Meanwhile, these political cases have become chronic sites of execrable transactions in buying and selling judicial decisions. In 2020, the Independent Corrupt Practices Commission (ICPC), reported that "lawyers were mostly responsible for offering bribes for favourable judgments mostly in electoral and political matters." According to the Commission, between 2018 and 2020, "II out of the 123 judges surveyed, reported "Nigeria's courts of unequal injustice and curious appointments", experiencing offers or payment of N3.307 billion and N392.3 million as a bribe", indicating that buying and selling judicial decisions is a highly profitable enterprise.

Fire on the mountain

ANY close observer of goings-on in the South East cannot but be alarmed at the hellish situation and the rest of us are looking away. Our gaze and exertions are concentrated on politics when gloom overcasts the land. Listening to politicians and outspoken members of the elite clubs, you have the wrong impression that all is well. Yet reports and videos say otherwise. Not even the proactive NGOs have drawn attention to the nation's hara-kiri. When any part of the body is ill it is the whole of it that is ill and will know pains. As it is with the body so is it with a nation: When any component part of it is unsettled and in grievous harm's way or is already entrapped in it, it is the entire country that suffers. It is existential conundrum to which we have not paid thoughtful attention. The posture of Buhari was that it is strong-arm tactics that would teach the agitators in the South East the lessons of their lives. He was unable to distinguish between agitators for freedom and agitators to enslave and dispossess—the bandits and kidnappers. Those pressing for freedom are the "Biafrans." For most of the eight years that Buhari was the Sheriff we witnessed violent, murderous campaigns waged by the agitators. And he thought he should pay them back in kind with firmness that may include military operations, which I consider problem of poor human management.

In my intervention in the matter at a time, I recommended that Buhari should consider an exploratory meeting with three or so representatives of the agitators led by Nnamdi Kanu. He should get Dr. Christopher Kolade assisted by his right-hand man Professor Pat Utomi he esteems highly and trusts to go to the East and fetch Nnamdi Kanu who would be accompanied by Prof. Ben Nwabueze, SAN, for whom Nnamdi Kanu had tremendous respect and could hardly look in the face and perhaps joined by Senator Ababribe who was already in Abuja in the Senate at the time or even Prof. Charles Soludo. Kolade was going to fetch Nnamdi Kanu armed with his disarming sense of humour that can melt a heart of stone; Utomi was to provide the intellectual powerhouse.

When all are seated in the appropriate conference room, Buhari would emerge from his office accompanied by Boss Mustapha (SGF), Chief of Staff Abba Kyari, and Femi Adesina, with his two fists already hitting the air. In a display of mock pugilism, as his guests rise to pay customary homage, he blurts out, inviting Nnamdi Kanu forward for a duel: "Who amongst you here is Nnamdi Kanu? You want to fight; I hear you want to fight; come out, let us fight." He cuts the image of Mohammed Alli at that moment. The guests; everyone, surprised would say, "Your Excellency, Sir, don't do that. No, don't do that, Sir!" It was all going to be a ioke to relax everyone, and everyone would laugh heartily and say to one another: "So, this man is a human being after all! It is from a far that we see him as stiff, rigid and unsmiling; so he is this approachable." After banters, Buhari would say to Nnamdi: "Young man, what's your problem? I want to listen to you." Dr. Kolade would then take the floor and give reasons he had gone to fetch Nnamdi Kanu. After discussions that would last no more than 45minutes in such a relaxed and cordial atmosphere, Buhari would then say: "All right, you know what? Young man Kanu, go and give me a paper on your vision of Nigeria. Do we then say we meet again in three weeks time or is it a month? The choice is yours. When you are ready, Dr. Kolade will keep me posted." He brings the meeting to a close; there is laughter; there is shaking of hands. He asks Boss Mustapha to collect Nnamdi Kanu's number. With that encounter, Buhari would have made a lasting impression on Kanu and his colleagues. Tension would have gone down. We would have been on the way to resolving the conundrum and preventing the escalation in violence. It would be seen, indeed proven that to jaw jaw is infinitely better than to war, war, as they say. My suggestion certainly fell on deaf airs and the situation

It became frightening when the Biafran agitation deteriorated into locking down towns and villages on May 30 of every year in commemoration of the declaration of the independence of the Republic of Biafra by Odumegwu Ojukwu. IPOB followed the compulsory marking of the anniversary with Monday restrictions. What is in force today is "Stay-at-home" order for the first week of every month. The IPOB high command believes this is not enough. It has issued a circular with effect that from August 5 the restrictions will be extended to

Today, life in the South East is more nightmarish for indigenes and other residents of the five states of Anambra, Enugu, Ebonyi, Imo and Abia states than those who live outside the Zone can imagine. The governors of the five states met in Abuja during the week and resolved to table their grave concerns before President Tinubu. These states are now probably no better than prison enclaves in which two governments contest for power. One government is official, deriving its authority from Nigeria and from the Nigerian citizens. The other government is illegal under the Nigerian law, but it is, nevertheless, obeyed and as effective, and may be considered even more effective than the official government in place, run armed with constitutional instrument, the grundnorm. This unofficial government has been nicknamed UNGUN Known Men, deriving the nickname from the corruption of Unknown Gunmen which the police are wont to blame for mayhem anywhere in Nigeria there is an incident by trigger-happy and fleeing hood-


From the relatively peaceful states of the South-West and South- South, and from the states of the North-West, North-East and North-Central, grappling with kidnapping, banditry and terrorism, it is as though the South Eastern states zone is a huge movie screen where the scenes are constantly changing from melodramatic to everyday tragedy. The nation has lived with the "Sit at home on Monday" order of the guerilla fighters for the Republic of Biafra for a while. The residents live in fear of them and obey them. Federal soldiers and police brought in to overpower them have been unable to record much success. They are handcuffed by history. That history is the Nigerian Civil war (1967-1970) in which the Igbos suffered horrendous human and material devastation.

Running over the South East again to forcibly quell Can we be so bereft of love and humanisionist movement 56 years after the first one, the wound of which has not completely healed, would almost amount to genocide on the part of Nigeria. Every Igbo man and woman would naturally rise in defence of their land and the result would be more catastrophic than of this IPOB problem and give it a simple the carnage of the Biafran war of 1967-1970. We may not rule out many donning the toga of Professor Wole Soyinka and wearing

the boot of Dr. Tai Solarin joining them. While Soyinka was kept away in solitary cell, Tai Solarin was going in and out of jail house. He was visiting Nzegwu's mother at Okpanam in today's Delta to check on her wellbeing.

Now, the guerilla fighters have gone one more step forward to claim authority in the South Eastern states. As said earlier, they have extended their Sit-at-home directive to one week and from next month to two weeks. Trade, business, industry and social lives have been damaged under the Monday hammer. Many sick prevented from accessing hospitals and clinics for health remedies and healing have died at home.

In consequence of fear for their lives, many Igbos are migrating to comfort zone states. Cross River, Rivers, Akwa Ibom, Edo, Delta and South-West states, especially Lagos and Ibadan, are their goals. This is creating immigrant pressure and population swells on the budgets of these states, with resultant tension. Igboland has a huge population crisis caused by many factors one of which is the landmass. The landmass is small and has not, even if it can, ably supported the ever growing population. Another factor is ancestral land holding culture which is not keeping pace with modern land demand and land use dynamics. Thus, there is the natural trigger instinct in the average South-Easterner,



man and woman, to immigrate to other parts of Nigeria and overseas where unrestrained, can spread his or her unfettered wings and find life's fulfillment.

The unknown gunmen question does not appear to have anything to do with business, commerce and industry. It is a pressure for inclusion in federal architecture. What is worrying about the new development in the South East, however, is that the five governors seem helpless and appear to have no authority over freedom fighters in their respective states. One governor came out to say he would revoke the licences of companies which obeyed the freedom fighters. It can be assumed the companies included banks, petrol filling stations, and retail markets and more. Imagine the emergent Nnewi industrial centre and Aba, the well known hub of industry and commerce, shutting down! Soon after the governor said this, the freedom fighters went to a public school which opened, got the poor children and teachers to lie on the ground and flogged them before sending them home. In a retail market, they opened gunfire for several minutes. The traders fled without their cash takings or wares. The message is clear: Will the traders like to remain in the state where they cannot eke out a living? Which parent will send a child to school when the unknown $gunmen\,have\,decreed\,they\,should\,not\,come$ to school? Who will be so foolhardy to disobey them? The decision to comply with the order will be based on the natural philosophy that the end of obedience is protection and protection is the assurance of obedience. Who does not obey armed robbers tearing into the house he or she built from his or her sweat when there is no state presence to protect him or her from the invaders? In this scenario, the South East may lapse deeper into newer levels of Biafra agitation which may find sympathy in other regions! This points in one direction only and that is Fire on the Mountain—on the Nigerian roof if we are not careful! What is President Bola Tinubu to do in the circumstance?

What is the way forward? First of all, we must recognise the purpose of life on earth and the unwavering principles governing life. They are the perfect Laws of Creation. In the enlightenment of these times, we learn how important these Laws are in our lives for peace and harmony, and joyful collaborative swinging. The greatest of what undergirds the principles is love. They encapsulate the Love of the Most High. Is it not an agelong saving that it is love that makes the world go round? In The Light of Truth beaming its rays on the eternal principles, the Laws of Creation, says: "The spirit of earthman must now become alive and strong in the Will of God, to serve which he is allowed to dwell in this Creation. The time has come! No longer are any enslaved spirits tolerated by God! And man's self-will shall be broken unless he is prepared to adjust himself to the primordial Laws of God which He placed into Creation. To these also belongs the Law of Movement, which demands unhampered progress in development. The extension of knowledge remains connected with this! The knowledge of Creation, spiritual knowledge, is the real purport of life!"

Can we be so bereft of love and humanity that we are unperturbed looking away in a situation a section of our society is under siege of terror? If we want progress, before we have a national crisis on our hands, the National Security Adviser, Nuhu Ribadu, and the President may wish to do a little review of this IPOB problem and give it a simple but effective solution.





Downplay import substitution, get on global market, Adesina charges Nigeria

 R^{EELING} out data from across the world on how export has changed the fate of economies, President of the African Development Bank (AfDB), Dr. Akinwumi Adesina, urged Nigeria to dump the layback economic models and survival mode while joining the Asian countries to compete for the huge export market.

In his tradition, the former Nigeria's minister of agriculture, yesterday in Lagos, spoke excitedly about the huge potential of the economy but warned that the import substitution policy option would continue to mask the opportunities to transform the country to the real "lion king" and increase the economic growth substantially.

At 2.31 year-on-year (Y|Y)growth in quarter one, Adesina, who spoke at BusinessDay CEO Forum 2023, said the country is developing too slowly and well below its potential, charging "the lion king in the making" to learn

"The key to unleashing

Nigeria's lionhood is engineer- and not a 'global manufacturing an industrial revolution, the likes of which we have not seen before. It must be deliberate and intentional," the AfDB

Part of the engineering, he said, would require de-emphathe restrictive import substitution model and taking the path of the Asian countries in exploring the unlimited opportunities in export. He regretted that Nigeria's manufacturing sector represents only three per cent of the total revenue from exports whereas it accounts for 50 per cent of the country's imports.

NCC unveils guidelines for promos, lists process of denial

THE Nigerian Communications Commission (NCC) has unveiled guidelines for the conduct of promotional activities, especially by Mobile Network Operators (MNOs) in the industry.

NCC, which referenced the powers conferred upon it by Section 70 of the Nigerian Communications Act, 2003 to regulate this, said the Guidelines are developed to set minimum requirements and standards for promotional advertisements by licensed communications operators in Nigeria.

According to NCC, 'Advertisement' means any message, the content of which is controlled directly or indirectly by the advertiser, expressed in any language and communicated in any medium with the intent to influence consumers' choice, opinion or behavior.

In the 15-page document by the regulator released, yesterday, NCC said the Licensee shall submit to the Commission a written request for the approval of any promotional advertisements for goods and Oservices. The request shall be

submitted at least 30 working days before the proposed or planned publication, and the licensee shall ensure that the application meets minimum standards and requirements.

NCC informed that all approvals granted shall be registered with the Federal Competition and Consumer Protection Commission (FCCPC) within three days of the launch of the promo-

Some of the requirements are the licensee shall attach a detailed report of the advertisement specifying the goods and/or services and the target consumers; the licensee shall, if the goods and services on which an advertised claim or representation depends can be tested by survey or data, provide such data, which shall be reasonably competent and reliable, reflecting the true and accepted principles of such research; the licensee shall adhere to set standards for quality and grade of service set by the Commission; the licensee shall adhere to the set standards on communications products and equipment that are manufactured. imported or sold in Nigeria.

THE Ministry of Finance Incorporated (MOFI) targets \$10 billion from its portfolio investment in the next 10

The Chief Executive Officer (CEO), MOFI, Armstrong Katang, stated this in Abuja, yesterday, at the Public Private Partnership Consultative Forum (3PUCF) meeting, adding that 50,000 new jobs are equally expected to be created by 2028.

According to him, MOFI will establish at least five new sector-focused growth funds within the next five years, to catalyse growth in priority sectors and support the development of high-potential businesses.

The number of companies under MOFI's portfolio is expected to increase by 15 per cent within the next five years by identifying and acquiring companies with significant potential for growth and profitability.

He noted that the organisation plan to develop and implement a comprehensive professionalization programme for all state-owned entities under MOFI's management within the next four years to improve their operational efficiency and financial performance.

He added: "MOFI's focus on professionalising state ownership is aimed at ensuring that all state-owned entities are effectively and efficiently managed to achieve greater economic impact.

"Professionalising state ownership involves providing stateowned entities with the necessary support to become more efficient, effective, and profitable in their operations. This support includes providing access to training, technology, and other resources necessary to improve their operations and financial performance. The goal is to enhance the competitiveness of state-owned entities and make them more attractive to potential investors."

We had discussions regarding what customs can bring to the table in terms of actualising the vision of renewed hope for Nigeria, bridging the gaps in revenue generation, enforcement strategies, and, most importantly, promoting port efficiency and competitiveness," he said.

The Acting Comptroller-General also assured of a pragmatic move towards decongestion of the country's ports to enhance revenue generation, facilitation of legitimate trade and antsmuggling war.

Addressing the rumour of integrating government agencies, Adeniyi said he was not privy to any information about that yet while explaining further that, although, there is a common base among revenue-generating agencies.

"There are some areas where we overlap and some can complement one another but in terms of bringing the agencies together under one organisation, we are yet to get details of that and we will be waiting to get the details and see how that pans out," he noted.

'Human capital most valuable resource in the digital economy'

DIRECTOR General (DG) Information Technology Agency Development (NITDA), Kashifu Abdullahi, said human capital is the most valuable resource in building a non-dependent digital economy while stressing the need for digital literacy and skills.

NERC to collaborate with stakeholders on power supply

OMMISSIONER in charge of Legal, Licensing and Compliance, the Nigerian Electricity Regulatory Commission (NERC), Dafe Akpeneye, said the commission is ready to partner state governments and other stakeholders in line with the new act to ensure uninterrupted power supply.

He made this known at the NERC stakeholder's workshop in Lagos, noting that Nigeria is yet to meet adequate supply,

"There is a cost to electricity, and we have not yet made the commensurate investment in the sector to give us ade-

quate supply, NERC's principle has always been that we will partner with any State or anybody that achieves the common goal of ensuring that the lights stay on," he said

The 2023 Electricity Act empowers NERC to have a continuing responsibility to monitor the Nigerian Electricity Supply Industry (NESI) regarding its potential for additional competition.

According to the Act, NERC must ensure the prevention or mitigation of abuses of market power, which includes market concentra-

The commission said there is no intention to 'central control' everything, noting that the regulator is aware of what the new Act entails, adding that it is geared towards improving service to the consumers and increasing investment.

Chairman/Commissioner of Market, Competition and Rates, NERC Musiliu Oseni, said only 53 per cent of available electricity capacity is utilised in the country due to challenges with the gas supply, transmission and distribution constraints and commercial challenges.

"Power is the engine to growth everywhere but there must be orderliness, we can work with states within existing legal frameworks and even if they set up additional legislation," he said.

The commission stressed that after reviewing the cost implication, states will decide how they want to work together, noting that it will not be a one shoe size fits all approach, but based on what they can sustain.

N the past month, there Lhave been sweeping changes in the foreign exchange markets in Nigeria. The most important of these introduce a single, marketdetermined exchange rate for all transactions, which is at odds with the policies of the Central Bank of Nigeria (CBN) since 2015.

The government had a separate exchange rate; the airlines had theirs; small businesses and manufacturers used a different rate; and individuals could access FX at different rates based on the purpose. Even worse, those who had the capacity to buy the FX rationing. Those who had the FX to sell were not allowed to do business at their preferred rate. It was an absurd arrange-

Unlike the apathy that greeted the prior stance of the CBN, the ongoing reform has been cheered by both foreign and domestic investors. In fact, Nigerian stocks eurobonds have recorded significant gains due to a boost to investor confidence. Nigeria Air: How to float national carrier without rancour, borrowed planes

The recent unveiling of Riyadh Air in Saudi Arabia offers Nigeria vital lessons on how to roll out a national carrier – if it must be done at all, **JOKE** FALAJU reports.

ON March 12, 2023, the Crown Prince of Saudi Arabia, Mohammed bin Salman, officially announced the establishment of Riyadh Air, the second national flag bearer of the country.

The airline is planning to be the largest in the Middle East in terms of revenue. It will operate domestic and international scheduled flights to over 100 different destinations in the Middle East, Africa, Asia, Europe, South America and North

Two days after the announcement, it was revealed that the airline had ordered 39 Boeing 787-9 aircraft, with options for

Unlike Nigeria Air - unveiled in 2016 at the London Air show by the immediate past Minister of Aviation Hadi Sirika amidst backlash from Nigerians over lack of consultation as many citizens got to know about the project when it was unveiled in London - Ryadh Air was launched amidst global cheers at the just-concluded Paris Air Show on the June 4, 2023 and with immediate footprints in international avia-

The same day, Riyadh Air unveiled its first livery Boeing 787-9 aircraft, it received its airline designator code "RX" from the International Air Transport Association (IATA) at the World Air Transport Summit, which took place in Istanbul.

On June 12, 2023, the first aircraft was delivered to the airline's fleet by Boeing and on June 14, 2023, the airline was granted the Passenger Air Transport Economic License by the General Authority of Civil Aviation (GACA), which is necessary for the airline to begin commercial operations.

Still on June 12, at the Paris Air Show, Riyadh Air signed an agreement for 90 GE Aerospace's GEnx-1B engines to power its future fleet of 39 Boeing 787-9 aircraft.


According to the Saudi Press Agency (SPA), Riyadh Air will be a company owned by the country's Public Investment Fund (PIF), with Yasir Al-Rumayyan, the governor of PIF, serv-

Tony Douglas has been appointed as the Chief Executive Officer (CEO). He previously served as the CEO of UAE-based airline Etihad Airways from January 2018 until October 2022. Riyadh Air is set to be a 'world-class airline', and is expected to add \$20 billion to non-oil GDP growth and create more than 200,000 direct and indirect jobs.

Nigeria Air project, on the other hand, has been a suspect. Recall that the project is a Public Private Partnership agreement orchestrated by the former Minister of Aviation, Hadi Sirika, wherein Ethiopian Airlines owns 49 per cent, MRS owns 31 per cent, SAHCO owns 15 per cent while the Federal Government owns five per cent equity.

But the arrangement has not gone down well with many stakeholders, especially airline operators.

The AON protested that the new carrier's strategic partnership with Ethiopian Airlines gave it an unfair advantage that would stifle the growth of domestic airlines by monopolising domestic, regional and international routes.

However, some experts in their arguments in favour of the Nigeria Air project, said Riyad Air aircraft also used for the unveiling is registered in the U.S. under a Boeing registration number: N8572CT, saying that was the same as the Nigeria Air unveiling with ET registered aircraft but Nigeria

An aviation expert, Captain John Ojikutu noted that Nigeria does not need a national carrier but a flag bearer. He said: "A country like Nigeria should not be talking about National Carrier but a flag carrier. What we need to have is an airline designated for inter-continental route and two carriers for regional and continental operations."

"We have wasted too much time and money on the national carrier. Since 1993, they wanted to kill Nigeria Airways, and then they came up with Virgin Nigeria, but they still failed. He said what needs to be done by the Nigeria Civil Aviation Authority (NCAA) is to come up with a commercial or economic report of airlines that are operating now, saying two of the airlines are good to go.

He said if AMCON and the Federal Ministry did not mess up Arik and Aero contractors the two airlines would have been used to set up flag carriers.

"Most countries that had a National Carrier during the same period of Nigeria Airways have closed down. Even America does not have a national carrier; what they have is flag carriers, even British Airways is a flag carrier.'

He said: "The former Minister of Aviation messed the whole process up. He is the only one running up and down. What about the remaining 95 per cent shareholders? If you are having an airline like that, you should allow the people with 95 per cent stake to control the whole process, and then come in when they are ready. It is only the government that is spending money, what about others?'

Ojikutu added that before designating an airline as a flag carrier, the government must ensure that 20-30 per cent of the shares are owned by the Nigerian public.

He said, if the government must go into partnership with an airline, it must not be competitors on the BASA route. They can go to Europe or Asia to get partners, but not with a competitor on the BASA route.

"We have done it before; we have partnered KLM and South African Airways. It did not work, so we should forget about it," Ojikutu said.

An Aviation commentator, Olumide Ohunayo, also submitted that "National carriers are usually owned and funded by the government. Most times, you see the government establish a national carrier where the market is closed. The dominant carriers are the ones owned by the government or the Middle East countries with excess funds.

"But in our case, we don't have that excessive fund, with our multidimensional poverty rate, which is more important to get out of than running a national carrier."

He added: "With the domestic carrier that we have, we can build a strong flag carrier because we have the market. Government can provide the necessary support that will attract partners to them. That is why we should be looking at how to build a flag carrier from the present crop of carriers that we have. This is doable and that is what we should

"Sirika has his agenda, dream and purpose, which was higher than national interest, which is why everything he did ended up in litigation, protest and condemnation. The new minister, when coming in, needs to investigate all the projects by the former minister so that we don't have partially functional projects," Ohunayo said.

"Foreign airlines must be restricted to a single point of entry into Nigeria and that is the way to go so that we can rescue the market

from foreign powers. We need to fly our own."

Vice President of the Airline Operators of Nigeria (AON), Allen Onyema, harped on passenger education to understand the operations of the airlines and stop the upsurge in condemnation due to delays and cancellation of flights.

He said urgent attention must be given to infrastructure development and the regulatory agency; the Nigeria Civil Aviation Authority (NCAA) must be allowed to be truly autonomous by the supervisory ministry.

Just President Bola Ahmed Tinubu has been preaching, students are at the centre of any policy on education because education is all about students. It is not about those that teach but basically the students. So, every policy around education should be centred around students and how to equip them with the right skills and knowledge to enable them contribute meaningfully to the society when they graduate.

"It is in the same line that TETFund is consulting with them to find out their needs, their expectations and their aspiration in order to guide our recommendations to the Board of Trustees and to Mr. President to make the right interventions."

On the issue of hostel accommodation, the ES admitted that the quality of accommodation in different campuses of public tertiary institutions is not something to be proud of. He therefore assured students that efforts are being made towards addressing the situation.

He said: "At the last engagement, there were requests bordering on students' accommodation because we all know that the quality of spaces where our students stay are not things that we should be proud of. We at TETFund are already designing interventions along those lines to ensure that we increase the stock of students' hostels, some directly and others through PPP arrangements because we also believe that we can leverage on our funds to attract investors to our campuses but we can do some of them

directly through our own projects", he said.
On the issue of transporta-

tion within campuses, Echono did not want to preempt Mr. President. He only assured his guests that the issue was receiving desired attention.

He said: "We also talked about the issue of transportation within campuses. I don't want to preempt Mr. President but we are already looking into those two major requests of theirs and they shall yield results.'

Before handing over the car documents and the key of the bus to the students, the ES charged them with the responsibility of monitoring intervention projects on campuses. This development, he believed, will put contractors on their toes, not just for timely completion of projects but also, to ensure good quality job.

"Another engagement we are having with the students is the fact that we want them to be our eyes in their respective institutions. TETFund interventions translate to execution of projects and implementation of different intervention lines, and these all happen on campuses. So, we want a situation where, when something is going wrong with projects on our campuses, we have multiple ways of being able to get information, and one of those ways is through the students who are the beneficiaries of those interventions.

"So, by our programme, we want to be able to identify on each campus, a contact person that would be able to liaise with our monitoring teams and be able to engage with the contractors. Sometimes, they may be required to visit a particular site, confirm whether work is going on there or not, look at the quality of work and see whether the contractors are on site or not so that we can have a first-hand information; not a situation where we wait for a school to apply for a particular tranche, then, we send our team there only to discover that everything has already gone wrong.

"We are doing similar

engagements with other stakeholders. In fact, the staff unions are also helping us to carry out monitoring of projects. So, we feel that going forward, this will help us to make our monitoring process more transparent and more engaging. Also, when people know that students who are constantly there are watching out, and can let TETFund know whether they are working well or not, I am sure that those working on those projects will sit up and ensure that they do good quality work."

The ES however informed them that the template for the monitoring would be worked out in consultation with the students to state how the Fund wants to structure it.

"As I said, they will give us a full representation in each of the almost 250 beneficiary institutions across the country. And with this, the Fund will officially commission the students' body to be part of the monitoring teams for intervention projects across the campuses.

Having said that, the ES went on to perform the symbolic transfer of the coaster bus to the students amidst cheers and encomium on the Fund and its leadership.


In his response, the President, NANS, Usman Barambu, who came with some of the executive members and former President, pledged to be ambassadors of TETFund.

He said that the student's body had earlier met with President Tinubu and tabled some of their requests, include provision of hostel accommodation on campuses as well as provision of means of transportation on campuses.

"But the important thing we mentioned was the recommendation of TETfund. We called on him to do more for TETFund. We told him that 90 per cent or more of the support for tertiary institutions came from TETFund.

"Without TETFund, our institutions would have died. We are proud to say it because if you go to our campuses, you





will witness the activities of TETFund. We are proud of that and we keep thanking Arc Echono and promise to contribute our own quota to support TETFund.

"As I have always said to our people, whenever we request for something from TETFund, they usually surprise us. Now, we are talking about the gift of a new bus and the ES has introduced the issue of monitoring. We have our independent monitoring group but not approved by him. According to his remarks, we are now empowered to monitor projects in our schools. I want to assure him that we will do our best to see that the contractors do the right thing because we have students that can work from morning till night, monitoring them."

The President of the students' body however tasked the ES to ensure that sanctions are meted to erring contractors to serve as deterrent.

"There should be disciplinary measures against any defaulting contractor so that students doing the monitoring and bringing reports to you would be encouraged to do more. We would be proud to do that. We will forward the names and contacts of the monitoring group to TETFund."

Adding: "The presence of TETFund is glaring in majority of our tertiary institutions. Like I said earlier, we have our independent monitoring committee that goes round, and we realised that part of the education stakeholders that is doing perfectly well is TETFund and we commend them for that."

He said that the bus will help the students' body in carrying out its activities and make it more efficient in its mandates.

Also, to further enhance standard of education in Nigeria, Barambu said that there was need for TETFund

to do more interventions, especially in the area of sponsoring lecturers for further studies by way of expanding the number of opportunities granted unto them so that they would be better equipped to impact knowledge.

Balancing TETFund's interventions with demands by the Academic Staff Union of Universities (ASUU) for better funding of education in the country, NANS' President said that there had been an interface between the body and President Tinubu, and that the students have explained the need for government to increase funding opportunities for TETFund to enable it expand its interven-

"If you visit any public tertiary institution, remove TETFund project and see what would be left. Yet, while we thank TETFund for all that it is doing, we still need more. That is what we told Mr. President. Yes, TETFund is doing so well but government should support it to do

To TETFund, NANS expressed its gratitude for the support. The body however urged ASUU and the Federal Government to be mutually respectful to their agreements.

"There are things that require political solution. Even though it is their right, ASUU still needs to shift ground for national peace", NANS held.

subsidy regime is a scam and has not in any way benefitted the so-called 'vulnerable' citizens.

He said it makes no economic sense to inject cash in the form of palliatives into an economy that is already beset with unending inflationary pressures.

"It is worthy of note that previous palliatives had proved not to palliate the economic woes of the citizens. In reality and within the context of our current economic situation, the majority of Nigerians are vulnerable, especially organised businesses."

National President of the Trade Union Congress (TUC), Festus Osifo, who kicked against the move, said any palliative payment by the Federal Government must be in line with the agreement reached with labour in line with the technical committee meeting.

The TUC Deputy President, Dr. Tommy Okon, also queried how the government would determine those who are to benefit from the data deficit in Nige-

"What the government has done is an ambush and gone beyond what it is supposed to be and probably decided on what to do. Who told them that that is the amount required to fund the recommendation of the commit-

"So if they have a budget already, it means that they have activities and if they do, who generated them? It means that the committees are not relevant and means the government is not confident and does not trust in the process which they have already initiated," he said.

Intrigues, issues ahead of Imo governorship election

Major political parties in Imo State are battling internal crises, with uncertainties as November 11 governorship election draws nearer.

PART of the hurdles appearing in the way of political parties and candidates of the All Progressives Congress (APC); the Peoples Democratic Party (PDP), and the Labour Party (LP) in the November 11 governorship election in Imo State, include the insecurity ravaging the state, crisis within the parties, as well as challenges surrounding political campaigns.

So far, all the political parties interested in the election have concluded their primaries and have continued to advance their engagements to deepen their acceptance and shore up their support base.

While all eyes are on the election to achieve transparency and deepen democratic tenets, the aforementioned issues among others, appear to be unsettling the parties and digging deep holes on their chances and participation

Last week, LP raised serious doubts over the sanctity of the election following rising insecurity in the state. National Vice Chairman of the party in the southeast, Chief Innocent Okeke, who expressed worries that insecurity had dislocated several residents, stated that unless something drastic was done to build confidence, many residents would not participate in

He specifically cited some local governments in the state such as Oru East, Oru West, Oguta, Orlu, Okigwe, Orsu and Njaba, saying that they have become "ghost towns" following incessant attacks created by state and non-state actors. He explained that the insecurity would go a long way to chart the path of the election. Okeke, who insisted that the insecurity may be utilised to the advantage of the party in power in the state, requested a deliberate action to solve the issue before the election.

Credence was lent to his position when the Peoples Democratic Party (PDP) in the state raised similar sentiments, alleging that, "half of Imo territory is under the occupation of bandits and kidnappers among other state actors who levy death upon the people". PDP added that most farmers have abandoned their farmlands, explaining that the development was increasing poverty, starvation and crimes in

It was apparently against these worries that a two-day stakeholders meeting that was held in the state recently advised the residents to embrace and encourage efforts that would guarantee credible and peaceful conduct of the November 11 election in the state.

The meeting organised by the Kukah Centre in partnership with Imo State Independent Statebased Peace Architecture (ISPA) had canvassed active participation in the election and advised citizens to eschew sentiment and resist attempt that would jeopardise efforts for continued peace and unity of the state, as well as ensure that credible leaders govern the state.

But while it is acceptable that insecurity ravages the southeast states and that Imo state is not insulated from it, perhaps, LP is also bored by the governorship primary that has enthroned two persons for the sole ticket of the party. Former Senator Athan Achonu and Chief Joseph Ikechukwu Ukaegbu are locked in contention over the governorship ticket of the

Achonu, who represented Imo North Senatorial District, had emerged from the April 15 governorship primary conducted by Abia governor, Alex Otti, after beating the likes of Lincoln Ogunewe, Martin Agbaso, Basil Maduka, Ibe Ike, Sam Amadi, David Mbamara, Kelechi Nwagwu, Charles Agomuo and Ndidi

A day after his emergence, a faction of the party held another primary superintended by Mohammed Alkali where Chief Joseph Ukaegbu emerged. His emergence however, did not deter the Independent National



Electoral Commission (INEC) to continue to relate with Achonu, on the ground that his (Achonu) emergence followed due process.

Ukaegbu was said to have gone to court. Last week, his petition in court made headlines and threw more confusion in the party following a ruling by the federal high court sitting in Bayelsa State that allegedly held that he is the authentic governorship candidate of the party. The ruling was said to have invalidated Achonu's election.

The Court was said to be responding to similar cases filed by contestants from Bayelsa and Kogi states in the primaries conducted by the national leadership of Julius Abure while he was on suspension from office. The Judge was reportedly said to have faulted and nullified the primaries he conducted while upholding that of the LamidiApapa-led faction of the

While Ukaegbu had gone to town with the claim of being the "authentic" governorship candidate of the party, his supporters had threatened Achonu with jail terms should he continue to campaign anywhere in the state.

But the Abure-led national executive in his response to the alleged ruling warned members of the public to be wary of the activities of those he described as "political and judicial pranksters."

A statement by the Acting National Publicity Secretary, Obioralfoh likened the judgment to what transpired in Kano State where they procured against the LP and Abia State then governor-elect, Alex Otti, adding that the group has not relented on their evil mission hence the purported judgment.

The judgment did not give any order to INEC or any other institution, affects the candidacy of Senator AthanAchonu; mention Senator AthanAchonu as he was not even a party in the matter, affirm Ukaegbu as the candidate or change any status quo already existing before the judgment.

"In law when a court says it has no jurisdiction and dismisses a matter as this one has been

means the matter is dead in the water", Ifoh party. Endless strife, mindless wars and erosion stated. It also dismissed threats against Achonu's campaigns in the state

While the LP battles with her internal issues, the political quagmire in the PDP in the state has continued to increase since the National Secretary of the party, Samuel Anyanwu clinched the governorship ticket of the party to contest in the election.

The squabbles in the party got to its head in the morning of June 18, when seven members of the state working committee announced their withdrawal of their membership from the party, accusing Anyanwu of not working in the interest of the party in the state.

Addressing a press conference at the party's secretariat in Owerri, the state capital, Collins Opurozor, who until then the state Publicity Secretary of party stated that the candidate of the party for the November 11 governorship election in the state, Samuel Anyanwu, did not have what it takes to govern the state.


He said himself, the secretary of party Ray Emeana, the youth leader, Greg Nwadike; the deputy state chairman, Martin Ejiogu; the woman leader, Maria Mbakwe; Treasurer, Josiah Eze; andVice Chairman, Orlu Zone, Chibuisi Obidohave resigned from their positions and equally dumped the party.

Opurozor had said during the press conference attended by all those that resigned: "Since 2020 when this Working Committee took over the administrative cockpit of the PDP in Imo State, we have evolved a tradition of being upfront with you as members of the Fourth Estate of the Realm about all issues that trouble our dear state. We have, through such interactions, inspired faith in a better Imo realised through good governance and democratic norms.

"It is necessary we remind you that in the last three years, this Working Committee has built Imo State. To enable the party to realise its due opposition and opponents. promise of being a truly democratic entity, we Sources stated that the party had capitalised on nvisioned the need to expand the internal an opposition. No other political party has attained this feat in Nigeria.

"More so, we institutionalised the culture of accountability in party administration, and demonstrated a readiness to govern and reform Imo.

These members have since joined APC, even as they stated that the floodgate of decampment had been opened and would soon "get to a stage where only Senator Anyanwu will be left with the PDP in Imo State."

Anyanwu has however remained upbeat, insisting that their exit was part of the ploy to undermine the party in the state and plunge it into crisis to pave way for the APC. He has insisted resignation from their positions, as well as that there was no going back on recovering the state for the PDP using the coming election.

PDP returned to power in the state using the 2019 general elections with the election of EmekaIhedioha; but the pronouncement of the Supreme Court a year after rubbed it of the opportunity with the incumbent governor, Hope Uzodimma of the APC as the beneficiary. Ihedioha is considered a strong force in the party. As of the moment, it is still unclear the role he is playing, especially with the defeat of AtikuAbubakar in the presidential election of

Nonetheless, even with their power of incumbency and allegation that it is poised to reap from the festering insecurity, all seems not to be well with the APC. Part of the challenge the party and its candidate, Uzodimma are faced in the election is the near loss of confidence by the people, which was blamed for insecurity and poor performance in the state.

The Guardian gathered that following the ravaging insecurity in the state with the attendant implication on the economy, living conditions are becoming unbearable for the people, thereby raising so much opposition to the re-election of the governor as many believe that if reelected as governor would further emasculate the state. Furore as Enugu tribunal orders Labour Party to inspect BVAS

TONTROVERSY has erupt-⊸ed in Enugu State, followthe Governorship Election Tribunal's order authorising the Labour Party (LP) to inspect the Bimodal Voter Accreditation System (BVAS) used for voter accreditation in the March 18 governorship election.

The order followed an application by LP's governorship candidate in the election, Chijioke Edeoga, to the tribunal to be allowed access to the facility to enable him prosecute his petition against the declaration of Peter Mbah of the Peoples Democratic Party (PDP) as winner of the election.

The exercise, which was to be

electoral National Commission (INEC) headquarters, in Enugu, was thwarted midway, following disagreement between LP members, officials of the commission and some chairmen of other political parties in the state over modalities.

Briefing journalists after the botched exercise, the LP accused the commission of deliberately refusing it to carry out the tribunal's order, while the commission and members of other political parties, on hand, accused the LP team of attempting to "tamper" with the BVAS

The LP members, led by its deputy governorship candidate, Dr. John Nwokoabia, said they arrived at the premises of the commission by 9:00 a.m. with their forensic expert, but were allegedly told not undertake the exercise without agreeing with

Addressing journalists, the spokesman of the Edeoga Campaign Organisation, George Ugwu, accused INEC of partisanship in an exercise where it was supposed to be the umpire, calling on wellmeaning Nigerians to advise the electoral body to toe the path of honour by respecting the court order.

Ugwu said: "We do not understand what these people are doing. As you can see, we arrived here expecting to inspect the BVAS machines. How INEC invited the PDP and insisted they would have to agree before we carry out the inspection is what we don't understand. This is the height of impunity, and we want Nigerians to bear witness that the commission is not only showing unhindered partisanship, but also disobeying an order of the tribunal to frustrate our search for justice."

But, chairmen of other political parties, who also briefed journalists, insisted that the exercise was aborted because the LP team attempted to tamper with the BVAS machines, warning that such "rascally behaviours" could set the state on fire.

NITP urges Abia govt to fund physical planning, domesticate building code By Victor Gbonegun

While stressing that he has no security vote to draw from as the chief security officer of the state, the governor said he manages to adopt both kinetic and non-kinetic strategies to deal with security challenges as much as the law permits him.

He stressed the need for

governors to be given more latitude to perform their functions effectively.

The governor pointed out that the people of the South East, like other regions, deserve the Federal Government's support to enable them live their daily lives and go about their busi-

He, however, did not give details of what the South East

leaders would be demanding from the President when the meeting holds, but lamented that non-state actors have utilised fear. indiscriminate killing and brigandage to enforce an illegal sit-at-home in the region.

According to him, it has become an issue of "perception management," pointing out that international diplomacy, which is also part of the solution, is beyond the purview of governors.

EFCC arrests 13 Chinese over illegal mining in Kwara

OFFICERS of the Economic and Financial Crimes Commission (EFCC) have arrested 13 Chinese nationals over offences bordering on illegal mining activities in Ilorin, Kwara State.

The offence is contrary to, and punishable under Section 1(8) (b) of the Miscellaneous Offences Act Cap M17, 1983.

A female and 12 male Chinese were arrested on Wednesday, July 12, 2023, at Government Reserved Area (G.R.A.), Ilorin, following credible intelligence about their activities, including illegal mining and non-payment of royalties to the Federal Government as required by law.

The suspects are identified as Guo Ya Wang (36), Lizli Hui (42), Guo Jian Rong (36), Lizh Shen Xianian (37), Lishow Wu (26), Guo Pan (38), Lia Meiyu (53), Guo Kai Quan (36) and Lin Pan (50).

Others are Ma Jan (38), Wendy Wei Suqin (31), Li Zhinguo Wei (29) and Xie Zhinguo (53).

Prior to their arrest, investigations on illegal miners in Kwara revealed that the operators had different illegal mining sites in almost all the 16 local councils of the state. Upon interrogation, the suspects confessed to be workers of a Chinese Company in Ifelodun Local Council. It was gathered that the company was producing marble and selling within Nigeria.

Tunisian clubs get highest share from Qatar 2022 FIFA Club Benefit programme

By **Christian Okpara**TUNISIAN clubs, which provided the highest number of players from Africa at the Oatar 2022 World Cup, will re-Benefit programme.

Represented by Esperance, Club Africain and Etoile du Sahel at last year's World Cup. the Tunisian clubs will share \$1, 494, 734 from the \$4, 569. 981 that accrued to African clubs with players at the Copa du Mundo.

Moroccan clubs will get \$1. 437, 244, while Egypt, which did not feature at the World Cup, but had players from Tunisia that participated in the competition, are due \$650,000.





APC and the challenges of managing victory

Our political parties have poor records of appreciating the architects of their electoral fortunes. It is part of the tragedy that has led to the lack of culture and tradition in our political parties as necessary institutional pillars of democracy. Here are some pieces of evi-

The late Chief Solomon Lar, first national chairman of PDP, led the party to victory in the critical transitional general elections of 1999. The presidential election produced Chief Olusegun Obasanjo, who made history as the first military ruler in the country to return as a faux democrat and a civilian president. The greatest beneficiary of that election did not thank Lar for his leadership. In gratitude, Obasanjo made Lar's tenure history.

The president then picked Chief Barnabas Gemade but dropped him before the 2003 general elections. Chief Audu Ogbeh succeeded Gemade and led the party to victory with Obasanjo's re-election in the 2003 general elections. In gratitude, Obasanjo gave Ogbeh the same treatment he meted to Lar.

Chief John Oyegun was the first national chairman of APC. Under his leadership, the party won the general elections of 2015. Major-General Muhammadu Buhari, the man with the longest quest for political power in our country so far, got what he wanted and became president. He did what Obasanjo did - a former military dictator turned a faux democrat. But whatever Oyegun did to put the retired general where he had always wanted to be, did not save him. Buhari muscled him out as national chairman of the party in the firm tradition of political ingratitude.

Adams Oshiomhole, the former labour leader, and two-term Governor of Edo State, succeeded Oyegun as national chairman of the party in 2018. He too led the party to victory and Buhari was re-elected for a second and final term in the 2019 general elections. And then his battle for survival began. He fought the governors but by 2020, he knew that the game was up. At the instance of Buhari, ostensibly acting to save the party that had already begun to haemorrhage, the national executive committee of the party gave him the red card. He stepped down as national chairman.

The Governor of Yobe State, Mai Mala Buni, was appointed interim leader of the party and something Caretaker/Extraordinary Convention Planning Committee. He was given a six-month mandate to put the house of the party in order. It proved a difficult task for him because the party at all levels was torn by internal crises and lack of internal democracy, the bane of our political parties in general. The party faced the increasingly dark prospects of the sun setting on it at noon. Buni was taking the party down the slope of irrelevance.

The party leaders stepped in. On September 14, 2022, it constituted a nine-member national reconciliation committee to patch up things and save the party from the clear danger of a short shelf life. Senator Abdullahi Adamu, a

ranking senator, was appointed chairman of the committee. The party leadership charged his committee with three assignments, the most critical to the party being to "conduct appropriate engagement between identified groups in each state where there are disputes with a view to bringing about genuine reconciliation and establishing lasting peace and unity in the party.'

An onerous task, given the state of the party at the state level.

Buni swore in the committee on October 14, and it set to work. The committee found that matters were much worse for the party at the state level than its leaders appreciated. It had been polarised into irreconcilable warring factions - a clear and obvious danger to it retaining its place in Aso Rock in the 2023 general elections.

As I pointed here in an earlier column, "Adamu is a savvy politician with the unusual gift of quickly seeing and appreciating political problems. He has a demonstrated knack for throwing himself into assignments, heart and soul, because it is always important for him to leave his size 11 shoe size footprints along whatever path he passes through in his political career." He needed no one to tell him that the fate of the party would be determined by the work of his committee.

With his single-minded commitment, he pulled the chestnuts from the fire. He did what other party leaders feared would never happen,

i.e., make APC one cohesive political family again, given the deep fissures and the frayed nerves among the leaders and the frustrated members of the party. The party had begun to bleed badly. He reconciled the warring factions to prepare the party for this year's transitional general elections.

This knack propelled Adamu forward and upward. Buhari and the party leaders decided he was the right man to implement the findings and the recommendations of his reconciliation committee. He was elected national chairman of the party on March 26 last year. Some element of poetic justice was at play here. Adamu, never afraid of taking on tough tasks, left the Senate to take on the more challenging

task of saving his party. He staked his integrity on doing almost the impossible - leading APC to victory in the 2023 general elections.

He was true to himself and to his party and, as the common saying goes, he delivered against certain odds in the nomination process that produced Asiwaju Bola Ahmed Tinubu as the party's presidential candidate on June 8 last year. Jagaban went on to win the presidential election last February. Adamu pulled the party from the jaws of certain defeat that stared it in the face. Given the record of Buhari's non-stellar performance in office, APC stood on shaky moral grounds to ask the electorate to retain it in power in the 2023 general elections. Those who predicted its defeat were not being mischievous. But the rest is now history.

The party has now entered a new phase of challenges as critical, if not more so, than its winning the elections. I suppose this is the time for the leaders of the party, including the president, to begin the task of managing their victory. Winning is a difficult task but sustaining victory is even more complex than that.

The atmosphere is being polluted by the lethal combination of weaponised fake news, conspiracy theories, ignorance, and the sheer inclination by the online and social media to mislead, misinform and miseducate the public. We are in danger of being swamped by the combination of these blights that have distorted the noble mission of the mass media as a critical and important national institution. No one should think this is a child's play.

The talks about the president's alleged frosty relationship with Adamu are, of course, lies. But lies, once sold to the public takes on lives of their own. The liar has a purpose in suggesting that that there is a frosty relationship between Adamu continuing in his current position in the party. It is an unholy attempt to drive a wedge between him and the president. There is always a purpose to all madness.

Tinubu is not Obasanjo, and he is certainly not Buhari. He should not invite himself to walk along their path. His administration has much to gain from a stable, cohesive, and united APC. He would be unfair to himself were he, through acts of insouciance, allow the party to regress to what it was before Adamu and his committee responded to the challenges of saving it from itself. A crisis fomented at this time in the life of the Tinubu administration would also affect the president's capacity to chart a new path for the nation. He cannot afford to be distracted from the path he has mapped out for himself as president. Our faith in his avowal to renew the nation is hinged on his capacity to think differently and act differently.

This is not about saving Adamu's job. It is $about\, stability\, in\, the\, ruling\, party\, and\, what\, the$ nation stands to gain from the president and the party managing their victory so the country could renew its faith in itself. A stable APC will discharge its duty as the custodian of the governments elected on its platform. It will police how its servants in government fulfil its manifesto, being its contract with the people.
