It is my pleasure to extend a warm welcome as you begin your journey at the EUI.

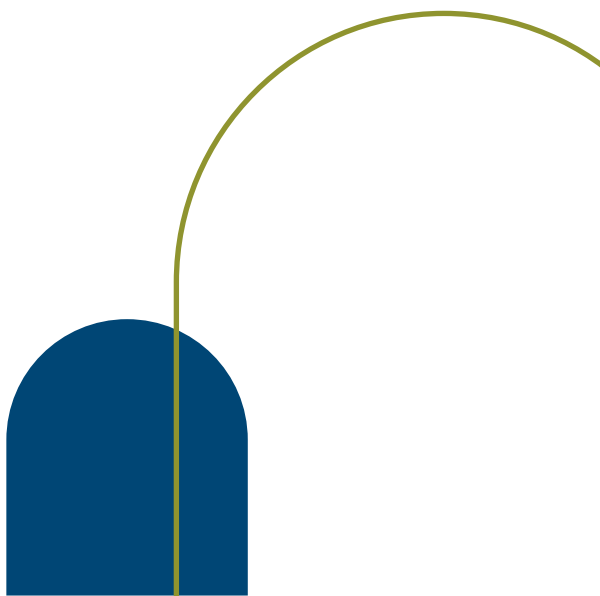
This booklet is designed to provide you with practical guidance to facilitate your arrival at the EUI and help you settle into life in Florence and Fiesole.

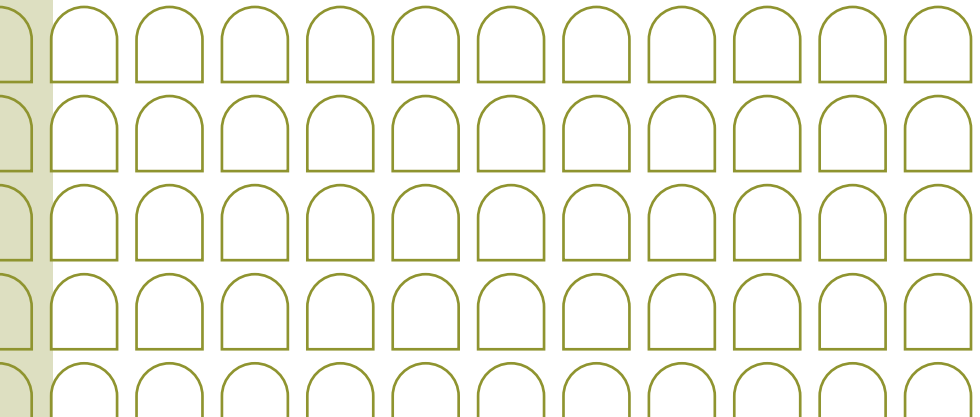

Florence is one of the most important cities in Italy for culture, history, and business. The city is well located in the centre-north of Italy, which allows for fast connections to other key cities across the Italian peninsula and abroad.

Airports

Florence has its own airport (Aeroporto di Firenze-Peretola "Amerigo Vespucci") which is 7.8km from Badia Fiesolana and 5.2km from the city centre. The airport is served by bus and tramway services.

Other close airports include Pisa (77km from Florence city centre) and Bologna (106km from Florence city centre), which are both connected to Florence via bus and train services. Pisa and Bologna airports are served by traditional as well as low-cost airlines, while Florence offers fewer low-cost flights.

Train Links

Florence has seven key train stations:

Firenze Santa Maria Novella (Firenze S.M. Novella) is the main central station for the city of Florence. Links from this train station include suburban and regional areas, as well as national and international destinations.

The closest train station to Badia Fiesolana is **Firenze S. Marco Vecchio** (2.3km from Badia Fiesolana); this local station is located on the train line that connects Firenze Santa Maria Novella with rural areas north of Florence, including Vaglia, San Piero a Sieve, and Borgo San Lorenzo.

Other relevant train stations in the Florence area include:

Firenze Campo di Marte; Firenze Statuto; Firenze Rifredi; Firenze Castello; Firenze Rovezzano.

MOVING TO FLORENCE

Moving to Florence entails several practical, legal, and administrative procedures. Please read the following information carefully, and for any specific questions, do not hesitate to contact us.

EUI CONTACTS FOR VISA AND RESIDENCY ISSUES

Non-EU/EEA members of the EUI who require a visa to travel and/or subsequently reside in Italy should file their request for a special Visa (**Type D - Mission**) with the relevant Italian Embassy/Consulate. The EUI assists concerned EUI members by providing them with complete information and issuing special letters of visa support and additional documentation to be presented to the Italian Embassy/Consulate. Non-EU/EEA dependents (spouses/children) accompanying EUI members during their stay at the EUI may also receive a letter of visa support from the EUI.

EU CITIZENS

Before departure

No visa is required.

Upon arrival at the EUI

Members of the EUI staying in Italy for 12 months or longer may request a special ID card issued by the Italian Ministry of Foreign Affairs, referred to in this document as the 'MOFA card'.

¹ Please be informed that traineeship contracts are not eligible for EUI visa assistance, permit of stay assistance, nor for MoFA ID Cards

The MOFA card is issued only after your official registration/entry into service at the EUI and must be requested within 30 days after the start date of your affiliation with the EUI. To speed up the application process for the MOFA card, please supply the necessary documents well before your arrival:

- A scanned copy of your passport
The passport must be valid for at least 6 months from the application date. Passports valid for less than 6 months cannot be accepted.
- A digital passport-type photo

The Institute is responsible for applying for the MOFA card on your behalf, and for issuing it to you once it has been received from the Italian Ministry of Foreign Affairs. According to your status, you are advised to contact the relevant service for all the necessary instructions and details.

If you are staying in Italy for more than 3 months and you are not entitled to receive an MOFA card, you may register your residency with your local town hall registry office (Comune, Ufficio Anagrafe). Please check the section on [Residency Registration](#).

NON-EU CITIZENS

Before departure

You are required to check if you need to apply for a visa to travel to Italy.

The EUI provides you with all the relevant information and a letter to support your application for a long-term Mission Visa. This should be submitted to the Italian Embassy or Consulate in your country of residence.

Note: You should apply for a visa in the 90 days preceding your arrival and, if you are expected to arrive in September, certainly by the end of June.

Upon arrival at the EUI

A visa entitles you to enter the Italian territory but NOT to reside in Italy. After arriving in Italy, there are further procedures to complete depending on the length of your stay and eligibility for an MOFA ID Card.

Stay of 12 months or longer

For non-EU citizens staying for 12 months or more and in possession of a long-term mission visa, the Italian Ministry of Foreign Affairs (Ministero degli Affari Esteri) issues a special ID card (MOFA card) which exempts non-EU citizens from having to apply for a Residence Permit (Permesso di soggiorno). The MOFA card is issued only after your official registration/entry into service at the EUI and must be requested within 30 days after the start date of your affiliation with the EUI. To speed up the application process for the MOFA card, please supply the necessary documents well before your arrival:

- A scanned copy of your passport
The passport must be valid for at least 6 months from the application date.
Passports valid for less than 6 months cannot be accepted.
- A copy of your visa
- A digital passport-type photo

The Institute is responsible for applying for the MOFA card on your behalf, and for issuing it to you once it has been received from the Italian Ministry of Foreign Affairs. According to your status, you are advised to contact the relevant service for all the necessary instructions and details.















Non-EU nationals who are not eligible for, do not wish to hold or renounce their MOFA ID Card must apply for a Residence Permit and residence registration. For further information, please check [Residence Permit](#) and [Residency Registration](#).

Stay of less than 12 months

Non-EU citizens staying less than 12 months are not eligible for the Italian Ministry of Foreign Affairs ID card (MOFA card) and must apply for a Residence Permit (see below '[Residence Permit for Non-EU citizens](#)'). They may register their residency with the local town hall registry office (see the section '[Certificate of Residency](#)'). For further information, please check [Residence Permit](#) and [Residency Registration](#).

EU CITIZENS

Before departure

No visa is required.

Upon arrival at the EUI

- Immediate family members of administrative, teaching, and academic staff staying 12 months or longer are also entitled to receive the ID card issued by the Italian Ministry of Foreign Affairs (MOFA card), as long as they have no income of their own from present or previous gainful employment. Dependent children under the age of 21 can also obtain the card. On presentation of supporting documents, the card is also issued to any cohabitant dependent child aged from 21 to 24 only if they are actively attending a full-time university course.
- Immediate family members of researchers and fellows are not entitled to receive the ID card issued by the Italian Ministry of Foreign Affairs (MOFA card), and therefore, the only way for them to certify their stay in Italy is to register their residency with the local authorities (town hall, see the section '[Certificate of Residency](#)').

NON-EU CITIZENS

Before departure

You are required to check if your accompanying family members need to apply for a visa to travel to Italy.

The EUI provides you with all the relevant information and a letter to support your spouse's and children's visa applications. Please note that the EUI is not in a position to issue visa supporting documents for partners who are not married or not registered in a civil union. These documents should be submitted to the Italian Embassy or Consulate in your country of residence.

Upon arrival at the EUI

A visa entitles you to enter the Italian territory but NOT to reside in Italy. After arriving in Italy, your family members must complete further procedures to settle residency obligations.

- Family members (spouse/children) of administrative, teaching and academic staff, researchers and fellows staying 12 months or longer may be entitled to receive the ID card issued by the Italian Ministry of Foreign Affairs (MOFA card) and, as such, may be exempt from having to apply for a Residence Permit if they fulfil the following eligibility requirements, set by the Italian Ministry: They must not be in work, they must be dependent on the EUI member, and they must be accompanying them in Florence.
- All other family members not eligible for the MOFA card must apply for a Residence Permit or file a Declaration of Presence (see below) within 8 working days of arrival (see the section '[Permits of Stay](#)').
- If your family members will stay in Italy for more than 3 months and are not entitled to receive the ID Card issued by the Italian Ministry of Foreign Affairs (MOFA card), they must also register their residency at their local town hall registry office. (see the section '[Residency registration](#)').

UPON ARRIVAL:

PERMIT OF STAY, RESIDENCY REGISTRATION

EUI MEMBERS and ACCOMPANYING FAMILY MEMBERS (SPOUSE AND CHILDREN) WHO DO NOT RECEIVE AN MOFA ID CARD

There are three types of documents for non-EU citizens: two for those staying for more than 90 days, and the other for those staying for less than 90 days.

Residence Permit (Permesso di soggiorno)

Non-EU citizens staying in Italy for more than 90 days and not eligible for the Italian Ministry of Foreign Affairs ID card (MOFA card) must apply for a Residence Permit (Permesso di Soggiorno) within 8 working days of arriving in Italy.

EC Long-term residency permit (Carta di Soggiorno) for foreign family members of EU Citizens

For stays longer than 90 days, non-EU family members of EU citizens can apply for the EC Long-Term Residency Permit (Carta di soggiorno) for foreign family members of EU citizens. To apply for an EC Long-term residency permit you will be required to provide supporting documents, including a certificate issued by the local Italian townhall confirming the EU family member has registered their address with them (i.e. residenza anagrafica). Declaration of Presence (Dichiarazione Di Presenza)

Non-EU nationals staying in Italy for up to 90 days and who are not eligible for the Italian Ministry of Foreign Affairs ID card (MOFA card) must submit a Declaration of Presence (Dichiarazione di Presenza) within 8 working days of arriving in Italy (entering visa-free). For non-EU citizens coming from countries that do not apply the Schengen Convention, the obligation to make a declaration of presence is satisfied through the application of a stamp or the USV sticker on the travel document at border control (entering with a visa).

The Italian Government charges a fee for the Permesso di Soggiorno and the Carta di Soggiorno, to be paid by the applicant. It does not charge a fee for the Dichiarazione di Presenza.

Assistance from Italy4You is provided in English, and the costs of the service for both the EUI member and their family members are covered by the EUI.

Please note: the administrative costs for Permesso di Soggiorno and Carta di Soggiorno are charged to the applicants.

Residency

Certificate of Residency (Certificato di Residenza)

The ID card issued by the Italian Ministry of Foreign Affairs (MOFA card) exempts holders from having to register their residency with the local authorities (Registrazione della Residenza Anagrafica with the Comune). The card can be used in all dealings and transactions requiring residency registration.

The MOFA card may not be held simultaneously with residency registration. EUI members who intend to register their residency with the local authorities must inform the Academic Service / EUI Welcome Office and return their MOFA card as soon as the residency registration has been finalised. EU citizens and non-EU citizens who do not hold an ID card issued by the Italian Ministry of Foreign Affairs (MOFA Card) and are staying in Italy for more than 90 days must register their residency at their local town hall registry office (Comune, Ufficio Anagrafe). Non-EU citizens need a valid Residence Permit (permesso di soggiorno) to apply for residency.

If you are planning to register your residency in Florence and are coming with your family, prior to your departure you are advised to obtain an international family book (libretto di famiglia), or certified copies of the relevant documents (marriage certificate, birth certificates for children); the Comune will require these documents to register you and your family's residency. All documents must be translated into Italian by a certified translator.

TAX CODE

During your stay in Italy, you will need a tax code (Codice Fiscale). This is mandatory for Italian and foreign citizens living in Italy, regardless of whether you pay Italian taxes or not. The only valid "Codice Fiscale" is the one issued by the Italian tax authorities. Obtaining the "Codice Fiscale" is free of charge. The Codice Fiscale identifies a citizen in all dealings with the Italian Public Authorities and Administrations. When living in Italy, you will need it to:

- Open a bank account;
- Buy a car or motor scooter;
- Re-register a vehicle;
- Sign any official contract, e.g. the lease for a flat;
- Take out an Italian insurance policy;
- Sign contracts with the gas, electric and telephone companies (including mobile phones);
- Ask for a medical check-up invoice;
- Sign any sort of work contract subject to Italian labour law, etc.

How to get a Codice Fiscale

The tax code may be requested through the Italian Embassy or Consulate in your home country. In this case, you will not need to present your documents once in Florence.

Alternatively, you may apply for a tax code in person once you are in Italy through the Italian income revenue authority (Agenzia delle Entrate):

Bring the original AND a copy of your passport or ID card. Non-EU/EEA citizens will also need to attach a copy of their Italian visa page and entry stamp (only for short-term visitors without a Residence Permit).

The EUI requests codice fiscale issuing on behalf of researchers and fellows arriving in September as part of the pre-registration procedure. Concerned EUI members will receive detailed information by May.

Please note that the process of obtaining the tax code (codice fiscale) can take up to a week after the application (with the relevant form and passport) has been submitted. In case of problems, please contact Welcome@eui.eu

IMPORTING PETS, CARS, AND PERSONAL BELONGINGS

EU CITIZENS

If you wish to import personal belongings to Italy, there are no specific procedures or formalities to follow. There are no restrictions on the importation of personal belongings, electrical goods, computers etc. into Italy, provided the goods were purchased in the EU.

Note: If you bring articles purchased duty-free outside the EU, and for which duty and/or value-added tax has not been paid in one of the EU States, they will be subject to Italian import duty.

NON-EU CITIZENS

Non-EU nationals, wishing to import a small quantity of their personal belongings, including books, are recommended to bring them as accompanying luggage. There are no particular procedures to bring a small quantity of personal effects. You will need your passport (and visa, if required) and a list of the items you bring. We strongly advise against shipping your belongings separately. Whatever the quantity, we urge you to bring them as accompanying luggage so that you can settle matters personally and directly with customs on arrival in Italy.

Non-EU administrative staff and faculty members who need to import larger quantities of goods are entitled to import their belongings duty-free.

If you wish to import a larger quantity of goods, you must submit a request for duty-free importation following the procedure and deadlines below:

1. To complete all formalities, you must submit the required request forms to the Welcome Office at least three months before the expected arrival of your goods.
2. Eligibility for duty-free import expires one year after your entry into service, in accordance with the agreement between the Italian State and the EUI. Duty-free import is not possible if the goods arrive at customs more than one year after your entry into service or in separate shipments. You must organise a single shipment which arrives before the deadline, as the EUI can only file one exemption request before the deadline.

It is the responsibility of the EUI member to ensure that both the required forms and goods arrive before the relevant deadlines.

Please note that the EUI Welcome Office can request duty-free importation only for goods entering through an Italian customs office. If you plan to import your goods through another EU Member State, you should consult your removal company regarding any duty or VAT charges (if applicable).

Vehicles and driving licences

Non-Italian citizens residing abroad can drive a vehicle with foreign license plates for up to 1 year after entering Italy. If you register your residency in Italy (residenza anagrafica), as an EU citizen, you must have your vehicle registered and issued with an Italian license plate within a year of taking up residency; if you are a non-EU citizen, this must be done within 60 days from when you take up residency. Failing to do so will result in a hefty fine and possible confiscation of the vehicle.

If you hold a driving licence issued by an EU or EEA country, you may use it to drive in Italy under the same conditions as Italian licence holders, unless an exception applies (e.g. your driving licence has been obtained by conversion of a licence issued by a non-EU country with which Italy does not have mutual agreements on the conversion of driving licences). You are responsible for

checking the complete set of regulations applicable to your case. You may find additional information on the Italian Ministry of Transportation website and the [EU website](#).

If you hold a driving licence issued by a non-EU or EEA country: According to applicable regulations, non-EU members of the EU, who have not registered their residence in Florence (*residenza anagrafica*) and hold a valid Special ID Card issued by the Italian Ministry of Foreign Affairs ([MOFA ID Card](#)), may drive in Italy with their foreign driving licence, provided that it is accompanied by a full official translation into Italian, and their MOFA ID Card. The Italian Ministry of F.A. has specified that the official translation of the foreign licence may be issued either by:

- the diplomatic or consular representation of the State that issued the driving licence; or
- an official translator or interpreter who certifies the accuracy of the translation under oath before a civil registrar (normally a *Cancelliere del Tribunale*).

EUI members who wish to register their residence (*residenza anagrafica*) should check how long they can drive in Italy with their non-EU driving licence. Normally, you can drive with a non-EU driving licence for a maximum of 1 year from acquiring residence in Italy, after which you must either exchange your driving licence for an Italian one (if possible) or obtain an Italian one by taking the required qualification tests. Those who need to convert their licence may find information on the [Italian Ministry of Transportation's website](#).

Bringing your pet to Florence

Common pets like cats and dogs are usually widely accepted in cafes, restaurants and shops, with specific regulations from businesses or local councils (e.g. use of leashes).

To bring your pet to Italy, you must follow the guidance and regulations of the Italian Ministry of Health (Ministero della Salute).

To bring your dogs, cats and ferrets to Italy from EU countries, plus selected non-EU countries, you must have:

- A European Passport for your pet
- Anti-rabies vaccination certificate

To bring your dogs, cats and ferrets to Italy from third countries (non-EU and not in the selected list), you may require your pet's health certificate attesting anti-rabies and any other relevant vaccination, as well as reporting the execution with favourable results of the rabies post-vaccination.

Please read the [webpage of the Italian Ministry of Health](#) on this for full details on bringing your dogs, cats, ferrets or other pets to Italy.

Please note that the EUI cannot provide assistance with the import of pets.

Buying a new or used vehicle in Italy

If importing your car is not an option, you may consider buying a car or leasing one.

If you wish to buy a new or a second-hand vehicle, you will need:

- Passport or national ID card;
- [Codice Fiscale \(Tax Code\)](#);
- [Certificato di Residenza \(Residency Certificate\)](#);
- [Permesso di Soggiorno \(Residence Permit\)](#) when applicable.

New and used vehicles must be registered and issued with Italian plates. Registration is not free of charge and may be quite expensive.

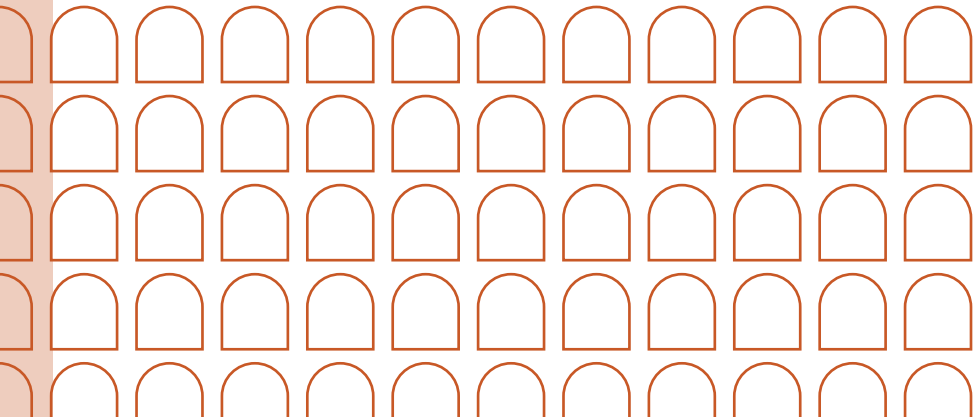
If you buy a vehicle from a car dealership, they will take care of the registration procedure. All expenses related to the registration of the vehicle must be paid directly to the car dealership.

If you buy a used vehicle from a private owner, you must complete the procedures for registration and transfer of ownership. If you hold an ID card from the Italian Ministry of Foreign Affairs (MOFA card) and wish to purchase a vehicle (new or second-hand), please contact the EUI Welcome Office for more information.

HOUSING

The EUI Housing Office organizes the allocation of the EUI residential apartments at Ponte alla Badia (PAB) and Pian del Mugnone (PDM), and Fiesole. It also provides, the Florence Housing Service (FHS), assistance to all members of the EUI community in finding long- and short-term accommodation in the private market in and around Florence.

EUI RESIDENTIAL ACCOMMODATION

The EUI owns 71 apartments, and rents 4 additional apartments, which are available on a 12, 24, or 36 month basis or for shorter periods (no less than 1 month). They are located near the Institute.

PAB Flats: 60 completely furnished apartments with air-conditioning, communal laundry, WiFi connection, parking, outdoor picnic and BBQ area. Located at Ponte alla Badia, via Faentina 386, Florence, 300 metres from the Badia Fiesolana

The PAB Flats offer four different types of apartments, all of which have a built-in kitchen equipped with electric stove with four burners and oven, washbasin with dish drainer and dishwasher, top-freezer refrigerator, extractor fan and wall cupboards with a complete kitchenware set (plates, glasses, cups and cutlery):

> **Type A1:** average size 50sqm, with 2 single bedrooms, living room, 1 bathroom. Each single room has a second pull-out bed, making it possible to comfortably have two single beds or a double bed.

16 apartments are on the ground floor, 16 on the first floor and 6 on the second floor.

A1 apartments can be shared by 2 single tenants or rented by a couple / family.

> **Type A2:** average size 50sqm, with 1 double bedroom, living room, 1 bathroom.

8 apartments are located on the second floor, 1 on the ground floor.

A2 apartments can be rented by a single tenant or a couple (no sharing).

> **Type A3:** on 2 levels, located on the ground and first floor, average size 55sqm. Downstairs: living room with built-in kitchen, half-bathroom; upstairs: 2 bedrooms (1 double, 1 single) and bathroom. Each single room has a second pull-out bed, making it possible to comfortably have two single beds or a double bed.

9 apartments, available to share by 2 single tenants or to rent by a couple / family

> **Type A4:** on 2 levels, located on the ground and first floor, average size 62sqm. Downstairs: living room with built-in kitchen, a study, half-bathroom; upstairs: 2 bedrooms (1 double, 1 single) and bathroom. Each single room has a second pull-out bed, making it possible to comfortably have two single beds or a double bed.

4 apartments, available to share by 2 single tenants or to rent by a couple / family

PDM Flats: 11 completely furnished apartments with WiFi connection, communal laundry, and parking. Located at Pian del Mugnone, via Faentina 94b, Fiesole. The flats are located close to n. 21 bus stop and are regularly serviced by the EUI Shuttle bus.

The n. 21 bus has a reduced frequency and the service stops at 9:30pm, therefore a private means of transport is warmly recommended.

The PDM Flats offer three different types of apartments, all of which have a living room with built-in kitchen equipped with

a basic kitchenware set (plates, glasses, cups, and cutlery), washbasin and dishwasher, stove and oven, a large balcony, and heating system:

> **Type B1:** 58sqm, located on the first floor (n. 1, 2, 5 & 6) and on the second floor (n. 3, 4, 7 & 8). Each apartment has 1 double and 1 single bedroom, living room with built-in kitchen and bathroom.

8 apartments to be rented by 2 single tenants or to rent by a couple/family

> **Type B2:** 58sqm, located on the first floor (n. 9 & 10), each with 2 single bedrooms, living room with built-in kitchen and bathroom. Each single room has a second pull-out bed, making it possible to comfortably have 2 single beds or a double bed.

2 apartments, available to share by 2 single tenants or rent by a couple / family

> **Type B3:** 1 shared apartment of 106sqm, located on the second floor, with 2 single bedrooms, 2 double bedrooms, living room with built-in kitchen and 2 bathrooms. Each single room has a second pull-out bed, making it possible to comfortably have two single beds or a double bed.

Both complexes are connected to other EUI buildings by the EUI Shuttle bus. The apartment is available to share by 4 single tenants, or rented by a large family.

Fiesole Flats: 4 completely furnished apartments with partial air-conditioning, in-home laundry, WiFi connection, and communal garden. The apartments are structured on multiple levels, without an elevator. Located in Piazza Mino, Fiesole, 1.5 km from the Badia Fiesolana, the Fiesole Flats offer four different types of apartments, all of which have a built-in kitchen equipped with electric stove with four burners and oven, washbasin with dish drainer and dishwasher, top-freezer refrigerator, extractor fan and wall cupboards with a complete kitchenware set (plates, glasses,

cups and cutlery):

- **Apt. 1:** on three levels, average size 100smq, with 3 double bedrooms with private bathroom, living room, kitchen, and garden. This apartment can be shared by 3 single tenants or rented by a large family.
- **Apt. 2:** on three levels, average size 100sqm, with 3 double bedrooms (2 with private bathroom), living room, 1 additional shared bathroom, kitchen, and garden. This apartment can be shared by 3 single tenants or rented by a large family.
- **Apt. 3:** average size 100sqm, with 2 double bedrooms and 1 single bedroom (with private bathroom), living room, kitchen, and 1 additional shared bathroom. This apartment can be shared by 3 single tenants or rented by a large family.
- **Apt. 4:** average size 100sqm, with 2 double bedrooms and 1 single bedroom (with private bathroom), living room, kitchen, and 1 additional shared bathroom. This apartment can be shared by 3 single tenants or rented by a large family.

BUYING PROPERTY IN ITALY

If you wish to buy property in Italy, we can direct you to services and professionals in the Florence area.

Houses for sale are advertised at estate agents as well as on commonly-used platforms like Immobiliare.it and Idealista. If you purchase a house you have found/seen with an estate agent, you will be required to pay the estate agent a fee (commissione). This fee is usually 1% to 5% of the selling price. Please note that estate

agents will usually refer to their commission without accounting for VAT, which you will be required to pay with the fee itself; VAT is usually 22% for estate agents' services. If you find a house for sale privately (i.e. without the intermediation of an estate agent), you may avoid paying the commission.

In Italy, it is almost always the case that a house is sold for either less than or for the exact price the house is listed for; it is not expected that the seller will receive offers higher than the asking price. Exceptions may occur, particularly if the seller receives multiple offers at once.

It is common practice (and the safest way for both the seller and the buyer) that offers are made in writing and signed by both the seller and the buyer. This document is then registered with Agenzia delle Entrate (national agency on inland revenue). Estate agents will usually provide the template for this document and take care of the registration with Agenzia delle Entrate.

The purchase of a house is formalised during a sitting with a Notary Public (which is arranged and paid for by the buyer). The Notary Public will register the change of title deeds as well as receive from the buyer any state tax owed for the purchase of the property (i.e. *tassa di registro*).

HOUSING EXPENSES IN FLORENCE

Whether you own or rent your house/flat, you may be liable for all or some of the following expenses:

- **TA.RI (Tassa sui Rifiuti)**: is the council tax for the management of rubbish. People living in a house they own, as well as those living in rented accommodation, are usually liable for this tax. Please check with your local council and landlord.

- **Utility bills:** usually include electricity, gas (for cooking and gas boilers), and water. If you are a homeowner, you will usually be liable for all these utilities. If you are a tenant, specific agreements may be included in the tenancy agreement on whether you are liable for all utility bills or if some or all of these may be included in your rent. Please note that all EUI accommodation includes all utility bills and TA.RI in the monthly rent.

- **IMU:** if you are a homeowner but you have your residency registered elsewhere, you may be liable to pay the State tax IMU. If you have registered your residency in the house you own, but this is considered as a luxury home, you may still be liable to pay for IMU. Please check with your local council.

VOTING

EU citizens

EU citizens who have registered their residence in Italy (residenza anagrafica) may participate in local council and European elections. To do so, they must make an official request to the city hall (Comune) to be registered on the electoral roll. Please check with your local council for full details.

Non-EU citizens

Citizens who do not hold an EU nationality cannot vote in Italy.

OPENING A BANK ACCOUNT

MONEY AND BANKING IN ITALY

Both cash and bank cards are widely used in Italy. In bigger cities, most cafes, shops, and grocery stores accept card payments (both debit and credit). You may find that smaller, independent businesses, particularly those located away from city centres, may not accept card payments, especially for things like tobacco products.

Many banks will offer credit cards as well as pre-paid cards. Please check with your bank in Italy for the terms and conditions.

INTERNATIONAL BANK ACCOUNTS

Depending on your length of stay in Italy, you may opt to not open an Italy-based bank account and use your bank account and bank cards from a bank outside of Italy. The advantages of an Italian bank account are usually: having an account in Euros (i.e. the same currency of Italy); possible lower charges on Italian bank cards when making purchases in Italy; possibility to activate direct debits for utility bills and/or other expenses.

ITALY-BASED BANK ACCOUNTS

If you wish to open a bank account with an Italy-based bank, you may choose one from the [list of authorised banks](#). Please note that the Italian Postal service ([Poste Italiane](#)) also provides banking services.

The Italian national bank Intesa Sanpaolo offers dedicated services to EU members, including opening a bank account, loans, and mortgages. Check full information and contact details for this bank here: <https://www.eui.eu/en/services/accounting-service/bank-and-bancomat>

To open an Italy-based bank account you will usually require: an Italian Tax Code (i.e. Codice Fiscale) and an Italian mobile number.

Note: it may take up to 2 weeks to complete the process of opening a bank account and having an active bank card. Please plan accordingly.

INTERNET, MOBILE AND PHONE SERVICES

WI-FI CONNECTION AT THE EUI AND AROUND FLORENCE

The EUI is a member of eduroam, an international federation of academic institutions which allows its users to visit other organisations and gain access to the Internet using the same login credentials (username and password) of their home institution.

Additionally, all EUI members have free access to the EUI internet network EUI-WiFi. Members receive the log-in details to access the network upon arrival, during their first registration/check-in.

EUI members may request their partners be issued with an EUI Partner card, which also provides them with their own log-in details to access EUI-WiFi network.

Within the Florence city centre area, you will find Firenze WiFi, a wireless network supplied by the City of Florence. Internet connection is limited to 500 MB/day.

Many cafes and restaurants, particularly in central areas, will offer free Wi-Fi connection for customers.

MOBILE PHONE PROVIDERS

If you have an internet and calls plan with a mobile phone provider in an EU country, you will be able to use part of that plan at no additional cost during your stay in Italy. Please check the exact terms and conditions with your phone provider before travelling.

If you require an Italian mobile number and internet/calls plan, you can purchase a SIM card with one of Italy's key phone providers: Fastweb; Iliad; TIM; Vodafone; Wind Tre.

You may also explore virtual phone providers like ho.,

PosteMobile, spusu, Very Mobile.

Most providers will allow you to link your phone plan to a credit card or bank account; alternatively, you can add credit to your phone to pay for your plan at physical stores (Tabacchi) or online.

HEALTH AND ACCIDENT INSURANCE

All EUI members must be covered by a health insurance policy that is valid in Italy, for both emergency and general healthcare as minimum requirements, for the whole duration of their stay at the Institute.

STUDENTS, RESEARCHERS AND POSTDOCS

Medical and accident insurance matters for researchers and postdocs are dealt with by the Academic Service, via the Health Insurance team.

Information on the medical and accident insurance schemes available through the EUI for students, researchers and postdocs may be found [at the dedicated webpage](#)

As a general rule, students, researchers, and postdocs should

already be insured under a valid and adequate medical scheme upon their arrival at the EUI.

This may be through a private or state/national insurance scheme.

Students, researchers, and postdoc fellows will be asked to provide details of their health insurance scheme at the beginning of their stay at the EUI via the dedicated form on **My EUI portal** (<https://my.eui.eu/>).

Please contact the Health Insurance team (Health.Insurance@eui.eu) should you have any questions.

HEALTH INSURANCE OPTIONS

Students, researchers, postdocs and trainees should choose one of the following options, where applicable:

1. Extension of their national insurance rights to Italy, where applicable: E106 (S1) form and EHIC card (valid for emergency hospital care only)
2. Voluntary enrolment to the Italian National Health System by paying a fee
3. The EUI Health Insurance Policy – Cigna
4. Other private health insurance

1. Extension of national insurance rights to Italy

In very specific cases, it may be possible to transfer your national insurance rights from your home country to Italy at no cost. Within the EU, form E106 (in some EU countries, the name has changed to 'S1 form') is required to register with the Italian national health system.

Beyond the EU, many countries also have bilateral health insurance arrangements with Italy. To see if you are eligible, check with the Overseas Branch of your national insurance/social security office in the country where you are resident.

The E106 (S1) form is issued by the pertinent National Social Security scheme to those who are in receipt of a salary (instead of a grant) from their National Authority. Once in Italy, it should be

exchanged for an Italian health card (tessera sanitaria) at the local Azienda Sanitaria Locale (ASL) office.

The EHIC (European Health Insurance Card - valid for emergency hospital care only)

The EHIC (or TEAM in Italian) gives you access to emergency and medically necessary hospital care in Italy, provided under the national health system, either free of charge or by paying a contribution (ticket). It can be issued by the public health authorities in your country of origin. Kindly bear in mind that the EHIC cannot be considered as a sufficient health coverage for the duration of your EUI membership. Indeed, the EHIC is not meant to provide full coverage of health services such as GP or specialist visits, medical tests, pharmaceutical costs, etc..

2. Voluntary enrolment to the Italian NHS by paying a fee

3. The EUI health insurance policy — Cigna

Basic policy

Another option is to subscribe to Cigna, the Institute's collective policy.

Researchers with grants from Austria, Belgium, Bulgaria, France, Ireland, Latvia, Poland, Portugal, Sweden, or in receipt of a grant from the EUI itself (ASPIRE, EUI Scholarships for Widening Countries, EUI Special Doctoral Fellowships), automatically have the Cigna basic policy covered by their grant authority.

Special insurance conditions apply to researchers funded by the programme "Grant for Foreigners" of the Italian Ministry of Foreign Affairs. For further information, researchers from this programme may contact Health.Insurance@eui.eu

Researchers funded by other grant programmes, postdocs, fellows, LLM, MRes and Master Students can sign up for the Cigna health insurance at their own expense. The subscription procedure

is directly dealt with by Cigna.

Supplementary policy

In case of hospitalisation and surgery, you should note that the basic Cigna health insurance policy does not cover 100% of medical costs.

In order to obtain a more extensive coverage, you are advised to consider subscribing to a supplementary policy, an option that is in addition to the basic policy. This would be at your own expense, even when the basic premium is covered by your national grant authority (as mentioned above). An exception is made for researchers funded by Poland, whose supplementary insurance is also covered by the grant authority.

4. Other private health insurance

Students, researchers, and fellows can subscribe to any other private medical insurance, provided that the private insurance is valid in Italy, for both emergency and general healthcare as minimum requirements, for the whole duration of their stay at the Institute.

ACCIDENTS AND EMERGENCY HOSPITAL CARE

EU CITIZENS:

European Union citizens in possession of the European Health Insurance Card (EHIC in English, or TEAM in Italian) are entitled to

receive emergency hospital care paying just a contribution to the Italian National Health Service (NHS), instead of paying the costs in full. The amount of such contribution is calculated according to the severity code assigned by the Emergency Department upon admission. The costs not paid by you are charged to the NHS of your country of origin.

NON-EU CITIZENS:

Special agreements with the Italian NHS, providing rights similar to those guaranteed by the EHIC, also exist in some non-EU countries. Non-EU citizens should check if such an agreement exists in their country of origin, and, if this is the case, they may request a certificate of entitlement before coming to Italy. This document will entitle them to receive emergency hospital care under the same conditions as EHIC-holders.

IN CASE OF AN ACCIDENT – ALL EUI STUDENTS, RESEARCHERS AND POSTDOCS:

Furthermore, all EUI students, researchers, postdocs and trainees are covered worldwide free of charge against the risks of accident by a second, additional, collective policy that the Institute has taken out with Cigna.

This is a complementary cover, which only comes into use after the insured's principal health insurance cover has reimbursed its part of the medical expenses incurred.

- In case of accident, you have 60 days after the day of the accident to submit the Declaration of Accident form to Cigna.

- The dependents of students, researchers or postdocs are NOT eligible for this accident insurance cover. They are advised to take out accident insurance cover in their country of residence, which shall be valid for the entire duration of their stay in Italy.

HEALTH INSURANCE

The Joint Sickness Insurance Scheme for the EU institutions (JSIS) covers the medical expenses of its beneficiaries resulting from illness, accidents, and confinement.

JSIS coverage depends on personal situations and contract categories.

Who is covered?

Permanent agents, temporary agents, contract agents, full-time professors, full-time assistant professors, research fellows, and academic assistants.

Under certain conditions, and to differing degrees, dependants, in particular the spouse or recognised partner and the children.

Who is not covered?

- Part-time professors, part-time assistant professors
- Academic collaborators
- Trainees

What is covered?

Within the limits and under the conditions set out in the Rules on Sickness Insurance, persons covered under this Scheme are guaranteed reimbursement of expenses incurred as a result of illness, accident or confinement.

ACCIDENT & OCCUPATIONAL DISEASE INSURANCE

Administrative and teaching staff members are covered by an accident insurance coverage for occupational and private accidents (24/7 worldwide).

- In case of accident, you have 10 days after the day of the accident to submit the Declaration of Accident to JSIS.

SUPPLEMENTARY HEALTH INSURANCE

In the framework of the Institute's collective policy for researchers, ALLIANZ CARE offers a supplementary health insurance (hospitalisation insurance) to EUI staff members.

You can subscribe to this policy on a private and voluntary basis.

According to their policy conditions, the hospitalisation insurance offers a cover that is supplementary to the cover you and your family members enjoy under the JSIS for medical expenses incurred as a result of illness, an accident or maternity or childbirth expenses, within the maximum intervention limits foreseen by the policy.

NATIONAL HEALTHCARE

FIRST AID AND ACCIDENTS & EMERGENCIES (PRONTO SOCCORSO)

If the patient is in possession of a EHIC (TEAM) card or is enrolled in the Italian national health system, they may benefit of first-aid services in public hospitals, either free of charge or just paying a small contribution to the NHS.

If the patient is covered by a private insurance, for example Allianz or JSIS, they must inform the hospital upon admittance, in order for them to charge the relevant costs to the insurance company directly.

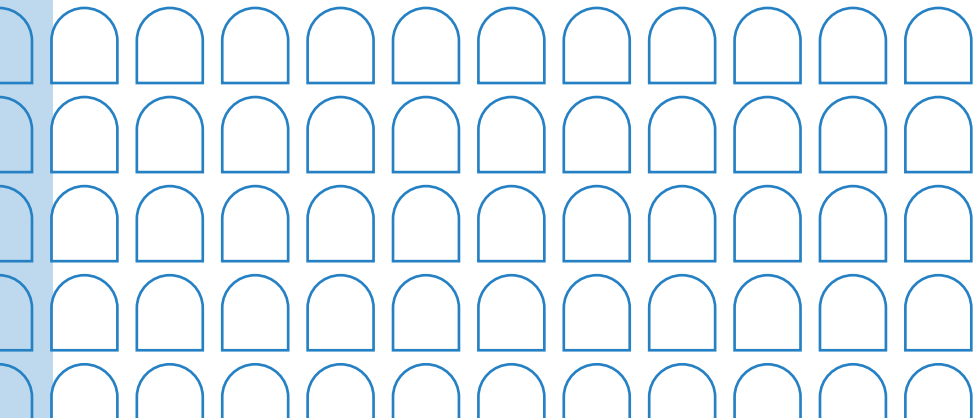

ACADEMIC YEAR AND TERMS

LOCKERS AND WORKSPACES

Lockers are attributed through an allocation/renewal procedure run by Academic Service on a yearly basis, always at the beginning of an academic year, for researchers who hold an active student status. Once a locker is on loan to a researcher, the locker key and content are under the responsibility of the researcher.

There are shared workspaces throughout the EUI campus. In the Badia (Upper Cloister and the Library), desks are on a day-at-a-time, first-come, first-served basis. In Villa Schifanoia (Casale, Garage and Sal Nyobe) a community workspace system is operational. Researchers who request a locker in any of these three areas become part of a community and share the workspaces out amongst themselves. In theory, this means there are about twice as many people as workspaces. In practice, there are almost always free workspaces.

Paper bus tickets can be purchased at newsagents, tobacconists, and some cafes, as well as on the bus itself through the driver (note: the bus driver may have no tickets available to sell). E-tickets can be purchased through the official website of Autolinee Toscane. You may also pay for your bus trip by **tapping on and off** the bus with your card or Google Pay/Apple Pay. SITES IN SAN DOMENICO AREA

You can reach all sites in San Domenico, including the Badia Fiesolana, Villa Sanfelice, Villa Paola, Villa la Fonte, the Convento, and the Villa Schifanoia campus by taking bus number 7 from Piazza della Libertà to Fiesole and getting off at 'Di San Domenico Della Badia' stop. Villa il Poggiolo is located near the number 7 bus stop 'Piazza Edison'.

VILLA SALVIATI

BEYOND FLORENCE

Florence is well connected to many regional destinations through train and bus services, including Prato, Siena, Pistoia, Lucca, Pisa and Livorno.

Florence is also well connected to other major Italian cities through high-speed train services. These services depart from Firenze Santa Maria Novella, from which you can reach Bologna in 0.38 hours, Rome in 1.36 hours, Milan in 1.55 hours, Venice in 2.16 hours, Turin in 3 hours and Naples in 3 hours.

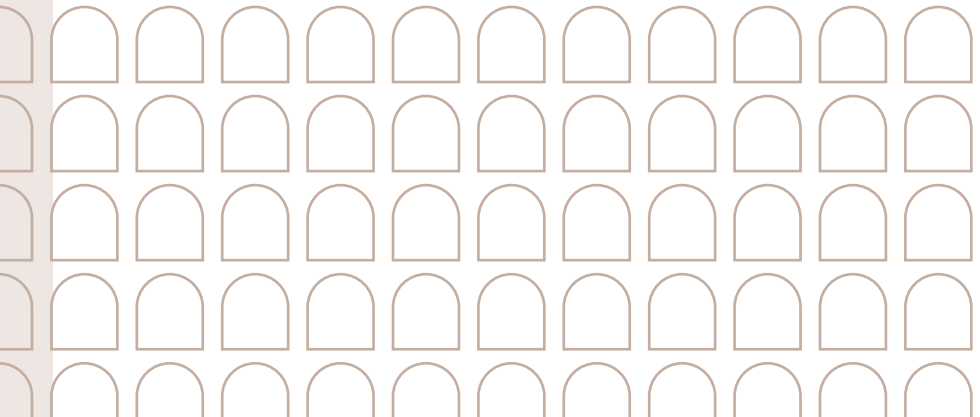

Building your social network

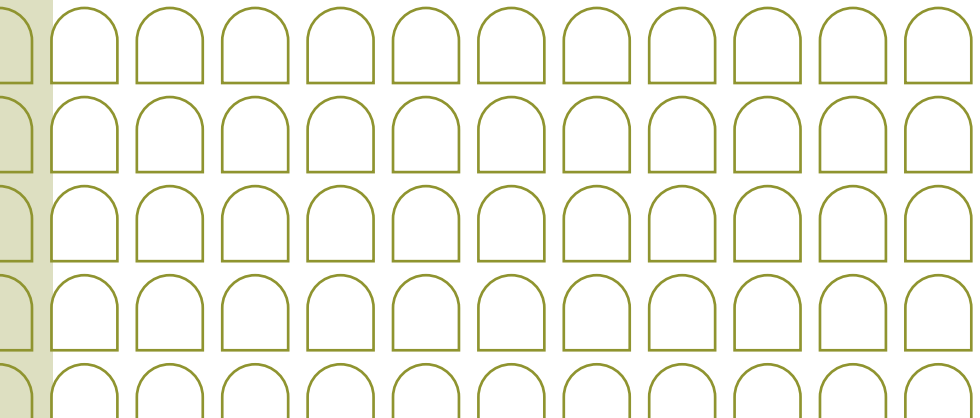

TYPES OF SCHOOLS

In Italy, most children attend public schools, with a growing share of students attending private schools that follow the Italian curriculum offering bilingual teaching (e.g. Italian and English, Italian and French).

SCHOOL YEAR AND HOLIDAYS

The school year usually runs from the start of September and to late June.

The school year is usually divided into two terms: 1st Term (Primo Quadrimestre) and 2nd Term (Secondo Quadrimestre).

Key holidays usually include: 1st Nov; 8th Dec; Christmas and New Year break (25th Dec to 7th January); Easter break; 1st May; 2nd June.

Schooling up to primary school (i.e. 6 years of age) is not compulsory in Italy, while from age 6 to 16, the Italian law requires children to attend school.

Primary schools are called Scuola Primaria, but they are also commonly known as Scuola Elementare. This school cycle is made up of 5 grades/years. Primary schools may offer 24- to 27-hour-per-week classes, as well as so-called full-time (tempo pieno) which corresponds to 40 hours of school per week. Assessments are carried out throughout the year, with no final national exams at the end. Most public primary schools will offer similar curriculums to one another.

Middle schools are called Scuola secondaria di primo grado, but they are also commonly known as Scuola Media. This school cycle is made up of 3 grades/years. Middle schools may offer 30-hours-per-week classes, as well as so-called full-time (tempo prolungato) which corresponds to 36 to 40 hours of school per week. Assessments are carried out throughout the year, with a final national exam being held at the end of year 3, which allows access to high schools. Middle schools may differ in terms of which third language they offer (i.e. French, German or Spanish, in addition to English, or no third language with more teaching hours focused on English, i.e. Inglese potenziato) or if they offer musical teaching (e.g. piano, violin, guitar, etc.).

High schools are divided into three groups:

- Liceo – Liceo high schools have a strong focus on theory and preparing students for university. This group of schools includes 8 curricula.
- Istituto tecnico – Technical schools include characteristics of Licei and Istituti professionali by providing an equal balance between practical activities and theory. This group includes 12 curricula.
- Istituto professionale – Professional schools offer a strong focus on practical activities in the areas of agriculture, health professions, and manufacturing. This group includes 11 curricula.

All the abovementioned high schools allow access to university studies. High schools typically have 5 grades/years, but exceptions apply. Assessments are carried out throughout the year, and a final state exam is held at the end of the 5th year called Esame di Stato/Esame di maturità.

INTERNATIONAL EDUCATION

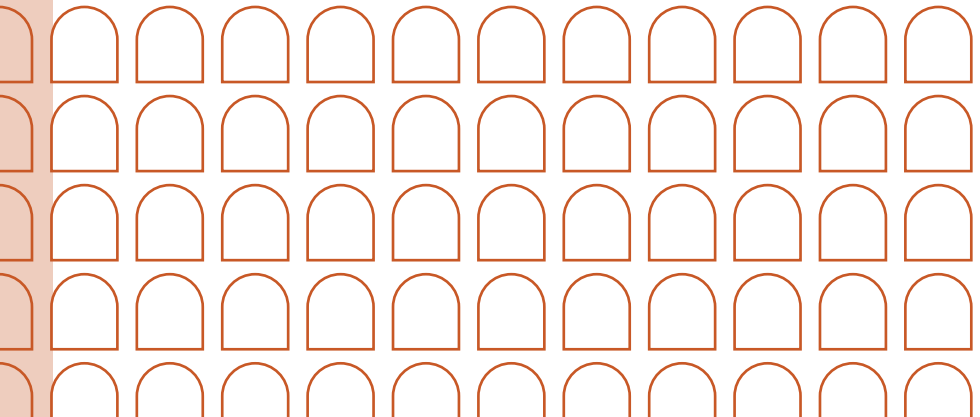
In the Fiesole and Florence area there is a selection of schools that offer international curricula, like the Ontario Canadian curriculum and the French curriculum. These schools offer teaching at all kindergarten, primary, middle, and high school levels. These schools are often attended by Italian children with international backgrounds, and by children from around the world who have moved to Florence with their families. These schools have a strong focus on languages, including English, French and Spanish, as well as Italian.

Attending these schools may be particularly beneficial for children moving to Florence for short-medium term periods to ensure continuity with previous schooling and recognition of their time in Florence at subsequent schools abroad.

Most of the Library's print holdings are on open shelving. In addition, the Library provides its users access to an extensive collection of databases, full-text e-journals, eBooks and electronic working papers.

The Library has the status of European Documentation Centre (EDC), an official depository of EU publications and documents.
